BIOSECURITY AND AGRICULTURE MANAGEMENT ACT 2007

DETERMINATION UNDER SECTION 130 (1)

Acting under section 130 of the *Biosecurity and Agriculture Management Act 2007* I determine rates chargeable on land held under pastoral lease in the prescribed areas for the financial year commencing on 1 July 2014 as follows—
