Land Tax Assessment Act 2002

Land Tax Assessment Amendment Regulations 2014

Made by the Governor in Executive Council.

1. Citation

These regulations are the *Land Tax Assessment Amendment Regulations 2014*.

2. Commencement

These regulations come into operation as follows —

- (a) regulations 1 and 2 — on the day on which these regulations are published in the *Gazette* (**gazettal day**);
- (b) the rest of the regulations —
 - (i) if gazettal day is before 1 July 2014 — on 1 July 2014; or
 - (ii) if gazettal day is, or is after, 1 July 2014 — on the day after gazettal day.

3. Regulations amended

These regulations amend the *Land Tax Assessment Regulations 2003*.

4. Regulation 12 amended

Delete regulation 12(2)(e) to (k) and insert:

- (e) the Bunbury Port Authority established by the *Port Authorities Act 1999* section 4;
