I, Reece Waldock, Director General of the Department of Transport, acting pursuant to Section 111AB(2) of the *Road Traffic Act 1974* and Regulation 41 of the *Road Traffic (Vehicle Standards) Regulations 2000*, hereby exempt the vehicles specified in Clause 2 from the following dimension limits in the *Road Traffic (Vehicle Standards) Rules 2002*, subject to compliance with the conditions set out in Clause 3 of this Notice.

Part 3 Division 2 Rule 14—Compliance with third edition ADRs as it relates to Clause 6.1.2.1 of ADR 43/04, which limits the distance from the point of articulation to the line from which the rear overhang is measured, and Clause 6.1.2.3 of ADR 43/04, which limits the distance from the point of articulation to the rear end.

Part 7 Division 2 Rule 62—Length of trailers, as it relates to a semi-trailer.

**2. Vehicles Exempted**

The application of this Notice is limited to refrigerated, rigid walled, insulated semi-trailers used to transport chilled or frozen goods.

**3. Conditions**
