Industrial Relations Act 1979

Industrial Relations Commission Amendment Regulations (No. 2) 2015

Made by the Chief Commissioner of The Western Australian Industrial Relations Commission after consulting the members of the Commission.

1. Citation

These regulations are the *Industrial Relations Commission Amendment Regulations (No. 2) 2015*.

2. Commencement

These regulations come into operation as follows —

- (a) regulations 1 and 2 — on the day on which these regulations are published in the *Gazette*;
- (b) the rest of the regulations — on the day after that day.

3. Regulations amended

These regulations amend the *Industrial Relations Commission Regulations 2005*.

4. Regulation 18 replaced

Delete regulation 18 and insert:

18. Joinder of parties

- (1) An application to join any person as a party to proceedings before the Commission (the *substantive proceedings*) must —
 - (a) be made in the form of Form 1; and
 - (b) name the person the applicant seeks to be joined as a party to the substantive proceedings (the *person to be joined*); and

- (c) have attached a written statement of the grounds on which the application is made and the facts to show that the applicant is entitled to make the application.
- (2) The Registrar is to give an application made under subregulation (1) the same distinguishing number as the substantive proceedings to which it relates.
- (3) The applicant must serve a copy of the application and the attachments on —
 - (a) the person to be joined; and
 - (b) each other party to the substantive proceedings.
- (4) The application is not to be listed for hearing unless —
 - (a) a notice of answer has been received from the person to be joined; or
 - (b) the time for filing a notice of answer has expired; or
 - (c) the Commission otherwise directs.
