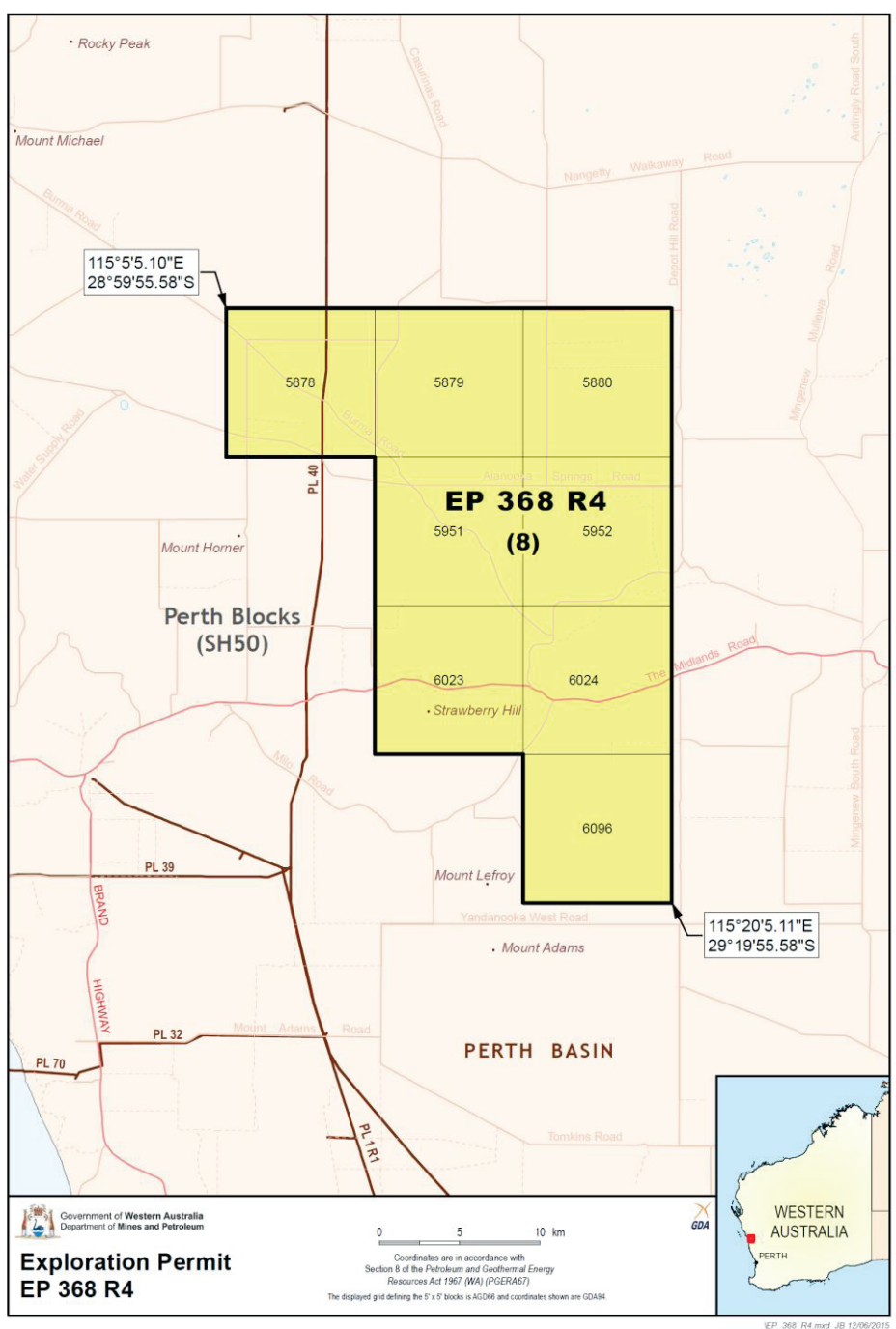

## IMPROVEMENT PLAN NO. 43

## Shenton Park Rehabilitation Hospital

It is hereby notified for public information that the Western Australian Planning Commission acting pursuant to Part 8 of the *Planning and Development Act 2005* has certified and recommended that for the purpose of advancing the planning, development and use of the land described below, that the land should be made the subject of an improvement plan.

The subject site is located within the suburb of Shenton Park. The site is approximately 16 hectares in size and is bounded by Selby Street to the east and Lemnos Street to the south, as depicted on Western Australian Planning Commission plan numbered 3.2622.

The purpose of this improvement plan is to develop the Shenton Park Rehabilitation Hospital (SPRH) site into the Shenton Park Urban Village in a co-ordinated manner recognising its significant landholding that requires careful planning, design, consolidated, re-subdivided, cleared, developed, reconstructed, or rehabilitated land. The Improvement Plan will act as the strategic planning and development instrument for delivery of the subsequent Improvement Scheme for the SPRH site.

The recommendation has been accepted by the Minister for Planning and the Deputy of the Governor in Executive Council, and will be known as Improvement Plan No. 43—Shenton Park Rehabilitation Hospital. Improvement plan number 43 is effective on and from 3 July 2015.
