**1. Citation**

**2. Commencement**

These regulations come into operation as follows —

- (a) regulations 1 and 2 — on the day on which these regulations are published in the *Gazette*;
- (b) the rest of the regulations — on the day after that day.

**3. Regulation 8 amended**

- (1) In regulation 8(6) delete “the form of Form 2.” and insert:

a form approved by the Chief Magistrate.

- (2) Delete regulation 8(7).

Delete Schedule 2 Form 2.

## Supreme Court Act 1935

**Supreme Court Amendment Rules (No. 4) 2015**

Made by the Judges of the Supreme Court.

**1. Citation**

These rules are the *Supreme Court Amendment Rules (No. 4) 2015*.

**2. Commencement**

These rules come into operation as follows —

- (a) rules 1 and 2 — on the day on which these rules are published in the *Gazette*;
- (b) the rest of the rules — on the 14<sup>th</sup> day after that day.

**3. Rules amended**

These rules amend the *Rules of the Supreme Court 1971*.

**4. Order 24A amended**

- (1) Delete Order 24A rules 1 and 2 and insert:

**1. Parties entitled to make offer**

In any proceedings the plaintiff or the defendant may make to the other an offer to compromise any claim in the proceedings on the terms specified in the notice of offer.

**2. Application of this Order to counterclaims and third party notices**

Where a party makes a claim by way of counterclaim or third party notice, this Order applies in relation to the proceeding on that claim as if —

- (a) the party making the claim were the plaintiff; and
- (b) the party against whom the claim is made were the defendant.

**3A. How to make offer**

- (1) An offer of compromise is made to a party under this Order by serving a notice of the offer on the party.

- (2) A notice of offer is to —
  - (a) be in writing; and
  - (b) bear a statement to the effect that the offer is made under this Order.
  
- (2) Delete Order 24A rule 8(2) and insert:
  - (2) Where a party to an accepted offer fails to comply with the terms of the offer, and another party in the proceedings has made a claim which is not the subject of the accepted offer, the Court may make such order or give such judgment under subrule (1), and make such order that the proceeding on that other party's claim be continued, as it thinks fit.
  
- (3) Delete Order 24A rule 10(3) and insert:
  - (3) Subrules (4) and (5) apply to an offer which has not been accepted in the time prescribed by rule 3(5) if the Court is satisfied by the party who made the offer that the party was at all material times willing and able to comply with the terms of the offer.
  
- (4) In Order 24A rule 10(4) delete “basis.” and insert:

basis, except as provided in subrule (5A).
  
- (5) Delete Order 24A rule 10(4a) and insert:
  - (5A) If the Court is satisfied that the failure by the defendant to accept the offer made by the plaintiff was unreasonable, the plaintiff's costs from the date on which the offer was made are to be taxed on an indemnity basis, unless the interests of justice require otherwise.
  
- (6) In Order 24A rule 10(5) and (6) delete “basis.” and insert:

basis, except as provided in subrule (7A).
  
- (7) After Order 24A rule 10(6) insert:
  - (7A) If the Court is satisfied that the failure by the plaintiff to accept the offer made by the defendant was

unreasonable, the defendant's costs are to be taxed on an indemnity basis, unless the interests of justice require otherwise.

(8) Delete Order 24A rule 10(9).

**LOCAL GOVERNMENT ACT 1995**

*Shire of Collie*

**REPEAL LOCAL LAW 2015**

Under the powers conferred by the *Local Government Act 1995* and under all other powers enabling it, the Council of the Shire of Collie resolved on 28 July 2015 to make the following local law.

**1. Citation**

This local law may be cited as the *Shire of Collie Repeal Local Law 2015*.

**2. Application**

This local law applies to the district of the Shire of Collie

**3. Commencement**

This local law comes into operation 14 days after the date of its publication in the *Government Gazette*.

**4. Repeal**

The following local laws are repealed—

- (a) *Collie Road Board—Building By-laws* published in the *Government Gazette* on 14 January 1949.
- (b) *By-laws of the Collie Coalfields Road Board* as published in the *Government Gazette* on 28 March 1952 and as amended in the *Government Gazette* on 20 February 1953 and 28 August 1952.
- (c) *Collie Coalfields Road Board By-laws governing Long Service Leave to be Granted to the Employees of the Collie Coalfields Road Board* published in the *Government Gazette* on 20 February 1953.
- (d) *Collie Coalfields Road Board By-laws for Regulating the Use of, and for Prescribing the Charges to be Paid for the Use of a Schweschesten Concert Grand Piano at the Mineworkers' Institute Hall, Collie* published in the *Government Gazette* on 18 April 1956.
- (e) *Collie Coalfields Road Board By-laws for Regulating the Construction, Establishment, Operation and Maintenance of Motels* published in the *Government Gazette* on 6 October 1960.
- (f) *The Municipality of the Shire of Collie By-laws Relating to the Keeping of Bees* published in the *Government Gazette* on 31 August 1962.
- (g) *The Municipality of the Shire of Collie Adoption of Draft Model By-laws (Storage of Inflammable Liquid) No. 12* published in the *Government Gazette* on 7 November 1963.
- (h) *The Municipality of the Shire of Collie Adoption of Draft Model By-laws (Storage of Inflammable Liquid) No. 12* published in the *Government Gazette* on 12 October 1965.
- (i) *The Municipality of the Shire of Collie Adoption of Draft Model By-laws (Deposit of Refuse and Litter), No. 16* published in the *Government Gazette* on 24 May 1966.
- (j) *The Municipality of the Shire of Collie By-laws Relating to Shire Clerk's Duties* published in the *Government Gazette* on 7 September 1966.
- (k) *The Municipality of the Shire of Collie By-laws Relating to the Control, Operation and Management of the Mine Workers Memorial Olympic Pool* published in the *Government Gazette* on 31 August 1990.
- (l) *The Municipality of the Shire of Collie By-law Relating to the Clearing of Land and Removal of Refuse, Rubbish and Disused Materials* published in the *Government Gazette* on 3 April 1992.

*City of Joondalup*

**PARKING AMENDMENT LOCAL LAW 2015**

Under the powers conferred by the *Local Government Act 1995* and under all other powers enabling it, the Council of the City of Joondalup resolved on 17 August 2015 to make the following local law.

**PART 1—PRELIMINARY****1.1 Citation**

This local law may be cited as the *City of Joondalup Parking Amendment Local Law 2015*.

**1.2 Commencement**

This local law commences on the 14th day after the day on which it is published in the *Government Gazette*.

**1.3 Purpose and effect**

- (a) The purpose of this local law is to amend certain provisions within the *City of Joondalup Parking Local Law 2013*.
- (b) The effect of this local law is to better clarify the provisions relating to the control of parking throughout the district.

**PART 2—AMENDMENTS****2.1 City of Joondalup Parking Local Law 2013 amended**

This Part of the local law amends the *City of Joondalup Parking Local Law 2013*.

**2.2 Clause 1.5 amended**

Clause 1.5 is amended as follows—

- (a) Delete the definition for “**ACROD sticker**”.
- (b) After the definition of “**commercial vehicle**”, insert “**disability parking permit** has the meaning given to it in the *Local Government (Parking for People with Disabilities) Regulations 2014*”.
- (c) Delete “**Parking facilities**” and insert “**Parking facility**”.
- (d) After the definition of “**symbol**”, insert “**tare weight** means the weight of a motor vehicle without the addition of the driver, passengers or load of any kind”.
- (e) Delete “**thoroughfare** has the meaning given to it by the Act;” and insert—  
“**thoroughfare** means a road or other thoroughfare and includes a verge, structures or other things appurtenant to the thoroughfare that are within its limits, and nothing is prevented from it being a thoroughfare only because it is not open at each end;”.

**2.3 Clause 2.2 amended**

Clause 2.2 is amended as follows—

- (a) In subclause (1)(b) replace “the” with “a”.
- (b) In subclause (2) replace “that” with “a”.

**2.4 Clause 3.5 amended**

Clause 3.5(2)(k) is deleted and the following inserted—

- “(k) within 10 metres of the prolongation of the nearer edge of any intersecting carriageway intersecting that carriageway on the side on which the vehicle is parked”.

**2.5 Clause 3.8 amended**

Clause 3.8 is amended as follows—

- (a) In subclause (1) after “not” insert “park or”;
- (b) In subclause (2) after “not” insert “park or”.

**2.6 Clause 6.9 amended**

In clause 6.9(1)(b) replace “GVM” with “tare weight”.

**2.7 Clause 6.15 deleted**

Clause 6.15 is deleted.

**2.8 Clause 9.1 amended**

In clause 9.1(3) replace “\$1,000” with “\$5,000” and replace “\$100” with “\$500”.

**2.9 Schedule 2 amended**

Schedule 2 is amended by deleting Item 74 and the items following this being renumbered accordingly.

**2.10 Amendment throughout the *City of Joondalup Parking Local Law 2013***

Replace “ACROD sticker” where referenced with “disability parking permit” throughout the *City of Joondalup Parking Local Law 2013*.

#### SCHOOL EDUCATION ACT 1999

##### DECLARATION OF LOCAL-INTAKE AREAS FOR SCHOOLS WITH PRIMARY STUDENTS

(Pursuant to Sections 60, 78, 79 and 80)

The Hon. Minister for Education has declared that the local-intake areas for the schools listed hereunder shall be as stated in this notice. Children of compulsory school age who reside within the local-intake areas stated shall be entitled to attend the schools to which such local-intake areas apply if there is an appropriate educational program for them at that school. Children who reside outside these local-intake areas may apply to attend the schools to which such local-intake areas apply.

#### **ANNIE'S LANDING (Ellenbrook) (planning name only) PRIMARY SCHOOL (Sept15)**

The following will define the local-intake area of this school from 2016—

From the junction of Bordeaux Lane and Farnborough Pathway, north along Farnborough Pathway (east side included) to Putley Road, west along Putley Road (north side included) to Delapre Drive, north along Delapre Drive (east side included) to Stanbury Crescent, west and north west along Stanbury Crescent (north and north east sides included) to Banrock Drive, south west along Banrock Drive (north west side included) to Dalgarpur Way, north west along Dalgarpur Way (east side included) and continuing north west along the extension of Dalgarpur Way to Maralla Road, east along Maralla Road (both sides excluded) and its extension to the railway line, generally south along the railway line to the intersection of the railway line and Apple Street, west along Apple Street (north side included) and its western extension to the golf green of the 13th hole, south west between 108 Hermitage Drive and 96 Hermitage Drive to Hermitage Drive, north along Hermitage Drive (east side included) to a point located east of the tennis courts, west through the centre of the tennis courts to the 10th fairway, west along the centre of the 10th fairway and continuing south west along the centre of the 11th fairway to Vines Avenue, north along Vines Avenue (east side included) to Bordeaux Lane and west along Bordeaux Lane (north side included) to Farnborough Pathway.

#### **BLETCHLEY PARK PRIMARY SCHOOL (Sept15)**

The following will define the local-intake area of this school from 2016—

From the intersection of Ranford Road and Warton Road, north east along Warton Road (east side included) to Garden Street, south east along the locality boundary between Huntingdale and Southern River (which corresponds to the extension of Garden Street) to the junction of Holmes Street and Balfour Street, south east along Holmes Street (both sides included) to Passmore Street, north east along Passmore Street (both sides included) to Dallen Street, southeast along Dallen Street (both sides excluded) and its south easterly extension to the Tonkin Highway, south west along the Tonkin Highway (west side included) to Ranford Road, and north west along Ranford Road (north side included) to Warton Road.

#### **ELLEN STIRLING PRIMARY SCHOOL (Sept15)**

The following will define the local-intake area of this school from 2016—

From the intersection of The Broadway and The Promenade, east along The Promenade (north side included) and continuing north east along Millhouse Road (north side included) to a point due south of the western end of Trilogy Court, north from Millhouse Road to the western end of Trilogy Court (both sides excluded), and continuing north to the junction of Bordeaux Lane and Farnborough Parkway, west along Bordeaux Lane (south side included) to The Broadway, and west and south along The Broadway (south and east sides included) to The Promenade.

The following defines an optional area between Ellen Stirling Primary School and Upper Swan Primary School—

From the point where Millhouse Road crosses Ellen Brook, north and west along Millhouse Road (north side included) to a point due south of the western end of Trilogy Court (both sides included), north from this point on Millhouse Road to the western end of Trilogy Court (both sides included), and continuing north to Bordeaux Lane, east along Bordeaux Lane (south side included) to Vines Avenue, south along Vines Avenue (west side included) to the nearest point to the green of the 11th fairway, north west along the centre of the 11th fairway to the 10th fairway, east along the centre of the 10th fairway and continuing through the tennis courts to Hermitage

Drive, south along Hermitage Drive to a point midway between 96 and 108 Hermitage Drive, north east to the green of the 13th fairway and east to a point on both Ellen Brook and the western extension of Apple Street, and south and west along Ellen Brook to Millhouse Road.

#### **FORRESTDALE PRIMARY SCHOOL (Sept15)**

The following will define the local-intake area of this school from 2016—

From the intersection of Armadale Road and Nicholson Road, west along Armadale Road (south side included) to Taylor Road, south along Taylor Road (both sides excluded) to Rowley Road, east along Rowley Road (north side included) to Ditton Road, south along Ditton Road (both sides included) to Craddon Road, west and south along Craddon Road (both sides included) and its southern extension to Anketell Road, east along Anketell Road (north side included) to Thomas Road, north east and east along Thomas Road (both sides excluded) to the Birriga Drain, north and east along the Birriga Drain to Kargotich Road, north east along Kargotich Road (both sides excluded) to Rowley Road, east along Rowley Road (both sides excluded-and excluding Lentara Place) to Hopkinson Road, north from this point to Forrest Road, west and north west along Forrest Road (south west side included) to Twelfth Road, north north east along Twelfth Road (both sides included) to Armadale Road, west along Armadale Road (south side included) to a point coinciding with the extension of Brigade Road, north east from this point to and along Brigade Road (both sides excluded) and its extension to Lake Road, north east along Lake Road (both sides excluded) to Champion Drive, north west along Champion Drive (west side included) to Tonkin Highway, south west along Tonkin Highway (east side included) to Ranford Road, north west along Ranford Road (south west side included) to Anstey Road, generally south west along Anstey Road (south east side included) to Armadale Road, and west along Armadale Road to Nicholson Road.

The following defines an optional area for Atwell Primary School and Forrestdale Primary School—

From the junction of Armadale Road and Liddelow Road, south along Liddelow Road (east side included) to Bartram Road, east along Bartram Road (north side included) to Taylor Road, north along Taylor Road (both sides included) to Armadale Road and north west along Armadale Road (south side included) to Liddelow Road.

The following defines an optional area between Forrestdale Primary School and Marri Grove Primary Schools—

From the junction of Hopkinson Road and Rowley Road, west along Rowley Road (both sides included—and including both sides of Lentara Place) to Kargotich Road, south west along Kargotich Road (both sides included) to the Birriga Drain, in a general easterly direction along the Birriga Drain to Hopkinson Road, and north along Hopkinson Road (both sides included) to Rowley Road.

The following defines an optional area between Forrestdale Primary School and Harmony Primary School—

From the junction of Liddelow Road and Bartram Road, south along Liddelow Road (east side included) to the junction with Wilga Court, east from this junction to Taylor Road, north along Taylor Road (both sides included) to Bartram Road and west along Bartram Road (south side included) to Liddelow Road.

The following defines an optional area between Forrestdale Primary School and Aubin Grove Primary School—

From the junction of Liddelow Road and Wilga Court, east from this junction to Taylor Road, south along Taylor Road (both sides included) to Rowley Road, east along Rowley Road (south side included) to Ditton Road, south along Ditton Road (both sides excluded) to Craddon Road, west and south along Craddon Road (both sides excluded) and south along its southern extension to Anketell Road, west along Anketell Road (north side included) to the locality boundary between Anketell and Oakford, north from this point to the more southern junction of De Haer Road and Leslie Road, north east and north along De Haer Road (south east and eastern sides included) to Rowley Road, and continuing north along Liddelow Road (east side included) to Wilga Court.

#### **HERON PARK (Harrisdale) (planning name only) PRIMARY SCHOOL (Sept15)**

The following will define the local-intake area of this school from 2016—

From the intersection of Ranford Road and Warton Road, south east along Ranford Road (south west side included) to Anstey Road, south west along Anstey Road (north west side included) to Armadale Road, west along Armadale Road (north side included) to Nicholson Road, generally north along Nicholson Road (east side included) to Warton Road, and north east along Warton Road (south east side included) to Ranford Road.

#### **JOHN BUTLER PRIMARY COLLEGE (Sept15)**

The following will define the local-intake area of this school from 2016—

From the junction of the coastline and the locality boundary between Alkimos and Eglington south east along the coastline to a point located on the south western extension of Carmethan Avenue, north east along this extension to Carmethan Avenue, north east along Carmethan Avenue (north side included) to Camborne Way, south east along Camborne Way (east side included) to Whitland Street, north east along Whitland Street (north side included) to Goodwick Street, east along Goodwick Street (north side included) to Exmouth Drive, north west along Exmouth Drive (west side included) to Butler Boulevard, north east along Butler Boulevard (north side included) to the railway line, north along the railway line and the planned route of the railway line to Romeo Road, generally east along Romeo Road to the Mitchell Freeway, north

along the proposed extension of the Mitchell Freeway (west side included) to the locality boundary between Alkimos and Eglinton, west along the locality boundary between Alkimos and Eglinton to the coastline.

**MAKYBE RISE PRIMARY SCHOOL (Sept15)**

The following will define the local-intake area of this school from 2016—

From the intersection of Safety Bay Road and Baldivis Road, west along Safety Bay Road (south side included) to Nairn Drive, south along Nairn Drive (east side included) to Bramall Terrace, north east along Bramall Terrace (north side included) to Province Road, south along Province Road (east side included) to Greenock Road, east along Greenock Road (north side included) to Highbury Boulevard, east along Highbury Boulevard (north side included) to Bloomfield Parkway, generally east along Bloomfield Parkway (north side included) and its eastern extension to Baldivis Road, north along Baldivis Road (west side included) to Safety Bay Road.

**MALVERN SPRINGS PRIMARY SCHOOL (Sept15)**

The following will define the local-intake area of this school from 2016—

From the junction of The Broadway and Bordeaux Lane, east along Bordeaux Lane (north side included) to Farnborough Pathway, north along Farnborough Pathway (west side included) to Putley Road, west along Putley Road (south side included) to Delapre Drive, north along Delapre Drive (west side included) to Stanbury Crescent, west and north west along Stanbury Crescent (south and south west sides included) to Banrock Drive, south west along Banrock Drive (south east side included) to Dalgarpur Way, north west along Dalgarpur Way (west side included) and continuing north west along the extension of Dalgarpur Way to Maralla Road, west along Maralla Road (both sides excluded) to the proposed route of the Perth-Darwin Highway, south west along the proposed route of the Perth-Darwin Highway to a point due north of the middle of the Transit Corridor on Farmaner Pathway, south west along the middle of this Corridor to Galatea Pass, south east along Galatea Pass (both sides excluded) to The Broadway and generally east along The Broadway (north side included) to Bordeaux Lane.

**PIARA WATERS PRIMARY SCHOOL (Sept15)**

The following will define the local-intake area of this school from 2016—

From the junction of Armadale Road and Liddelow Road, generally south east along Armadale Road (north side included) to Nicholson Road, generally north along Nicholson Road (west side included) to Account Road, north west along Account Road (both sides excluded) to Fraser Road, south west along Fraser Road (east side included) to the junction with Jandakot Road, and south from this junction to the junction of Armadale Road and Liddelow Road.

**RIVERGUMS (Baldivis) (planning name only) PRIMARY SCHOOL (Sept15)**

The following will define the local-intake area of this school from 2016—
