Conservation and Land Management Act 1984

Conservation and Land Management Amendment Regulations (No. 5) 2015

Made by the Governor in Executive Council.

1. Citation

These regulations are the *Conservation and Land Management Amendment Regulations (No. 5) 2015.*

2. Commencement

These regulations come into operation as follows —

- (a) regulations 1 and 2 on the day on which these regulations are published in the *Gazette*;
- (b) the rest of the regulations on the day after that day.

3. **Regulations amended**

These regulations amend the *Conservation and Land Management Regulations 2002*.

4. **Regulation 60AA inserted**

After regulation 59 insert:

60AA. Notice of moorings suspected of not being lawfully authorised

- If the CEO is of the opinion that a mooring is on CALM land without lawful authority the CEO may give notice in writing to the person who owns or apparently controls the mooring.
- (2) The notice must specify a reasonable time within which the person must
 - (a) provide evidence to the CEO that the mooring is authorised to be on CALM land; or

- (b) apply to the CEO for a licence or other authorisation for the mooring to be on CALM land; or
- (c) remove the mooring.
- Proceedings for an offence under subregulation 59(1)(b) must not be commenced against a person unless the CEO has given the person a notice under subregulation (1) and either —
 - (a) the person has failed to comply with the notice; or
 - (b) the person has applied for a licence or other authorisation before the end of the period specified in the notice and the application has been refused.

LOCAL GOVERNMENT ACT 1995

City of Stirling

PARKING AMENDMENT LOCAL LAW 2015

Under the powers conferred by the *Local Government Act 1995* and under all other powers enabling it, the Council of the City of Stirling resolved on 17 November 2015 to make the following local law.

1. Citation

This local law may be cited as the City of Stirling Parking Amendment Local Law 2015.

2. Commencement

This local law comes into operation 14 days after the date of publication in the $Government\ Gazette.$

3. Principal local law

This local law amends the *City of Stirling Parking Local Law 2014* as published in the *Government Gazette* on 9 May 2014.

4. Clause 1.5 amended

In clause 1.5—

- (a) delete the definition for *ACROD sticker*; and
- (b) insert the following definitions in alphabetical order
 - **disability parking permit** means a current document issued by the National Disability Service (ACN 008 445 485), consisting of—
 - (a) an Australian Disability Parking Permit; and
 - (b) an ACROD Parking Program Card;
 - dividing strip has the meaning given to it by the Code;
 - electric personal transporter has the meaning given to it by the Code;
 - painted island has the meaning given to it by the Code;.

5. Clause 2.2 amended

Delete clause 2.2(3) and insert-

(3) When parking within a parking facility, a person shall not park a vehicle other than in a parking bay.

6. Clause 2.5 amended

Delete clause 2.5(b) and insert—

(b) displaying the ticket inside the vehicle in a prominent position, in such a manner the date and expiry time is clearly visible by an authorised person from the front of the vehicle at all times while that vehicle remains parked in the ticket parking zone, ticket parking area or parking station.

7. Clause 3.1 amended

In clause 3.1(3)-

- (a) in subclause (a) after "current", delete "ACROD sticker" and insert "disability parking permit";
- (b) in subclause (b) after "that" delete "ACROD sticker" and insert "disability parking permit".

8. Clause 3.2 amended

(1) In clause 3.2(2)(c) after "farther boundary of the carriage way", delete ", or median strip".

- (2) In clause 3.2(3)—
 - (a) delete subclause (a); and
 - (b) delete subclause (h) and insert—
 - (h) is between the boundaries of a carriageway and any continuous dividing line, or median strip, or dividing strip, or traffic island, or painted island, unless there is a distance of at least 3 metres clear between the vehicle and the nearer continuous dividing line, median strip, dividing strip, traffic island or painted island;.

9. Clause 6.9 amended

Delete clause 6.9 and insert—

6.9 Stopping on a path, dividing strip, median strip, traffic island or painted island

The driver of a vehicle (other than a bicycle, an electric personal transporter or an animal) shall not stop so that any portion of the vehicle is on a path, dividing strip, median strip, traffic island or painted island, unless the driver stops in an area, to which a parking control sign applies and the driver is permitted to stop at that place under this local law.

10. Schedule 2 amended

Schedule 2 is amended as follows—

- (a) In Item No. 2, after "Parking against the flow of traffic" insert "within a parking bay";
- (b) In Item No. 3, after "Failure to park", delete "wholly within parking area" and insert "other than in a marked bay";
- (c) In Item No. 21, after "farther carriageway boundary" delete ", median strip";
- (d) Delete Item No. 24;
- (e) In Item No. 31, after "continuous dividing line" delete "markings" and insert ", or median strip, or dividing strip, or traffic island, or painted island";
- (f) In Item No. 66, delete "80" and insert "150";
- (g) In Item No. 67, delete "80" and insert "150";
- (h) In Item No. 68, delete "80" and insert "150";
- (i) In Item No. 69, delete "80" and insert "150";
- (j) In Item No. 75-
 - (i) delete "Stopping on median strip or traffic island" and insert "Stopping on path, or dividing strip, or median strip, or traffic island or painted island;
 - (ii) delete "80" and insert "100"; and
- (k) In Item No. 76, delete "6.10" and insert "6.10(1)(a)".

LOCAL GOVERNMENT ACT 1995

Shire of Gingin

BEE KEEPING AMENDMENT LOCAL LAW 2015

Under the powers conferred by the *Local Government Act 1995* and all other relevant powers, the Council of the Shire of Gingin resolved on 27 October 2015 to make this local law.

1. Title

This local law may be cited as the Shire of Gingin Bee Keeping Amendment Local Law 2015.

2. Commencement

This local law commences on the 14th day after the day on which it is published in the *Government Gazette*.

3. Principal Local Law

This local law amends the *Shire of Gingin Bee Keeping Local Law 2004* as published in the *Government Gazette* on 13 September 2004.

4. Clause 3 amended

In clause 3—

(a) Insert new definitions in alphabetical order as follows—

- "Bee keeper" has the meaning given to it in regulation 3 of the Biosecurity and Agriculture Management Regulations 2013;
- "Rural Living Area" means any area zoned as Rural Living under the local government's Local Planning Scheme;
- "Schedule" means the Schedule to this local law; and
- (b) Amend the definition for "permit holder" by deleting the word "and".

5. Clause 4 amended

In clause 4(2)(a) delete "the townsite" and replace with "a townsite or Rural Living Area";

6. Clause 5 amended

In clause 5(a) delete "section 8 of the *Beekeeper's Act 1963*" and replace with "regulation 13 of the *Biosecurity and Agriculture Management (Identification and Movement of Stock and Apiaries) Regulations 2013*".

7. Clause 6 amended

In clause 6(4), following "issue" insert "for a period of five years,".

8. Clause 7 amended

Clause 7 is amended as follows—

- (a) In clause 7(1)(a) delete "a good and sufficient" and insert "an adequate and permanent";
- (b) In clause 7(1)(b)(i)—
 - (i) after "any" insert "neighbouring building,"; and
 - (ii) after "place" insert ", private street, laneway";
- (c) In clause 7(1)(c) delete "and";
- (d) In clause 7(1)(d) delete the full stop and replace with a semi colon; and
- (e) After subclause (1)(d) insert—
- (e) annual submission by the permit holder of a copy of a Bee Keeper's Licence as approved by the Department of Agriculture and Food, Western Australia; and
- (f) an annual inspection will be carried out by the local government.

9. Clause 8 amended

In clause 8(3)(a) delete "section 8 of the *Beekeeper's Act 1963*" and replace with "regulation 13 of the *Biosecurity and Agriculture Management (Identification and Movement of Stock and Apiaries) Regulations 2013*".

10. Clause 9 amended

(1) In clause 9(2)(a) delete "section 8 of the *Beekeeper's Act 1963*" and replace with "regulation 13 of the *Biosecurity and Agriculture Management (Identification and Movement of Stock and Apiaries) Regulations 2013*"; and

(2) In clause 9(3)(a) delete "section 8 of the *Beekeeper's Act 1963*" and replace with "regulation 13 of the *Biosecurity and Agriculture Management (Identification and Movement of Stock and Apiaries) Regulations 2013*".

11. Clause 12 amended

In clause 12(1) delete "Beekeeper's Act 1963" and replace with "Biosecurity and Agriculture Management Act 2007".

12. Clause 15 amended

In clause 15 delete "and 34".

13. Schedule amended

Delete the Schedule and insert—

- (2) Delete section 24(3) and insert:
 - (3) As often as is necessary, the Regulator is to request both the Chairman referred to in subsection (2) and the Perth Centre for Energy & Resources Arbitration Ltd to make a recommendation.
 - (4A) The request must specify a day (the *specified day*) before which the recommendation is to be made.
 - (4B) The Regulator may effect any necessary inclusion or removal of a name without complying with subsection (2) if
 - (a) the Regulator makes a request to both the Chairman referred to in subsection (2) and the Perth Centre for Energy & Resources Arbitration Ltd; and
 - (b) neither the Chairman referred to in subsection (2) nor the Perth Centre for Energy & Resources Arbitration Ltd make a recommendation before the specified day.



6.3.2 Despite the land use permissibility indicated in the Scheme Zoning Table or any provisions elsewhere in the Scheme, Planning Approval is required for any proposed use or development within the wastewater infrastructure special control area as depicted on the Scheme Map.

6.3.3 The Wastewater Treatment Plant and its associated infrastructure may create odour nuisance to surrounding land uses. Therefore, when determining applications for planning approval for development or land use within the Special Control Area, the Council shall—

- a. Consider the compatibility of the use or development with wastewater treatment plant infrastructure having regard to potential odour and noise emissions from the wastewater treatment plant;
- b. Consider whether the use or development would have a detrimental impact on the long term operation of the wastewater treatment plant;
- c. Obtain and have regard to the advice and recommendations of the wastewater treatment operator and the Department of Environmental Regulations and any relevant policies of the Department of Environment Regulation and the Western Australian Planning Commission, including State Planning Policy 4.1 (State Industrial Buffer Policy);
- d. Not approve any application for land use or development within the buffer that are considered to be sensitive land uses and would suffer unacceptable impacts from odour, or which by its nature may adversely impact on the continued operation of the wastewater treatment plant.
