Queen Elizabeth II Medical Centre (Delegated Site) Amendment By-laws 2016

Made under section 13(2e)(b) of the Act by the Minister in his capacity as the board of Sir Charles Gairdner Hospital with the approval of the deputy of the Governor given on the recommendation of the Trust.

1. Citation

These by-laws are the *Queen Elizabeth II Medical Centre (Delegated Site) Amendment By-laws 2016*.

2. Commencement

These by-laws come into operation as follows —

- (a) by-laws 1 and 2 — on the day on which these by-laws are published in the *Gazette*;
- (b) the rest of the by-laws — on 1 July 2016.

3. By-laws amended

These by-laws amend the *Queen Elizabeth II Medical Centre (Delegated Site) By-laws 1986*.

4. By-law 26AE amended

After by-law 26AE(4) insert:

- (4A) Unless sub-by-law (4) applies, within 14 days of receiving an application for a parking permit, an authorised person is to —
 - (a) grant a parking permit to the applicant; or
 - (b) by written notice given to the applicant, refuse to grant a parking permit to the applicant.

- (4B) An authorised person is to give written notice to an applicant who is granted a parking permit if —
- (a) the parking permit granted is not of the class requested by the applicant; or
 - (b) the parking permit is granted subject to a condition.
- (4C) Written notice under sub-by-law (4A)(b) or (4B) must state the reasons for the decision and provide information about the right to a review of the decision under by-law 26AF.

5. By-law 26AF inserted

After by-law 26AE insert:

26AF. Review of decisions about parking permits

- (1) In this by-law —
- committee* means the committee appointed under sub-by-law (4);
- decision* means a decision by an authorised person under by-law 26AE to —
- (a) refuse to grant a parking permit; or
 - (b) grant a parking permit of a class other than the class requested by the applicant; or
 - (c) grant a parking permit subject to a condition.
- (2) An applicant for a parking permit who is aggrieved by a decision may apply in writing in an approved form to the committee for a review of the decision.
- (3) An application for a review of a decision must be made by the applicant within 14 days after the applicant receives notice of the decision under by-law 26AE(4A)(b) or (4B).
- (4) The committee is to consist of 3 members appointed by the secretary, one of whom is to be a practitioner as defined in the *Hospitals and Health Services Act 1927* section 2(1).
- (5) An applicant must provide the committee with any additional information or document that the committee asks for to enable it to review the decision.
- (6) An applicant or other person must not give information in relation to a review that the person knows to be —
- (a) false or misleading in a material particular; or
 - (b) likely to deceive in a material way.

- (7) After reviewing a decision the committee, by written notice given to the applicant, is to affirm, reverse or vary the decision.
- (8) The committee is to give the notice referred to in sub-by-law (7) within 30 days of receiving the application for a review of the decision under sub-by-law (2).

RACING AND WAGERING WESTERN AUSTRALIA ACT 2003
RACING AND WAGERING WESTERN AUSTRALIA (FOB RULES)
NOTICE (NO. 4) 2016

Made by Racing and Wagering Western Australia under section 61 of the Act.

1. Citation

This notice is the *Racing and Wagering Western Australia (FOB Rules) Notice (No. 4) 2016*.

2. Commencement

These rules came into operation on 12 June 2012.

3. Interpretation

In this notice—

“**the Act**” means the *Racing and Wagering Western Australia Act 2003*;

“**the Rules**” means the rules described in clause 4, adopted by Racing and Wagering Western Australia.

4. Rules adopted under section 61 of the Act

(1) In a meeting held on 31 May 2012, Racing and Wagering Western Australia resolved—

(a) to adopt and operate under rules relating to a jointly operated fixed odds wagering system in accordance with section 61(2) and (4) of the Act.

(2) A copy of the rules adopted was published for public information in the *Special Gazette* of 12 June 2012 at pp. 2413-2441.

(3) Further amendments to the Rules were adopted by resolution of the Board dated 11 October 2012, 25 March 2013, 30 August 2013, 31 October 2013, 20 December 2013, 1 May 2014, 3 September 2014, 28 November 2014, 21 September 2015, 23 November 2015, 21 January 2016, 29 February 2016 and 4 April 2016 and published for public information in the *Gazettes* of 23 October 2012 at pp. 5058-5060, 5 April 2013 at pp. 1490-1491, 17 September 2013 at pp. 4337-4346,

15 November 2013 at pp. 5262-5265, 10 January 2014 at pp 24-25, 13 May 2014 at pp 1455-1465, 12 September 2014 at pp 3290-3291, 5 December 2014 at pp 4523-4525, 25 September 2015 at pp 3881-3883, 27 November at pp 4756-4758 29 January 2016 at pp 276-277, 4 March 2016 at pp 627-628 and 8 April 2016 at pp 1101-1103.

5. Changes to Rules published for public information section 61(6)(c) of the Act

(1) Further amendments to the Rules were adopted by resolution of the Board dated 27 June 2016.

(2) Those further amendments to the Rules are published in the Schedule to this notice for public information, as required by section 61(6)(c) of the Act.

Schedule 1—Amendments to Adopted Rules

- 12** In addition, RWWA reserves the right to—
- (a) place restrictions on a Client's RWWA Betting Account with or without notification; or
- close a Client's RWWA Betting Account and refund the balance of their account without further explanation. DECLARATION OF LOCAL-INTAKE AREAS FOR SCHOOLS WITH PRIMARY STUDENTS

(Pursuant to Sections 60, 78, 79 and 80)

The Hon. Minister for Education has declared that the local-intake areas for the schools listed hereunder shall be as stated in this notice. Children of compulsory school age who reside within the local-intake areas stated shall be entitled to attend the schools to which such local-intake areas apply if there is an appropriate educational program for them at that school. Children who reside outside these local-intake areas may apply to attend the schools to which such local-intake areas apply.

ALKIMOS SOUTH WEST PRIMARY SCHOOL (planning name) (Jun16)

The following will define the local-intake area of this school from 2017—

From the junction of Marmion Avenue and Santorini Promenade, north along Marmion Avenue (west side included) to Romeo Road, generally east along Romeo Road (north side included) to the proposed alignment of the Mitchell Freeway, north west along the proposed route of the Mitchell Freeway (west side included) to Pipidinny Road, west along Pipidinny Road (south side included) and its western extension to the coastline, generally south west along the coastline to a point on the western extension of Selacosa Way, east along this extension and east along Selacosa Way (north side included) to Marlinspike Boulevard, north along the northern extension of Marlinspike Boulevard (west side included) to the western extension of Santorini Promenade and east along the western extension of Santorini Promenade (north side included) to Marmion Avenue.

The following defines an optional local-intake area between Ashdale Primary School and Landsdale Primary School: The locality of Gngangara as delineated in the 2015 edition of the Perth UBD Street Directory.

AUBIN GROVE PRIMARY SCHOOL (Jun16)

The following defines an optional area between Forrestdale Primary School and Aubin Grove Primary School—

From the junction of Liddelow Road and Wilga Court, east from this junction to Taylor Road, south along Taylor Road (both sides included) to Rowley Road, west along Rowley Road (north side included) to Liddelow Road and north along Liddelow Road (east side included) to Wilga Court.

BALDIVIS PRIMARY SCHOOL (Jun16)

The following will define the local-intake area of this school from 2017—

From the junction of the Kwinana Freeway and Safety Bay Road, west along Safety Bay Road (north side included) to Mandurah Road, north along Mandurah Road (east side included) to the private road leading to the Tamworth Hill Reservoir, north east along this private road (south east side included) to the reservoir, north east along the private road (south east side included) to the junction with Eighty Road, north from this junction to the junction of Fifty Road and Snowflake Approach, north along Snowflake Approach (east side included) to Ingarfield Green, east along Ingarfield Green (south side included) to Firebrand Grove, north along Firebrand Grove (east side included) to Monger Road, east along Monger Road (south side included) to Beckingham Parkway, north along Beckingham Parkway (east side included) to Pugey Way, east along Pugey Way (south side included) to Liddard Garden, north along Liddard Garden (east side included) to Wall Way, east to and along the east-west section of Prendergast Turn (north side excluded) to the lot boundary between 30 Prendergast Turn and 32 Prendergast Turn, east along the lot boundary between 30 Prendergast Turn and 32 Prendergast Turn to Nairn Drive (30 Prendergast is included and 32 Prendergast is excluded), north along the proposed Nairn Drive (east side included) to Kerosene Lane, east along Kerosene Lane (south side included) to Baldivis Road, north along Baldivis Road (east side included) to the local government boundary between the Town of Kwinana and the City of Rockingham, east along this local government boundary to Duckpond Road, south east along Duckpond Road (south side included) to Banksia Road, generally north along Banksia Road (east side included) to the east-west railway line, east along the railway line to a point on the north west extension of the branch drain, south east along the branch drain to the Birriga Main Drain, south and south west along the main drain to Mundijong Road and west along Mundijong Road (north side included) to Wilkinson Road, south west along Wilkinson Road (both sides included-it is located beside a drain) to the confluence of the drain with the Serpentine River, west from this confluence to Doghill Road, south west, south and west along Doghill Road (north side included) to Young Road, west along the westerly extension of Doghill Road to the Kwinana Freeway and north along the Kwinana Freeway (east side included) to Safety Bay Road.

BYFORD PRIMARY SCHOOL (Jun16)

The following will define the local-intake area of this school from 2017—

From the point at which Wungong Brook crosses the South Western Highway, east along Wungong Brook to Wungong Reservoir, southeast along Wungong Reservoir to 28 Mile Road, east along 28 Mile Road (both sides included) to Albany Highway, southeast along Albany Highway (both sides included) to Coronation Road, west along Coronation Road (both sides included) to Nettleton Road, south along Nettleton Road (both sides included) to Manjedal Brook, west along Manjedal Brook to the South Western Highway and north along South Western Highway (east side included) to Wungong Brook.

From the intersection of Hepburn Avenue and Mirrabooka Avenue, north along Mirrabooka Avenue (east side included) to Kingsway, east along Kingsway (south side included) to Abbotswood Drive, north and east along Abbotswood Drive (east and south sides included) to Hersey Parkway, east along Hersey Parkway (both sides included) to Sherwin Rise, north and west along Sherwin Rise to the pathway at the end of the cul-de-sac, north along the pathway to Mossfiel Retreat, east along the western section of Mossfiel Retreat (both sides excluded) to the pathway at the end of the cul-de-sac, east along the pathway to the eastern section of Mossfiel Retreat, east along the eastern section of Mossfiel Retreat (both sides included) to Babylon Bend, north and east along Babylon Bend (east and south sides included) to and across Alhambra Parkway to the junction of Thaxter Road and Monticello Meander, east along Thaxter Road
