Supreme Court (Jury Districts and Circuit Towns) Proclamation 2016

Made under the *Supreme Court Act 1935* section 46 and the *Juries Act 1957* Part III by the Governor in Executive Council.

1. Citation

This proclamation is the *Supreme Court (Jury Districts and Circuit Towns) Proclamation 2016*.

2. Commencement

This proclamation comes into operation as follows —

- (a) clauses 1 and 2 — on the day on which this proclamation is published in the *Gazette*;
- (b) the rest of the proclamation — on the day after that day.

3. Terms used

In this proclamation —

electoral district means an electoral district created under the *Electoral Act 1907* Part IIA;

electoral region means an electoral region created under the *Electoral Act 1907* Part IIA.

4. Proclamation revoked

The proclamation made under the *Supreme Court Act 1935* section 46 and the *Juries Act 1957* Part III on 22 January 2013 and published in the *Gazette* on 12 February 2013 at p. 919-20 is revoked.

5. Jury district for Supreme Court

The jury district for the Supreme Court is determined and declared to consist of the area described in Schedule 1.

6. Circuit towns and jury districts for Circuit Courts

- (1) Each place in Schedule 2 column 1 is a circuit town.
- (2) The jury district for each Circuit Court at a circuit town is declared to consist of the area in Schedule 2 column 2 opposite the circuit town in column 1 of that Schedule.

District Court of Western Australia Act 1969

District Court (Mandatory Testing Infectious Diseases) Appeal Rules 2016

Made by the judges of the District Court.

1. Citation

These rules are the *District Court (Mandatory Testing Infectious Diseases) Appeal Rules 2016*.

2. Commencement

These rules come into operation as follows —

- (a) rules 1 and 2 — on the day on which these rules are published in the *Gazette*;
- (b) the rest of the rules — on the day after that day.

3. Terms used

- (1) In these rules, unless the contrary intention appears —
Act means the *Mandatory Testing (Infectious Diseases) Act 2014*;
approved form means a form approved by the Court;
disease test order appeal means an appeal under Part 3 Division 5 of the Act.
- (2) Unless the contrary intention appears, a term used in these rules has the same meaning as it has in the *District Court Rules 2005*.

4. Non-application of *District Court Rules 2005* Part 6

The *District Court Rules 2005* Part 6 does not apply to a disease test order appeal.

5. Nature of appeal

- (1) In this rule —
primary court, in relation to a disease test order appeal, means the court that made the relevant disease test order as defined in section 15 of the Act.
- (2) A disease test order appeal must be by way of a reconsideration of the evidence that was before the primary court unless the parties agree otherwise.
- (3) At the hearing of the appeal a party must not adduce evidence that was not adduced in the primary court except with the leave of the Court.

- (4) The Court is not to grant such leave unless satisfied there are special grounds for doing so.

6. Commencement of appeal

- (1) To commence a disease test order appeal the appellant must give a notice of appeal in an approved form.
- (2) Except as provided in rule 9, the notice must set out the grounds for the appeal in accordance with subrule (3).
- (3) The grounds of appeal in a notice of appeal must not merely allege that an appealable decision is against the weight of the evidence or that it is wrong in law, they must specify the particulars relied on to demonstrate that the decision is against the weight of the evidence or the specific reasons why it is wrong in law.

7. Giving notice of appeal

To give a notice of appeal for the purposes of subrule 6, the appellant must —

- (a) file the notice; or
- (b) give notice under rule 9(1).

8. Filing notice of appeal

- (1) In addition to the *District Court Rules 2005* Part 3 Division 2, the notice of appeal may be filed by an email sent to the relevant registry.
- (2) As soon as practicable after filing a notice of appeal, the appellant must —
 - (a) serve it on the respondent; and
 - (b) file a certificate of service in an approved form.
- (3) A notice of appeal given under rule 9(1) is taken to have been filed for the purposes of Part 3 Division 5 of the Act.

9. Notice of appeal outside business hours

- (1) When a registry is not open for business, an appellant may give a notice of appeal by calling the Court's emergency telephone number as shown on the Court's website.
- (2) If notice of appeal is given under subrule (1), the appellant is not required to comply with rule 6 except to the extent directed under subrule (3).
- (3) The Court may give directions as to —
 - (a) how and when the appellant is to specify the grounds for the appeal (including whether the appellant is required to prepare a notice of appeal in accordance with rule 6 and, if so, when that notice is to be given to the Court); and

- (b) how and when the appellant is to notify the respondent of the appeal, the grounds of the appeal and the date, time and place of the hearing of the appeal.

10. Hearing of appeal

- (1) The hearing of a disease test order appeal may, in accordance with directions of the Court, be held —
 - (a) at any place, including a place outside the Court's usual place of business; or
 - (b) by telephone.
- (2) The hearing of a disease test order appeal is not to be heard in open court and all persons other than a party to the appeal or the party's legal practitioner are to be excluded during the appeal, except as otherwise directed by the Court.

11. No fees

No fees are payable in relation to a disease test order appeal.

12. No costs

No costs are to be awarded in relation to a disease test order appeal.

Metropolitan Redevelopment Authority Act 2011

Metropolitan Redevelopment Authority Amendment Regulations 2016

Made by the Governor in Executive Council.

1. Citation

These regulations are the *Metropolitan Redevelopment Authority Amendment Regulations 2016*.

2. Commencement

These regulations come into operation as follows —

- (a) regulations 1 and 2 — on the day on which these regulations are published in the *Gazette*;
- (b) the rest of the regulations — on the day after that day.

3. Regulations amended

These regulations amend the *Metropolitan Redevelopment Authority Regulations 2011*.

4. Regulation 3 replaced

Delete regulation 3 and insert:

3. Terms used

In these regulations —

Heritage Council means the Heritage Council of Western Australia established under the *Heritage of Western Australia Act 1990* section 5;

heritage inventory means an inventory of heritage places and heritage precincts prepared by the Authority under a redevelopment scheme;

heritage place means land, or a building or other structure, that is —

- (a) identified as a heritage place in a redevelopment scheme or in a plan, strategy or other instrument relating to heritage prepared and adopted under a redevelopment scheme; or
- (b) located within a heritage precinct; or
- (c) listed on the Register of Heritage Places;

heritage precinct means an area that is identified as a heritage precinct on a heritage inventory;

public work has the meaning given in the *Public Works Act 1902* section 2;

R-Codes means the Residential Design Codes prepared by the Western Australian Planning Commission under the *Planning and Development Act 2005* section 26, as amended from time to time;

Register of Heritage Places means the Register established under the *Heritage of Western Australia Act 1990* section 46;

section means a section of the Act;

subdivision works means works for the purpose of enabling the subdivision of land and includes, to the extent necessary for the subdivision, the following —

- (a) site works, including remediation;

- (b) road works;
- (c) the provision of utility services;

utility services means drainage, electricity, sewerage, water, gas and telecommunications supply services.

A declaration under regulation 8 or 9(2) that any work, act or activity does not constitute development does not include a reference to any work, act or activity carried out in, or in relation, to a heritage place unless the work, act or activity is carried out —

- (b) in accordance with a conservation plan, or other agreement relating to the conservation of heritage places, prepared by the Authority in consultation with the Heritage Council.

- (a) the carrying out of minor ground work if the cumulative change (including any sand pad or site works associated with building) in the natural ground level over the 5 years before the completion of the work is no more than 0.5 m;
 - (b) the carrying out of work inside a building that is not related to a change of use of any part of the building and does not alter its external appearance;
 - (c) the construction of a swimming pool or a pool barrier if the swimming pool or pool barrier is associated with a dwelling and is behind the front setback of the lot;
 - (d) the erection, maintenance or alteration of a boundary fence or wall if the fence or wall —
 - (i) is between 2 private properties; and
 - (ii) is behind the front setback of the lot; and
 - (iii) is not greater than 1.8 m in height; and
 - (iv) does not face a road or a public place;
 - (e) the demolition or removal of a single dwelling or of a minor or ancillary structure, such as a patio, pergola, garage, carport, fence, shed, store room or similar structure;
 - (f) the erection of a single story extension to a single dwelling if the extension is behind the front setback of the lot and complies with —
 - (i) the design guidelines for single dwellings in the redevelopment scheme for the redevelopment area; or
 - (ii) if there are no design guidelines for single dwellings in the development scheme for the redevelopment area — the deemed-to-comply requirements of the R-Codes;
 - (g) the erection of a single dwelling on a lot with an area greater than 260 m², if the dwelling complies with —
 - (i) the design guidelines for single dwellings in the redevelopment scheme for the redevelopment area; or

- (ii) if there are no design guidelines for single dwellings in the development scheme for the redevelopment area — the deemed-to-comply requirements of the R-Codes;
- (h) the erection of a minor or ancillary structure such as a patio, pergola, garage, carport, fence, shed, store room or similar structure if the structure complies with an applicable policy published by the Authority;
- (i) the erection of signage or advertising if the signage or advertising complies with an applicable policy published by the Authority.

Planning and Development (Development Assessment Panels) Amendment Regulations 2016

Made by the Governor in Executive Council.

1. Citation

These regulations are the *Planning and Development (Development Assessment Panels) Amendment Regulations 2016*.

2. Commencement

These regulations come into operation as follows —

- (a) regulations 1 and 2 — on the day on which these regulations are published in the *Gazette*;
- (b) the rest of the regulations — on 1 February 2017.

3. Regulations amended

These regulations amend the *Planning and Development (Development Assessment Panels) Regulations 2011*.

4. Regulation 3 amended

- (1) In regulation 3(1) in the definition of *specialist member* delete “25(1)(b).” and insert:

25(1)(b);

- (2) In regulation 3(1) insert in alphabetical order:

- (a) development in the district of the City of Perth that has an estimated cost of \$2 million or more and less than \$20 million;
- (b) development in a district outside of the district of the City of Perth that has an estimated cost of \$2 million or more and less than \$10 million;

- (c) development of a warehouse in any district that has an estimated cost of \$2 million or more.

 - (c) the terms of any condition to which the approval of the application is subject;
 - (d) reasons for any refusal of the application.

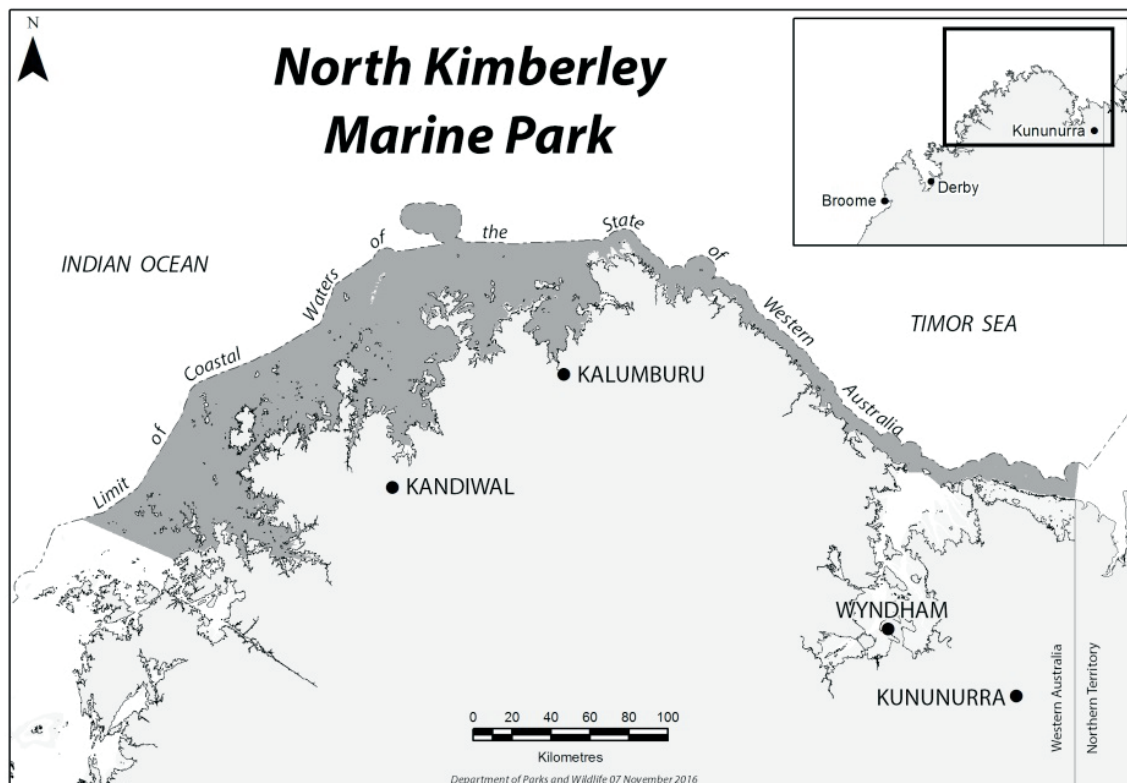
