CONSERVATION AND LAND MANAGEMENT 1984 PUBLIC FIREWOOD AREAS ORDER 2016

Made by the CEO under the *Forest Management Regulations 1993* regulation 98.

1. Citation

This order is the *Public Firewood Areas Order 2016*.

2. Commencement

This order comes into operation as follows—

- (a) clauses 1 and 2—on the day on which this order is published in the *Gazette*;
- (b) the rest of the order—on the day after that day.

3. Public firewood area

(1) The area of State forest named in Schedule 1 column 1 and described in Schedule 1 column 3 is—

- (a) set aside for the purposes of the collection of firewood by members of the public; and
- (b) designated as being an area to which the *Forest Management Regulations 1993* regulation 100 applies.

(2) The locations of the areas referred to in subclause (1) are shown on the relevant DECMAP referred to in Schedule 1 column 2.

Electricity Industry Act 2004

**Electricity Industry Exemption Amendment
Order (No. 2) 2016**

Made by the Governor in Executive Council.

1. Citation

This order is the *Electricity Industry Exemption Amendment Order (No. 2) 2016*.

2. Commencement

This order comes into operation as follows —

- (a) clauses 1 and 2 — on the day on which this order is published in the *Gazette* (**gazettal day**);
- (b) clause 5 — on the day on which the *Electricity Industry (Solar Power Purchase Agreements) Exemption Order 2016* clause 3 comes into operation;
- (c) the rest of the order — on the day after gazettal day.

3. Order amended

This order amends the *Electricity Industry Exemption Order 2005*.

4. Clause 3A amended

- (1) In clause 3A delete the definition of **commercial premises**.
- (2) In clause 3A insert in alphabetical order:

non-residential property means a property or any part of a property that is not —

- (a) a residential property; or
- (b) a site as defined in the *Caravan Parks and Camping Grounds Act 1995* section 5(1);

property means a parcel of land and includes —

- (a) a part of a parcel of land; and
- (b) 2 or more parcels of land with common boundaries that are constituted, owned or occupied as 1 property;

residential property means a property or any part of a property used, or intended to be used, as a person's principal place of residence but does not include a site

as defined in the *Caravan Parks and Camping Grounds Act 1995* section 5(1);

5. Clause 3B inserted

After clause 3A insert:

3B. Application of order

This order does not apply to a person in relation to the supply of electricity to a customer under a solar power purchase agreement as defined in the *Electricity Industry (Solar Power Purchase Agreements) Exemption Order 2016* clause 3.

6. Clause 4A amended

(1) In clause 4A(1A):

(a) in paragraph (a) delete “commercial premises; and” and insert:

a non-residential property; and

(b) in paragraph (b) delete “those premises.” and insert:

the property.

(2) In clause 4A(1):

(a) in paragraph (a) after “connected” insert:

(b) after paragraph (a) insert:

(aa) is located or to be located on a non-residential property; and

(c) in paragraph (b) delete “commercial premises” and insert:

8. Clause 4 replaced

Delete clause 4 and insert:

4. Exemptions for on-supply

- (1) A person is exempt from the *Electricity Industry Act 2004* section 7(2) if the transmission system concerned —
- (a) is located or to be located on a non-residential property; and
 - (b) is used or to be used solely for the transportation of electricity for consumption on the property.
- (2) A person is exempt from the *Electricity Industry Act 2004* section 7(3) if the distribution system concerned —
- (a) is located or to be located on a property; and
 - (b) is used or to be used solely for the transportation of electricity for consumption on the property.
- (3) A person who is exempt under subclause (1) is exempt from the *Electricity Industry Act 2004* section 7(4), in relation to the sale of electricity transported by the

transmission system, if the electricity is sold for consumption on the property.

- (4) A person who is exempt under subclause (2) is exempt from the *Electricity Industry Act 2004* section 7(4), in relation to the sale of electricity transported by the distribution system, if the electricity is sold for consumption on the property.
- (5) The exemptions provided for in this clause —
- (a) are subject to the conditions set out in clause 6; and
 - (b) do not apply to the Rottnest Island Authority established under the *Rottnest Island Authority Act 1987*.

9. Clause 5 deleted

Delete clause 5.

10. Clause 6 amended

- (1) Delete clause 6(1) and insert:

- (1) In this clause —

electricity reticulation system means any apparatus, plant or equipment that is used for, or in connection with, the transportation of electricity to a property;

exempt supplier, in relation to a property, means a person who is exempt from the *Electricity Industry Act 2004* section 7(2), (3) or (4) under clause 4 in relation to the property;

occupier, of a property, means a person in lawful occupation of the property.

- (2) Delete clause 6(3) and insert:

- (3) Without limiting subclause (2), electricity services include —

- (a) the provision and maintenance of an electricity reticulation system; and
- (b) the connection of a property to an electricity reticulation system; and
- (c) the provision, maintenance and reading of a meter to measure and record the quantity of electricity supplied to a property; and
- (d) the preparation and issue of accounts in relation to the supply of electricity to a property; and

- (e) anything incidental to or associated with a matter referred to in paragraph (a), (b), (c) or (d).

- (3) In clause 6(4) delete “the relevant premises by the supplier is supplied to the supplier by the Electricity Generation and Retail Corporation, any charge imposed by the supplier” and insert:

a residential property by an exempt supplier is supplied to the exempt supplier by the Electricity Generation and Retail Corporation, any charge imposed by the exempt supplier

- (4) In clause 6(5A) delete “the relevant premises by the supplier is supplied to the supplier by the Regional Power Corporation, any charge imposed by the supplier” and insert:

a residential property by an exempt supplier is supplied to the exempt supplier by the Regional Power Corporation, any charge imposed by the exempt supplier

- (5) Delete clause 6(5) and insert:

- (5) If electricity supplied to a residential property by an exempt supplier is generated using generating works that are owned or operated by the exempt supplier, any charge imposed by the exempt supplier for that electricity must not exceed the amount necessary for the exempt supplier to recover the costs of generation.

- (6) In clause 6(6) delete “the supplier for the provision of electricity services in relation to the relevant premises” and insert:

an exempt supplier for the provision of electricity services in relation to a residential property

- (7) In clause 6(7A) after “operated by the” insert:

exempt

- (8) Delete clause 6(7) and insert:
- (7) If an exempt supplier supplies electricity to a property, the exempt supplier must make available to an occupier of the property information that clearly sets out —
- (a) the quantity of electricity supplied to the occupier; and
 - (b) the fees and charges payable by the occupier —
 - (i) for electricity supplied; and
 - (ii) for the provision of electricity services in relation to the property.
- (9) In clause 6(9) delete “a resident of the relevant premises, the supplier must inform the resident” and insert:

an occupier of the property, the exempt supplier must inform the occupier of

- (1) In this clause —
- Eastern Metropolitan Regional Council*** means Eastern Metropolitan Regional Council (ABN 89 631 866 056);
- Hazelmere*** means Hazelmere Resource Recovery Park, 77 Lakes Road, Hazelmere, Western Australia;
- Perth Airport*** means Lot 100 on Plan 6619 being the whole of the land comprised in certificate of title volume 2124 folio 980;
- Perth Airport Pty Ltd*** means Perth Airport Pty Ltd (ABN 24 077 153 130).

Electricity Industry Act 2004

Electricity Industry (Solar Power Purchase Agreements) Exemption Order 2016

Made by the Governor in Executive Council.

1. Citation

This order is the *Electricity Industry (Solar Power Purchase Agreements) Exemption Order 2016*.

2. Commencement

This order comes into operation as follows —

- (a) clauses 1 and 2 — on the day on which this order is published in the *Gazette*;
- (b) the rest of the order — on the day after that day.

3. Terms used

In this order —

complaint means an expression of dissatisfaction made in writing and given to a supplier where a response or resolution from the supplier is explicitly or implicitly expected or legally required;

Coordinator has the meaning given in the *Energy Coordination Act 1994* section 3(1);

solar power purchase agreement means an agreement between a supplier and a customer under which the customer purchases electricity generated by a solar power system specified in the agreement;

solar power system means a system of photovoltaic arrays;

supplier means a person who is a supplier under clause 4(1).

4. Exemption

- (1) The following persons are suppliers —
 - (a) CSP National Pty Ltd (ABN 24 168 946 914);

- (b) Distributed Power Generation Limited
(ABN 15 610 829 386);
 - (c) Efficient Homes Australia Pty Ltd
(ABN 36 141 430 328);
 - (d) Origin Energy Retail No. 2 Pty Limited
(ABN 49 601 182 790);
 - (e) Protean Energy Ltd (ABN 81 119 267 391);
 - (f) Voltaic Energy Pty Ltd (ABN 38 162 893 889);
 - (g) Zeus Appollo Pty Ltd (ABN 99 151 279 908).
- (2) A supplier is exempt from the *Electricity Industry Act 2004* section 7(4) if the electricity is sold to the customer under a solar power purchase agreement.

5. Condition: written disclosure statement

- (1) The exemption is subject to the condition that before the solar power purchase agreement was executed by the customer the supplier had given the customer a written disclosure statement containing the following —
- (a) a statement to the effect that the solar power purchase agreement is separate from any standard form contract or non-standard contract (as those terms are defined in the *Electricity Industry Act 2004* section 47) that the customer may have with a person who holds a retail licence or an integrated regional licence;
 - (b) a statement to the effect that the supplier is not required to hold a retail licence or an integrated regional licence under the *Electricity Industry Act 2004* section 7(4) in relation to the sale of electricity to the customer because the supplier is relying on the exemption set out in the *Electricity Industry (Solar Power Purchase Agreements) Exemption Order 2016*;
 - (c) a statement to the effect that the solar power purchase agreement may be subject to the *Australian Consumer Law (WA)*;
 - (d) the term of the solar power purchase agreement;
 - (e) the customer's options at the end of the solar power purchase agreement;
 - (f) the fees and charges the customer is required to pay under the solar power purchase agreement including the per unit rate the customer is required to pay for the electricity and how the rate can change;
 - (g) the type of meter that will be used to measure the generation output of the solar power system;
 - (h) the accuracy of the meter referred to in paragraph (g);
 - (i) the following, as estimated by the supplier —
 - (i) the generation output of the solar power system for the period of 12 months beginning on the day

- the solar power system is expected by the supplier to begin generating electricity;
- (ii) the cost of the solar power purchase agreement to the customer for the period of 12 months beginning on the day the solar power system is expected by the supplier to begin generating electricity;
 - (j) the format and frequency of the bills to be given to the customer;
 - (k) a summary of the rights and obligations of the customer and the supplier in relation to the termination of the solar power purchase agreement;
 - (l) a summary of the obligations of the customer under the solar power purchase agreement;
 - (m) the name and contact details of the person responsible for the maintenance of the solar power system;
 - (n) the name and contact details of the person responsible for repairs to the solar power system;
 - (o) the dispute resolution procedure to be used to deal with a dispute between the supplier and the customer about the solar power purchase agreement;
 - (p) any other information that is reasonably necessary to enable the customer to make an informed assessment of the solar power purchase agreement.
- (2) The condition in subclause (1) is taken to be observed by the supplier if the solar power purchase agreement was assigned to the supplier from another supplier and the other supplier observed the condition in subclause (1).
- (3) The exemption is subject to the condition that, if the supplier becomes aware or ought reasonably to have become aware that information in the disclosure statement given under subclause (1) is incomplete, false or misleading, the supplier gives to the customer an updated disclosure statement as soon as practicable.

6. Condition: written report

- (1) The exemption is subject to the condition that the supplier, in respect of the most recently ended financial year (the *financial year*) gives to the Coordinator before 31 August in the following financial year a written report containing the following —
- (a) the number of solar power purchase agreements executed by or assigned to the supplier during the financial year;
 - (b) the number of solar power purchase agreements to which the supplier was a party as at the end of the financial year;

- (c) the number of solar power systems covered by solar power purchase agreements executed by or assigned to the supplier during the financial year;
 - (d) the number of solar power systems covered by solar power purchase agreements to which the supplier was a party as at the end of the financial year;
 - (e) the generation capacity in kilowatts of the solar power systems covered by solar power purchase agreements to which the supplier was a party as at the end of the financial year;
 - (f) the number and type of complaints received by the supplier in relation to solar power purchase agreements during the financial year.
- (2) The exemption is not subject to the condition in subclause (1) in respect of a financial year if the supplier was not a supplier at any time during the previous financial year.

Energy Coordination Act 1994

Energy Coordination Exemption Amendment Order 2016

Made by the Governor in Executive Council.

1. Citation

This order is the *Energy Coordination Exemption Amendment Order 2016*.

2. Commencement

This order comes into operation as follows —

- (a) clauses 1 and 2 — on the day on which this order is published in the *Gazette*;
- (b) the rest of the order — on the day after that day.

3. Order amended

This order amends the *Energy Coordination Exemption Order 2009*.

4. Clause 2A inserted

After clause 2 insert:

2A. Terms used

In this order —

exempt supplier, in relation to a property, means a person who is exempt from the *Energy Coordination Act 1994* section 11G(1) or (2) under clause 4 in relation to the property;

occupier, of a property, means a person in lawful occupation of the property;

property means a parcel of land and includes —

- (a) a part of a parcel of land; and
- (b) 2 or more parcels of land with common boundaries that are constituted, owned or occupied as 1 property;

residential property means a property or any part of a property used, or intended to be used, as a person's principal place of residence.

5. Clauses 4 and 5 replaced

Delete clauses 4 and 5 and insert:

4. Exemptions for on-supply

- (1) A person is exempt from the *Energy Coordination Act 1994* section 11G(1) if the distribution system concerned —
 - (a) is located or to be located on a property; and
 - (b) is used or to be used solely for the transportation of gas for consumption on the property.
- (2) The exemption provided for in subclause (1) is subject to the conditions set out in clause 5(1) to (3).
- (3) A person who sells to a small use customer gas transported through a distribution system located on a property is exempt from the *Energy Coordination Act 1994* section 11G(2) if the gas is sold for consumption on the property.
- (4) The exemption provided for in subclause (3) is subject to the conditions set out in clause 5.

5. Condition applying to exemptions for on-supply

- (1) If an exempt supplier supplies gas to a property, the exempt supplier must make available to an occupier of the property information that clearly sets out —
 - (a) the volume of gas supplied to the occupier; and
 - (b) the volumetric charge for the gas payable by the occupier; and

 - (b) any service fee or charge attributable to the supply of the gas paid or payable by the exempt supplier.

BIOSECURITY AND AGRICULTURE MANAGEMENT ACT 2007 ALTERNATIVE REQUIREMENTS

Pursuant to section 44 of the *Biosecurity and Agriculture Management Act 2007* (the Act) the A/Director General of the Department of Agriculture and Food has approved requirements for the intra-state movement of certain potential carriers of declared pests. These requirements take effect as an alternative to the requirements currently imposed under regulation 20 and 21 of the *Biosecurity and Agriculture Management Regulations 2013*. The requirements will remain in place until 10 April 2017, by which time they will be made permanent by amendment of the regulations. Failure to comply with the requirements constitutes an offence under the Act and penalties apply. Of particular importance are the requirements relating to the movement of banana containers to Kununurra and Carnarvon. These have been introduced to combat the threat of introduction of Panama Disease, a devastating disease of bananas recently found in Queensland.

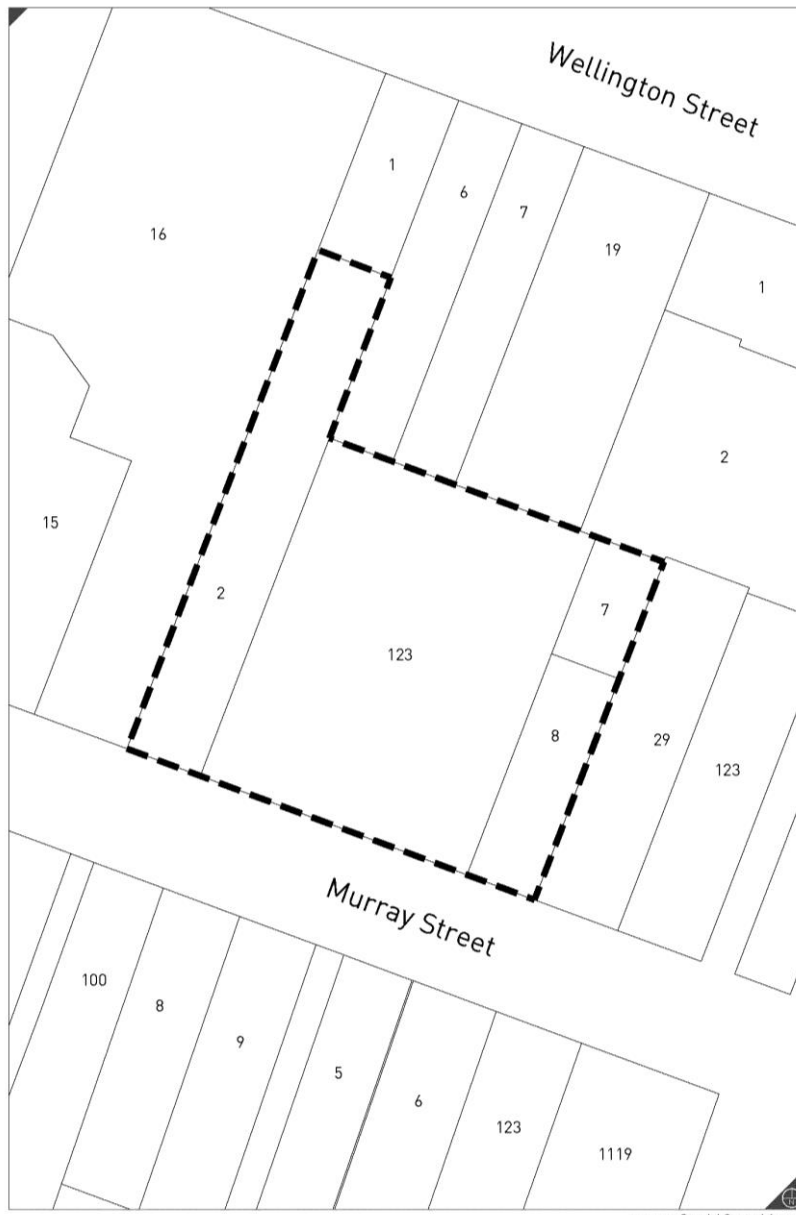


Figure 22.1 - Lots 2, 7, 8 and 123 Murray Street, Perth
