## CONSERVATION AND LAND MANAGEMENT 1984

FOREST MANAGEMENT (PUBLIC FIREWOOD AREAS) ORDER 2017 Made by the CEO under the Forest Management Regulations 1993 regulation 98.

#### 1. Citation

This order is the Forest Management (Forest Management (Public Firewood Areas) Order 2017.

#### 2. Commencement

This order comes into operation as follows—

- (a) clauses 1 and 2—on the day on which this order is published in the *Gazette*;
- (b) the rest of the order—on the day after that day.

#### 3. Public firewood area

- (1) The area of State forest named in Schedule 1 column 1 and described in Schedule 1 column 3 is—
  - (a) set aside for the purposes of the collection of firewood by members of the public; and
  - (b) designated as being an area to which the Forest Management Regulations 1993 regulation 100 applies.
- (2) The locations of the areas referred to in subclause (1) are shown on the relevant Parks and Wildlife map referred to in Schedule 1 column 2.

Library Board of Western Australia Act 1951

# Library Board (State Library) Amendment Regulations 2017

Made by the deputy of the Governor in Executive Council.

# 1. Citation

These regulations are the *Library Board (State Library) Amendment Regulations 2017.* 

#### 2. Commencement

These regulations come into operation as follows —

- (a) regulations 1 and 2 on the day on which these regulations are published in the *Gazette*;
- (b) the rest of the regulations on the day after that day.

# 3. Regulations amended

These regulations amend the *Library Board (State Library) Regulations 1956*.

# 4. Regulations 32 and 33 replaced

Delete regulations 32 and 33 and insert:

# 32. Persons may be excluded from library

- (1) The librarian may exclude a person from the library if the person
  - (a) is behaving in a disorderly manner; or
  - (b) appears to be affected by alcohol or drugs; or
  - (c) accesses any indecent, obscene or offensive content on a computer or other electronic device in a public area of the library and continues to do so after being directed to stop by the librarian; or
  - (d) is not using the library for the purpose for which it is intended; or
  - (e) has committed a breach of these regulations and it appears likely that the person's continued presence in the library may lead to a further breach of these regulations.
- (2) The librarian must give a person who is excluded under subregulation (1) a written notice that
  - (a) states the person is excluded from the library; and
  - (b) specifies the period of exclusion; and
  - (c) explains the reason for the exclusion; and
  - (d) informs the person about the person's right to apply to the Board under subregulation (4)(c) for a review of the exclusion.
- (3) The librarian may determine the period of exclusion for the purposes of subregulation (2)(b) which must not be longer than 2 years.
- (4) A person who is excluded under subregulation (1)
  - (a) if applicable must leave the library immediately; and

- (b) must not enter the library during the period of exclusion; and
- (c) may apply in writing to the Board for a review of the exclusion.
- (5) On application under subregulation (4)(c), the Board may
  - (a) confirm the exclusion; or
  - (b) revoke the exclusion; or
  - (c) substitute a different period of exclusion.

- (v) In Precinct Plan P5 and in Precinct Plan P11 Sheet B for the 'Residential/Commercial' zone under the heading 'Policy Note' replace the words 'the Town Planning Scheme Policy Manual' with 'a planning policy'.
- (vi) In Precinct Plan P5 delete the words 'contained in the Town Planning Scheme' at the end of the sentence commencing 'Development on Lots 14, 15 and 41 Armagh Street'.
- (u) Amend Precinct Plan P2 Sheet B as follows—
  - (i) Delete all text under the heading 'Structure Plan' and replace with the following wording—

Development within the Special Use zone is to be generally consistent with the approved Burswood Lakes Structure Plan. In relation to applications for development or subdivision approval within the Special Use Zone, the decision-maker is to have due regard to the approved structure plan when determining the application.

The approved structure plan may be amended in accordance with deemed clause 29, and inclusive of public consultation.

- (ii) In (1)(b) ii. replace the words 'contained in the Town of Victoria Park Town Planning Scheme No. 1 Policy Manual',. with 'planning policy'.
- (iii) Under the heading 'Variation to Development Standards' replace the words 'clause 36 of the Scheme' with 'deemed clause 67' and delete the words 'in accordance with clause 35(2)'
- (iv) Under the heading 'General Design Guidelines' replace the words 'as contained in the Town of Victoria Park Town Planning Scheme No. 1 Policy Manual', with 'planning policy'.

TEMPORARY SUSPENSION OF REGULATIONS

I, Michael Sparkman, Inspector being the delegated officer of the Minister for Transport under Section 139 of the *Road Traffic (Administration) Act 2008*, pursuant to the powers conferred by Section 139 of that Act, and the consent of the Local Authorities having been obtained and nominated for the purposes of:

A Cycling Road Races by members/entrants of the West Coast Masters Cycling Council Inc on 11 December 2016 between the hours of 08:00 Hrs and 11:30 Hrs, 12 February 2017 between the hours of 08:00 Hrs and 11:30 Hrs, 9 April 2017 between the hours of 08:00 Hrs and 11:30 Hrs do hereby approve the temporary suspension of the Road Traffic Act and/or Regulations made under such act on the carriageway(s) mentioned hereunder.

Racing to be confined to the left of the carriageway on—

William Street, Lefroy Avenue, Oakover Road, Campersic Road and William Street, in the City of Swan. Temporary suspension of the Road Traffic Act and Regulations applies to Regulation 130 (2) of the Road Traffic Code 2000 (to allow cyclists to ride in a peloton and overtake each other more than two or three abreast). Cyclists must keep left of the centre of the road, unless overtaking a slow moving vehicle where safe to do so, or they are conducting the official start and sprint finish where accredited traffic controllers with stop/slow bats are stopping and holding opposing traffic in accordance with the approved traffic management plan.

All participants to wear approved head protection at all times.
