Mental Health Act 2014

**Mental Health (Authorisation of Public Hospitals) Order 2017**

Made by the Governor in Executive Council under section 542 of the Act.

**1. Citation**

This order is the *Mental Health (Authorisation of Public Hospitals) Order 2017*.

**2. Commencement**

This order comes into operation as follows —

- (a) clauses 1 and 2 — on the day on which this order is published in the *Gazette*;
- (b) the rest of the order — on the day after that day.

**3. Term used: plan**

- (1) In this order —

*plan* means a plan the original of which is held by the person with management and control of the public hospital represented on the plan.

- (2) A copy of each plan referred to in Schedule 1 is to be held for information purposes in the offices of the Chief Psychiatrist in Perth.

#### 4. Authorisation of hospitals

The parts of the public hospitals specified in Schedule 1 are authorised for —

- (a) the reception of persons under the Act; and
- (b) the admission of involuntary patients.

#### 5. Revocation

The *Mental Health (Authorisation of Public Hospitals) Order 2002* is revoked.
