Lotteries Commission (Authorised Lotteries) Amendment Rules 2017

Made by the Lotteries Commission under section 28(1) of the Act.

1. Citation

These rules are the *Lotteries Commission (Authorised Lotteries) Amendment Rules 2017*.

2. Commencement

These rules come into operation as follows —

- (a) rules 1 and 2 — on the day on which these rules are published in the *Gazette*;
- (b) the rest of the rules — on the day after that day.

3. Rules amended

Lotto Bloc means the group that has entered into a Bloc Agreement, made up of the Commission and other designated authorities, for the promotion, conduct and sale of tickets in a particular type of lotto, when that term appears in the rules to that type of lotto;

player has the equivalent meaning to ***subscriber***;

self-serve kiosk means a self-contained processing station operated by the player, for digital entries into lotto;
