On 12 June 2017 the Commissioner for Consumer Protection (Commissioner) served notices on EAST KIMBERLEY AERO CLUB (INC)—A1006023E, DREAMBOATS LUXURY MOTOR YACHT CLUB INC—A1010327W and GETAWAY CRUISING CLUB INC—A1017131D (the Associations) pursuant to section 145(1) of the *Associations Incorporation Act 2015* (Act) informing it that if they did not show cause on or before 60 days after the day on which the notice was given (Allowed Period) the incorporation of the Associations would be cancelled.
