Retail Trading Hours Act 1987

### **Retail Trading Hours (Metropolitan Area) Variation Order 2017**

Made by the Minister for Commerce and Industrial Relations under section 12E of the Act.

**1. Citation**

This order is the *Retail Trading Hours (Metropolitan Area) Variation Order 2017*.

**2. Commencement**

This order comes into operation as follows —

- (a) clauses 1 and 2 — on the day on which this order is published in the *Gazette*;
- (b) the rest of the order — on the day after that day.

**3. Variation of metropolitan area trading hours during Christmas 2017**

- (1) In this clause —  
*Christmas 2017* means the period that begins on 5 December 2017 and ends on 31 December 2017 (both dates inclusive).
- (2) General retail shops, other than motor vehicle shops, in the metropolitan area are authorised to be open, at times when those shops would otherwise be required to be closed, on the days and during the periods referred to in the Table.

**Table**

Christmas 2017, other than 25 and 26 December 2017	Mondays, Tuesdays, Wednesdays, Thursdays and Fridays — from 7 am until 9 pm Saturdays — from 7 am until 6 pm Sundays — from 8 am until 6 pm
26 December 2017	From 8 am until 6 pm

**4. Variation of metropolitan area trading hours on New Year's Day and Australia Day 2018**

General retail shops, other than motor vehicle shops, in the metropolitan area are authorised to be open, at times when those shops would otherwise be required to be closed, on 1 and 26 January 2018, from 8 am until 6 pm.

**5. Relationship with *Retail Trading Hours (Public Holidays) Order 2012***

**STANDING ORDERS AMENDMENT LOCAL LAW NO. 2 2017**

Under the powers conferred by the *Local Government Act 1995* and all other powers enabling it, the Council of the City of Cockburn resolved on 9 November 2017 to make the following local law.

**1. Citation**

This local law may be cited as the *City of Cockburn Standing Orders Amendment Local Law No. 2 2017*.

**2. Commencement**

This local law comes into operation 14 days after the day of its publication in the *Government Gazette*.

**3. Principal local law amended**

The *City of Cockburn Standing Orders local law 2016* published in the *Government Gazette* on 22 September 2016, and amended on 21 March 2017 is referred to as the principal local law. The principal local law is amended.

**4. Part 4 amended**

Part 4 is amended as follows—

- (a) in clause 4.2 delete subclause (11); and
- (b) delete clause 4.6.

**5. Part 16 amended**

Part 16 is amended as follows—

in clause 16.10(b) delete the words “or has been communicated orally to the applicant or the applicant’s representative by an employee of the Council having authority to give such notification in ordinary circumstances”.

Road Traffic Act 1974

## **Road Traffic (Breath Analysis) Amendment Regulations 2017**

Made by the Governor in Executive Council.

**1. Citation**

These regulations are the *Road Traffic (Breath Analysis) Amendment Regulations 2017*.

**2. Commencement**

These regulations come into operation as follows —

- (a) regulations 1 and 2 — on the day on which these regulations are published in the *Gazette*;
- (b) the rest of the regulations — on the day after that day.

**3. Regulations amended**

These regulations amend the *Road Traffic (Breath Analysis) Regulations 1975*.

**4. Regulation 5 amended**

Delete regulation 5(b) and insert:

- (b) self-testing breath analysing equipment must be operated —
  - (i) in the case of apparatus known as the “Dräger Alcotest 7110” — in accordance with the instructions set out in Part 3 of the Second Schedule; or

- (ii) in the case of apparatus known as the “Dräger Alcotest 9510” — in accordance with the instructions set out in Part 4 of the Second Schedule.

**5. Second Schedule amended**

- (1) In the heading to the Second Schedule Part 3 delete “**equipment**” and insert:

**equipment (Dräger Alcotest 7110)**

- (2) At the end of the Second Schedule insert:

**Part 4 — Analysis of breath sample by self-testing  
breath analysing equipment (Dräger Alcotest 9510)**

1. Ensure that the equipment is switched on, that there is sufficient paper in the paper roll in the printer compartment, and that the words “READY TO START” appear on the display screen.
2. Follow the prompts on the display screen and enter particulars relating to the analysis.
3. After the words “PLEASE BLOW” appear on the display screen connect a mouthpiece to the sampling hose.
4. Direct the person whose breath is to be analysed to provide a sample of the person’s breath into the equipment.
5. If the expression “DO YOU WANT TO REPEAT THE TEST? YES NO” appears on the display screen indicating that a sample of breath has not been provided as required then —  
EITHER
  - 5.1 Select “YES” and follow instructions 3 and 4 again.OR
  - 5.2 Select “NO” to terminate the analysis.

Liquor Control Act 1988

### Liquor Control (Section 31) Notice (No. 2) 2017

Issued under the *Liquor Control Act 1988* section 31(4) and (7) by the Director of Liquor Licensing for the purpose of varying the authorisation conferred by certain licences by the issue of extended trading permits under section 60(4)(g) of that Act.

#### 1. Citation

This notice is the *Liquor Control (Section 31) Notice (No. 2) 2017*.

#### 2. Commencement

This notice comes into operation as follows —

- (a) clauses 1 and 2 — on the day on which this notice is published in the *Gazette*;
- (b) the rest of the notice — on the day after that day.

#### 3. Terms used

In this notice —

***extended trading days*** means the following days —

- (a) 10 December 2017;
- (b) 17 December 2017;
- (c) 24 December 2017;
- (d) 31 December 2017;

***hotel licence*** does not include a small bar licence, hotel restricted licence or tavern restricted licence.

#### 4. Extended trading permit varying authorisation conferred by hotel licence or liquor store licence: metropolitan area

- (1) This clause applies to a hotel licence or liquor store licence that relates to premises situated in the metropolitan area.
- (2) An extended trading permit is issued under section 60(4)(g) of the Act in respect of the licence.
- (3) The extended trading permit varies the authorisation conferred by the licence so as to authorise the licensee to sell packaged liquor on and from the licensed premises on the extended trading days from 8 am to 10 am.



- (4) The extended trading permit remains in force for the period beginning on the day after the day on which this notice is published in the *Gazette* and ending on 1 January 2018.

**5. Extended trading permit varying authorisation conferred by liquor store licence: outside metropolitan area**

- (1) This clause applies to a liquor store licence that relates to premises situated outside the metropolitan area unless it is a licence specified in Schedule 1.
- (2) An extended trading permit is issued under section 60(4)(g) of the Act in respect of the licence.
- (3) The extended trading permit varies the authorisation conferred by the licence so as to authorise the licensee to sell packaged liquor on and from the licensed premises on the extended trading days from 10 am to 10 pm.
- (4) The extended trading permit remains in force for the period beginning on the day after the day on which this notice is published in the *Gazette* and ending on 1 January 2018.

**BAL Assessment / Rating:** Means an assessment prepared in a manner and form set out in AS 3959 to determine a BAL.

In respect of land owned or occupied within these townsites, or any area subdivided for other purpose, you are required to implement the below stated measures—

#### Burning of Garden Refuse and Rubbish

Burning is NOT permitted at all during the Prohibited Burning Time.
