### LOTTERIES COMMISSION ACT 1990

#### LOTTERIES COMMISSION (AUTHORISED LOTTERIES) (MULTIPLE GAMES) AMENDMENT RULES 2018

Made by the Lotteries Commission under section 28(1) of the Act.

#### 1. Citation

These rules are the *Lotteries Commission (Authorised Lotteries) (Multiple Games) Amendment Rules 2018*.

#### 2. Commencement

These rules come into operation as follows—

- (a) rules 1 and 2—on the day on which these rules are published in the *Gazette*;  
(b) the rest of the rules—on the day after that day.

- and the prize reserve fund retains the remainder of the division 1 prize pool allocated for that lotto draw.
- (5) If a division 1 prize is to be distributed to division 2 winners, the prize money is still treated as a division 1 prize for the purposes of claiming and payment of prizes.

##### **109. Bonus draws and guaranteed prize pools for division 1**

- (1) The Commission may from time to time declare a Saturday Lotto draw to be a bonus draw and either—
- (a) fix a minimum guaranteed prize pool for division 1 in that draw; or
  - (b) fix a guaranteed prize pool for division 1 in that draw with a guaranteed division 1 prize for a maximum number of winners.
- (2) If the Commission declares a Saturday Lotto draw to be a bonus draw under subrule (1)(b)—
- (a) If the number of winners of a division 1 prize equals or is less than the maximum number of winners fixed by the Commission under subrule (1)(b), the guaranteed prize pool for division 1 is to be used to pay the guaranteed division 1 prize to each of those winners;
  - (b) If the number of winners of a division 1 prize exceeds the maximum number of winners fixed by the Commission under subrule (1)(b), the guaranteed prize pool for division 1 is to be used to pay each division 1 winner an equal share of the guaranteed prize pool for division 1;
  - (c) If the number of winners of a division 1 prize is less than the maximum number of winners fixed by the Commission under subrule (1)(b), the balance of the guaranteed prize pool for division 1 not used to pay each division 1 winner returns to the prize reserve fund;
  - (d) If there is no division 1 winner under subrule (1)(b), the prize reserve fund retains the entire amount allocated to it for that draw
- (3) When a bonus draw is declared under subrule (1) (a) and—
- (a) no one wins a division 1 prize in a bonus draw; and
  - (b) all or part of the prize reserve fund would have to have been used to increase the division 1 prize pool to a guaranteed amount had there been a division 1 winner,

the amount of the reserve that would have been so used is to be included as part of the division 1 prize pool for that draw when calculating the jackpot prize pool for the next Saturday Lotto draw.

(4) The Commission may add all or part of the prize reserve fund to the division 1 prize pool in a bonus draw to increase the division 1 prize pool to the guaranteed amount and any amount so added forms part of that prize pool.

(5) Where a bonus draw is declared under this rule, and a jackpot division 1 prize coincides with that draw, the Commission may elect to reduce the augmentation under subrule (4) by the amount of the jackpot.

Fremantle WA, 9 February 2018.

I, Raymond Buchholz, Marine Safety General Manager, Department of Transport (‘DoT’) and delegate of the Chief Executive Officer, DoT,—

1. acting under regulation 19H of the *Navigable Water Regulations 1958* (CI) and regulation 19H of the *Navigable Water Regulations 1958* (CKI) (‘the CI and CKI Regulations’), hereby declare the vessels listed in Schedule 1 (‘Schedule 1 vessels’) to be emergency vessels, with the specifications in Schedule 2; and
2. acting under section 115A of the *Western Australian Marine Act 1982* (CI) and section 115A of the *Western Australian Marine Act 1982* (CKI) (‘the CI and CKI Act’), hereby exempt (‘the exemption’) the Schedule 1 vessels from notices made under,
  - (a) section 66 of the CI and CKI Act (Closure of navigable waters); and
  - (b) section 67 of the CI and CKI Act (Limiting speed of vessels),
 subject to the conditions in Schedule 3.

This instrument is to be known as NWR-2018-202313 and is valid until revoked.

### Schedule 2—Declaration specifications

1. A Schedule 1 vessel is only operating as an emergency vessel when it is being used in relation to sea search and rescue or other situations where serious injury and/or loss of life can either be reasonably expected or has been reported to the vessel master or crew (‘identified emergency’).
2. Before a Schedule 1 vessel is so used, or as soon as practicable if extraordinary circumstances inhibit compliance with paragraphs (a) to (c) below, the master of a Schedule 1 vessel, must—
  - (a) notify a Police officer, or a police marine communications officer, of the particulars of the identified emergency;
  - (b) notify that person which vessel it is they are master of; and
  - (c) have received police authorisation that is required in the circumstances.
3. Regulation 19A (speed limit in Swan and Canning Rivers) and regulation 48 (limitation of speed) of the CI and CKI Regulations do not apply to a Schedule 1 vessel when it is being used as an emergency vessel.
4. A lamp displaying intermittent blue flashes—
  - (a) may be used on a Schedule 1 vessel at any time it is—
    - (i) operating as an emergency vessel; or
    - (ii) supporting an aquatic event approved under regulation 51C of the CI and CKI Regulations, under the direction of a DoT Marine Inspector appointed pursuant to section 117 of the CI and CKI Act;
  - (b) must be used on a Schedule 1 vessel when it is operating as an emergency vessel and exceeding the speed limit, operating in closed waters, or both of those.

5. The operator of a Schedule 1 vessel when it is operating as an emergency vessel must hold, as a minimum, a Recreational Skippers Ticket.
6. The master of a Schedule 1 vessel when it is operating as an emergency vessel must—
  - (a) assess if it is appropriate to exceed the speed limit; and
  - (b) comply with the *Prevention of Collisions at Sea Regulations 1983* (CI) and *Prevention of Collisions at Sea Regulations 1983* (CKI) including—
    - (i) rule 5 (Look-out);
    - (ii) rule 6 (Safe Speed); and
    - (iii) rule 7 (Risk of Collision).
7. The master and crew of a Schedule 1 vessel must comply with a direction issued by a Police officer or a DoT Marine Inspector (designated under section 117 of the CI and CKI Act), including a direction to provide a situation report in relation to the identified emergency.

#### **Schedule 3—Exemption Conditions**

1. The Schedule 1 vessel is being used in relation to an identified emergency.
2. A lamp displaying intermittent blue flashes is used on the Schedule 1 vessel when it is exceeding the speed limit, operating in closed waters, or both of those.
3. The operator of the Schedule 1 vessel holds, as a minimum, a Recreational Skippers Ticket.
4. Before the Schedule 1 vessel is used as an emergency vessel, or as soon as practicable if extraordinary circumstances inhibit compliance with paragraphs (a) to (c) below, the master—

5. The master of a Schedule 1 vessel complies with the *Prevention of Collisions at Sea Regulations 1983* (CI) and *Prevention of Collisions at Sea Regulations 1983* (CKI) including—
  - (a) rule 5 (Look-out);
  - (b) rule 6 (Safe Speed);
  - (c) rule 7 (Risk of Collision).
6. At all times that the Schedule 1 vessel is exceeding any speed limit, the master is assessing the extent to which, if any, it is appropriate to do so.
7. At all times that the Schedule 1 vessel is operating in closed waters, the master is assessing whether it is appropriate to do so.
8. The master and crew of a Schedule 1 vessel complies with directions issued by Police officers and DoT Marine Inspectors (designated under section 117 of the CI and CKI Act), including directions to provide information and situation reports in relation to the identified emergency.
