LOCAL GOVERNMENT ACT 1995

LOCAL GOVERNMENT AND PUBLIC PROPERTY AMENDMENT LOCAL LAW 2018

Under the powers conferred on it by the *Local Government Act 1995* and under all other enabling powers, the Council of the Town of Cambridge resolved on 26 June 2018 to make the following local law.

1.1 Title

This local law may be cited as the Town of Cambridge Local Government and Property Amendment Local Law 2018.

1.2 Commencement

This local law commences 14 days after the day on which it is published in the Government Gazette.

1.3 Principal local law

This local law amends the Town of Cambridge Local Government and Public Property Local Law 2017 published in the Government Gazette on 12 January 2018.

1.4 Principal local law amended

The principal local law is amended as follows-

- (a) delete clause 2.1(2);
- (b) in clause 4.3 after the words 'indecent exposure' insert 'except where the local government property is set aside for the wearing of no clothes under clause 2.7(2)(j)';
- (c) in clause 9.1, delete the words ', unless otherwise provided for in this local law'; and
- (d) in Schedule 1, under item 58, under the column of 'Nature of offence', delete the words 'without approval of the local government'.

Salaries and Allowances Act 1975

Salaries and Allowances Amendment Regulations 2018

Made by the Governor in Executive Council.

1. Citation

These regulations are the Salaries and Allowances Amendment Regulations 2018.

2. Commencement

These regulations come into operation as follows —

- (a) regulations 1 and 2 on the day on which these regulations are published in the *Gazette*;
- (b) the rest of the regulations on the day after that day.

3. Regulations amended

These regulations amend the Salaries and Allowances Regulations 1975.

4. Regulation 2 replaced

Delete regulation 2 and insert:

2. Terms used

In these regulations —

commencement day means the day on which the Salaries and Allowances Amendment Regulations 2018 regulation 3 comes into operation;

section means section of the Act;

taxation ruling means a public ruling, made by the Commissioner of Taxation of the Commonwealth under the Taxation Administration Act 1953 (Commonwealth), determining reasonable amounts for daily travel allowance expenses for a financial year.

5. Regulation 3 amended

In regulation 3 delete "section 6 of the Act." and insert:

section 6.

6. Regulations 4, 5 and 6 inserted

After regulation 3 insert:

4. Remuneration prescribed for s. 10C(5)

For the purposes of section 10C(5), motor vehicle benefits are prescribed, to the extent that a determination made by the Tribunal under section 5A on or after commencement day provides for the notional value of a motor vehicle benefit to be determined by reference to a formula that includes —

- (a) an amount of a tax imposed under a law of the Commonwealth, the rate of which may vary from time to time under that law; or
- (b) any other amount that may vary from time to time by reason of factors other than a determination by the Tribunal.

5. Remuneration prescribed for s. 10D(9)

(1) In this regulation —

post-commencement determination means a determination made by the Tribunal under section 6 on or after commencement day;

pre-commencement determination means a determination made by the Tribunal under section 6 and in force immediately before commencement day.

- (2) For the purposes of section 10D(9), the following kinds of remuneration are prescribed
 - (a) total daily amounts for accommodation allowances that
 - (i) under a pre-commencement determination, were determined by reference to the taxation ruling applicable at the date of the relevant travel; and
 - (ii) under a post-commencement determination, continue to be determined in that manner;
 - (b) conditions of service affecting remuneration that
 - (i) under a pre-commencement determination, were determined by reference to the *Public Service*Award 1992 and the *Public Service and*Government Officers General

 Agreement 2014; and

- (ii) under a post-commencement determination, are determined by reference to the *Public Service*Award 1992 and the *Public Service and*Government Officers CSA General

 Agreement 2017 or any instruments made under the *Industrial Relations*Act 1979 in substitution for those instruments;
- (c) motor vehicle benefits, to the extent that a post-commencement determination provides for the notional value of a motor vehicle benefit to be determined by reference to a formula that includes
 - (i) an amount of a tax imposed under a law of the Commonwealth, the rate of which may vary from time to time under that law; or
 - (ii) any other amount that may vary from time to time by reason of factors other than a determination by the Tribunal;
- (d) district allowances that
 - (i) under a pre-commencement determination, were determined by reference to the *Public Service*Award 1992 and the *District Allowance*(Government Officers) General
 Agreement 2010; and
 - (ii) under a post-commencement determination, continue to be determined by reference to those instruments or any instruments made under the *Industrial Relations Act 1979* in substitution for those instruments;
- (e) travel allowances that
 - (i) are described as Annual Leave Travel Concessions; and
 - (ii) under a pre-commencement determination, were determined by reference to the *Public Service*Award 1992 clause 23(10); and
 - (iii) under a post-commencement determination, continue to be determined by reference to that award or any instrument made under the *Industrial Relations Act 1979* in substitution for that award;

- (f) rental subsidies that
 - (i) under a pre-commencement determination, were determined by reference to the State government's Government Regional Officers' Housing Tenant Rent Setting Framework Policy; and
 - (ii) under a post-commencement determination, continue to be determined by reference to that policy or any policy issued by the State government in substitution for that policy;
- (g) home ownership subsidies that
 - (i) under a pre-commencement determination, were determined by reference to the State government's Home Ownership Subsidy Scheme for Government Employees in Regional Western Australia; and
 - (ii) under a post-commencement determination, continue to be determined by reference to that scheme or any scheme implemented by the State government in substitution for that scheme;
- (h) employer superannuation contributions, to the extent that a post-commencement determination in respect of an office referred to in section 6(1)(c), (d) or (e) provides for those contributions to be payable in accordance with the *State Superannuation Act 2000*, another written law or the *Superannuation Guarantee* (Administration) Act 1992 (Commonwealth).

6. Remuneration prescribed for s. 10E(3)

- (1) In this regulation *report* means a report made by the Tribunal under section 7.
- (2) For the purposes of section 10E(3), the following kinds of remuneration are prescribed
 - (a) a total daily amount for a travelling and accommodation allowance that
 - (i) under a report in force immediately before commencement day, was recommended to be payable in accordance with the taxation ruling applicable from time to time; and

- (ii) under a report made on or after commencement day, continues to be recommended to be payable in that manner;
- (b) motor vehicle benefits, to the extent that a report made on or after commencement day provides for the notional value of a motor vehicle benefit to be determined by reference to a formula that includes —
 - (i) an amount of a tax imposed under a law of the Commonwealth, the rate of which may vary from time to time under that law; or
 - (ii) any other amount that may vary from time to time by reason of factors other than a determination by the Tribunal.

Racing Bets Levy Act 2009

Racing Bets Levy Amendment Regulations 2018

Made by the Governor in Executive Council.

1. Citation

These regulations are the *Racing Bets Levy Amendment Regulations 2018*.

2. Commencement

These regulations come into operation as follows —

- (a) regulations 1 and 2 on the day on which these regulations are published in the *Gazette*;
- (b) the rest of the regulations on the day after that day.

3. Regulations amended

These regulations amend the *Racing Bets Levy Regulations 2009*.

4. Regulation 3 amended

In regulation 3 in the definition of *premium race meeting* delete paragraph (b) and insert:

- (b) in the case of a harness race meeting
 - (i) if the meeting occurs before 1 August 2018 \$50 000; or
 - (ii) if the meeting occurs on or after 1 August 2018 \$30 000;

5. Regulation 5 amended

In regulation 5(1) after "1 October 2014" insert:

but before 1 August 2018

Note: The heading to amended regulation 5 is to read:

Levy amount: bets placed or accepted on or after 1 October 2014 but before 1 August 2018

6. Regulation 6 inserted

After regulation 5 insert:

6. Levy amount: bets placed or accepted on or after 1 August 2018

- (1) The amount by way of levy to be paid under the *Betting Control Act 1954* section 14A(2) by a betting operator in respect of racing bets placed or accepted on a race meeting occurring on or after 1 August 2018 is set out in this regulation.
- (2) The amount is 1% of turnover for each month beginning with August 2018 unless subregulation (3) or (6) applies.
- (3) If turnover (calculated from the beginning of the racing year) reaches \$3 000 000, the amount is as follows
 - (a) in the case of pari-mutuel bets placed or accepted on premium race meetings 2.5% of turnover for each month, or part of a month, after turnover reaches \$3 000 000;
 - (b) in the case of pari-mutuel bets placed or accepted on standard race meetings 2% of turnover for each month, or part of a month, after turnover reaches \$3 000 000;
 - (c) in the case of betting exchange bets placed or accepted on premium race meetings 2.5% of turnover for each month, or part of a month, after turnover reaches \$3 000 000;

- (d) in the case of betting exchange bets placed or accepted on standard race meetings 1.5% of turnover for each month, or part of a month, after turnover reaches \$3 000 000;
- (e) in the case of non-exchange fixed odds bets placed or accepted on premium race meetings for each month, or part of a month, after turnover reaches \$3 000 000, the aggregate of the race meeting amounts calculated under subregulation (4), for the betting operator, in respect of premium race meetings occurring in the month or the part of the month;
- (f) in the case of non-exchange fixed odds bets placed or accepted on standard race meetings for each month, or part of a month, after turnover reaches \$3 000 000, the aggregate of the race meeting amounts calculated under subregulation (5), for the betting operator, in respect of standard race meetings occurring in the month or the part of the month.
- (4) For the purposes of subregulation (3)(e), the race meeting amount for a betting operator in respect of a premium race meeting is the greater of the following amounts
 - (a) 22.7% of the betting operator's gross revenue in relation to non-exchange fixed odds bets placed or accepted on the race meeting;
 - (b) 2.5% of the betting operator's turnover in relation to non-exchange fixed odds bets placed or accepted on the race meeting.
- (5) For the purposes of subregulation (3)(f), the race meeting amount for a betting operator in respect of a standard race meeting is the greater of the following amounts
 - (a) 13.6% of the betting operator's gross revenue in relation to non-exchange fixed odds bets placed or accepted on the race meeting;
 - (b) 2% of the betting operator's turnover in relation to non-exchange fixed odds bets placed or accepted on the race meeting.
- (6) No amount is payable for any month during which turnover does not reach \$1 000.

Liquor Control Act 1988

Liquor Control (Kalumburu Restricted Area) Amendment Regulations 2018

Made by the Governor in Executive Council.

1. Citation

These regulations are the *Liquor Control (Kalumburu Restricted Area) Amendment Regulations 2018.*

2. Commencement

These regulations come into operation as follows —

- (a) regulations 1 and 2 on the day on which these regulations are published in the *Gazette*;
- (b) the rest of the regulations on the day after that day.

3. Regulations amended

These regulations amend the *Liquor Control (Kalumburu Restricted Area) Regulations 2018*.

4. Regulation 9 amended

Liquor Control Act 1988

Liquor Control (Parnngurr Restricted Area) Regulations 2018

Made by the Governor in Executive Council.

Part 1 — Preliminary

1. Citation

These regulations are the *Liquor Control (Parnngurr Restricted Area) Regulations 2018.*

2. Commencement

These regulations come into operation as follows —

- (a) Part 1 on the day on which these regulations are published in the *Gazette*;
- (b) the rest of the regulations on the day after that day.

3. Terms used

In these regulations —

exempt person has the meaning given in regulation 4;

Parnngurr Aboriginal Community means the area of land within a radius of 30 km of the telecommunications aerial located at the point with the following Geocentric Datum of Australia 1994 (GDA94) coordinates —

- (a) 122.597657°E;
- (b) 22.817111°S.

4. Exempt person

For the purposes of these regulations, a person is an *exempt person* if the person is —

- (a) staying at a place that is at least 50 km from their usual place of residence for a period of at least 1 night; and
- (b) intending to stay away from their usual place of residence for a period of less than 12 months; and
- (c) not in the course of travelling on a regular journey between their usual place of residence or their place of work or education; and
- (d) travelling in the course of a holiday, or to visit friends or relatives, or for leisure, business or any other reason; and
- (e) not usually a resident in a restricted area declared under section 175(1a) of the Act.

5. Note is not part of regulations

The note after regulation 11 does not form part of these regulations.

Part 2 — Restricted area

6. Declaration of restricted area

The Parnngurr Aboriginal Community is declared to be a restricted area for the purposes of section 175(1a) of the Act.

7. Notice of restricted area

- (1) The Director of Liquor Licensing must take all reasonable steps to cause to be posted, and while the Parnngurr Aboriginal Community continues to be a restricted area by operation of regulation 6 to be kept posted, at each place where a customary access route enters the Parnngurr Aboriginal Community a notice
 - (a) describing the offences set out in regulation 8; and
 - (b) specifying the penalties for those offences.
- (2) A failure to comply with subregulation (1) does not invalidate the declaration in regulation 6.

Part 3 — Prohibitions and related provisions

8. Prohibitions as to liquor in the Parnngurr Aboriginal Community

- (1) Subject to regulation 9, a person commits an offence if the person
 - (a) brings liquor into, or causes liquor to be brought into, the Parnngurr Aboriginal Community; or
 - (b) possesses liquor in the Parnngurr Aboriginal Community.

Penalty for this subregulation:

- (a) if subregulation (2) applies a fine of \$5 000;
- (b) in any other case a fine of \$2 000.
- (2) This subregulation applies to an offence under subregulation (1) committed by a licensee, a manager of licensed premises or a director of a body corporate that holds a licence.

9. Exception to r. 8

A person who is an exempt person does not commit an offence under regulation 8(1) if the person continuously maintains possession of, but does not consume, the liquor.

10. Seizure and disposal of containers of liquor

Despite section 155(4) and (5) of the Act, a member of the Police Force may seize and, as soon as is practicable, dispose of any opened or unopened container of liquor suspected on reasonable grounds to be the subject of an offence under regulation 8.

Part 4 — Period of effect

11. Period during which these regulations have effect

Unless sooner repealed, these regulations have effect for the period that ends at the close of 7 July 2021.

Note for this regulation:

Under the *Liquor Control Act 1988* section 175(1d), these regulations expire at the end of the period referred to in regulation 11.

BIOSECURITY AND AGRICULTURE MANAGEMENT ACT 2007

RATES AND CHARGES

Notice under Section 130 (1)

Under Section 130 of the *Biosecurity and Agriculture Management Act 2007*, I determine rates chargeable on land in the prescribed areas for the financial year commencing on 1 July 2018 as follows—

- (a) 5.258 cents in the dollar on the unimproved value of the land held under pastoral lease in the local government districts of Carnarvon, Exmouth, City of Greater Geraldton, Murchison, Upper Gascoyne, Northampton and Shark Bay.
- (b) 5.05 cents in the dollar on the unimproved value of the land held under pastoral lease in the local government districts of Coolgardie, Dundas, Kalgoorlie/Boulder, Laverton, Leonora, Menzies, Ngaanyatjarraku, Sandstone, Wiluna and Yilgarn.
- (c) 1.067 cents in the dollar on the unimproved value of the land held under pastoral lease in the local government districts of Broome, Derby-West Kimberley, Halls Creek and Wyndham-East Kimberley.
- (d) 5.094 cents in the dollar on the unimproved value of the land held under pastoral lease in the local government districts of Cue, Meekatharra, Mount Magnet, Mount Marshall, Perenjori and Yalgoo.
- (e) 2.211 cents in the dollar on the unimproved value of the land held under pastoral lease in the local government districts of Ashburton, East Pilbara, Karratha and Port Hedland.
- (f) a flat rate (fixed sum) on land identified as freehold on the rural valuation roll maintained under the *Valuation of Land Act 1978*, in the local government district of Esperance of no less than 100 hectares in the area, in the following hectare ranges—

- (g) 0.652 cents in the dollar on the unimproved value of land identified as freehold on the rural valuation roll maintained under the *Valuation of Land Act 1978*, in the area within a 15km radius from the south-west corner of Bibbawarra road and North West Coastal Highway in the Shire of Carnaryon, with a minimum rates amount payable of \$200.
- (h) a flat rate (fixed sum) on land in the local government districts of Kondinin, Kulin, Lake Grace, Merredin, Mount Marshall, Mukinbudin, Narembeen, Nungarin, Trayning, Westonia and Yilgarn, that is—
 - i. identified as freehold on the rural valuation roll maintained under the Valuation of Land Act 1978; and
 - ii. no less than 20 hectares in area in the following hectare ranges as follows—

BIOSECURITY AND AGRICULTURE MANAGEMENT ACT 2007

RATES AND CHARGES

Notice under Section 130 (1)

Under Section 130 of the *Biosecurity and Agriculture Management Act 2007*, I determine rates chargeable on land in the prescribed areas for the financial year commencing on 1 July 2018 as follows—

- (a) a flat rate on freehold land in the local government districts of Bridgetown-Greenbushes and West Arthur and in the localities of Balingup, Mullalyup, Grimwade, Southampton and Wilga West in the local government district of Donnybrook-Balingup, that is
 - i. a fixed sum of \$50 on land identified as freehold on the rural valuation roll maintained under the *Valuation of Land Act 1978*;
 - ii. a fixed sum of \$40 on land identified as freehold and residential on the urban valuation roll maintained under the *Valuation of Land Act 1978*.
- (b) a flat rate (fixed sum) of \$30 on land in the local government districts of Harvey, Mandurah, Murray, Serpentine-Jarrahdale and Waroona, that is—
 - i. identified as freehold on the rural valuation roll maintained under the Valuation of Land Act 1978; and
 - ii. identified as freehold and residential on the urban valuation roll maintained under the *Valuation of Land Act 1978*; and
 - iii. no less than one (1) hectare in area.
- (c) a flat rate (fixed sum) on land in the local government district of Ravensthorpe, that is—
 - i. identified as freehold on the rural valuation roll maintained under the Valuation of Land Act 1978; and
 - ii. identified as freehold on the urban valuation roll maintained under the Valuation of Land Act 1978;

in the area in the following hectares ranges—

 - i. identified as freehold on the rural valuation roll maintained under the Valuation of Land Act 1978;
 - ii. no less than 100 hectares in area; and
 - iii. with a minimum rates amount payable of \$80.


