Shire of Toodyay

ADDITIONAL RESTRICTIONS DURING THE LIMITED BURNING TIMES

Pursuant to Section 24G(2) and Section 25(1a) of the *Bush Fires Act 1954* and applicable to all persons, the burning of garden refuse and lighting of camping or cooking fires is prohibited within the Local Government district of Toodyay during the Prohibited Burning Period. BUSH FIRES ACT 1954

City of Nedlands

FIRE BREAK NOTICE 2018/2019

Notice to all owners and occupiers of land within the City of Nedlands

To prevent the outbreak, spread or extension of a bush fire which may occur, all owners and occupiers of land within the City of Nedlands' district are required to on or before the 30th day of November in each year, or within 14 days of becoming an owner or occupier after that date—

Residential Land—Slash all grass and clear all inflammable matter on the land to a height no greater than 5cm and to maintain all grass and all inflammable matter on the land at a height no greater than 5cm up to and including the 31st day of March in the following year.

All Other Land—Slash all grass and clear all inflammable matter on the land to a height no greater than 5cm, for a width of no less than three metres (3m), immediately inside the external boundaries of the property. In addition, trees must be trimmed back to provide a vertical clearance of a minimum three and a half metres (3.5m) to allow fire appliances to drive along the firebreak.

An owner or occupier of the land who fails or neglects to comply with the requisitions of a notice given pursuant to section 33(1) of the *Bush Fires Act 1954* within the time specified in the notice, commits an offence and is liable to a penalty of \$5,000. The City of Nedlands may direct its officers together with such servants, workmen or contractors, and with such vehicles, machinery and appliances as the officers deem fit, to enter upon the land and carry out the requisitions of the notice which have not been complied with. The City of Nedlands may recover the amount of any costs and expenses incurred in carrying out those requisitions in any court of competent jurisdiction as a debt due from the owner or occupier of the land.

If it is impracticable for any reason to clear firebreaks or take measures in accordance with this notice, you may apply to the City of Nedlands in writing before the 19th day of November of each year for permission to provide fire breaks in alternative positions or to take alternative measures to prevent the outbreak or spread of a bush fire. If permission is not granted in writing by the City, you shall comply with the requirements of this Notice.

The requirements of this Notice should be carried out by means other than burning, for example, mowing and rotary hoeing.

Verge Maintenance—The City principally relies on residents for the improvement and maintenance of nature strips. The City encourages nature strips to be maintained by the adjacent owner/occupier in support of the Bush Fires Act requirements under this notice.

Burning Garden Refuse—Pursuant to the powers contained in the *Bush Fires Act 1954* and the *City of Nedlands Health Local Laws 1997*, the City of Nedlands prohibits the burning of all garden refuse within its district. This prohibition applies to all persons within the City's district. Failure to comply with this prohibition is an offence with a maximum penalty of \$3,000.

BUSH FIRES ACT 1954

City of Bunbury

BUSH FIRE NOTICE AND REQUIREMENTS

Owners or occupiers of land within the City of Bunbury are notified they must comply with the *Bush Fires Act 1954* (the Act) and carry out annual fire-prevention work, as set out in this notice.

All properties within Bunbury are subject to loss due to embers from nearby fires landing within your yards. Most homes are lost through fires from ember attack.

It is an offence not to comply with the Act which carries a modified penalty of \$250 and a maximum penalty of \$5,000. With or without prosecution and in accordance with the Act, the City of Bunbury may enter the land and carry out the required work at the expense of the land owner/occupier.

Work must be completed no later than 30 November and kept maintained throughout the summer months until 10 May annually. Properties assessed as having a bushfire hazard rating of very high or extreme will be sent further information and suggested fire-protection strategies.

REQUIREMENTS

1. Private property (including residential, commercial and industrial)

- Where the area of land is 2024m² or less, all flammable material on the land is to be removed except living trees.
- Where the land area exceeds 2024m² provide a 3 metre firebreak free of all flammable material, immediately inside all boundaries and surrounding all buildings and haystacks. Where adjoining lots are held or used by the owner/occupier, firebreaks may be provided immediately inside the external boundaries of the group of lots. Total removal of flammable material from the property would be considered an acceptable alternative.

2. Fuel and gas depots

All flammable material must be cleared from land where there are containers used for liquid or gasfuel storage including clearing all flammable material from any liquid or gas-fuel storage ramps or supports.

3. Plantations

Firebreaks 15 metres wide must be provided immediately adjoining all external boundaries of the planted area. The outer 10 metres must be cleared of all flammable material. The inner 5 metres, closest to the trees may be kept in a reduced fuel state by slashing or used for grazing provided the height of grass does not exceed 8cm. Plantations must be subdivided into areas not exceeding 30 hectares by firebreaks 6 metres wide. Firebreaks must be cleared of all flammable material and in the vertical plane a minimum height clearance of 5 metres from the ground level will be maintained above the firebreak.

4. Prohibited and restricted burning

The Prohibited Burning Period in the City of Bunbury district is from 30 December to 28 March annually. The Restricted Burning Periods in the City of Bunbury district are from 15 November to 29 December and from 29 March to 10 May annually. These dates may be varied according to seasonal conditions, but any changes will be publicly advertised.

5. Burning permits--bush, grass and garden refuse

Permits are required for any burning including garden refuse during the Restricted Burning Period as above. Burning of anything including bush, grass and garden refuse is totally prohibited from 30 December to 28 March annually. Burning permits will only be issued to owner/occupiers of land for hazard reduction burning until 30 November annually.

6. Campfires

Campfires are completely banned in the City of Bunbury from 15 November to 10 May annually.

7. Outdoor (fixed) solid fuel patio heaters

Most such devices are defined under the Act as 'fires in the open' and therefore, require a permit for use during the restricted burning period. Permits can be provided where defined conditions are satisfied. These permits can be issued by the City of Bunbury, for defined periods of time.

8. Exemptions

If it is impractical to clear firebreaks as required by this notice or if natural features make firebreaks unnecessary, you may apply to the Council or its authorised officer until 15 November for permission to provide firebreaks in alternative positions or take other action to abate fire hazards. If permission is not granted the requirements of the notice must be complied with.

Mandurah Estuary: All the waters of Mandurah Estuary upstream of a line drawn between two points located at 32° 31.807′ S, 115° 42.770′ E (Henry Sutton Grove approximately 40 metres east of Carter Street) and 32° 31.697′ S, 115° 42.901′ E (on the Peninsula Foreshore, approximately 210 metres northwest of Stingray Point) to Mandurah Bridge including all the waters of Mandjar Bay.
