1. Citation

These regulations are the *Freedom of Information Amendment Regulations 2019*.

2. Commencement

These regulations come into operation as follows —

- (a) regulations 1 and 2 — on the day on which these regulations are published in the *Gazette* (**gazettal day**);
- (b) the rest of the regulations —
 - (i) if gazettal day is before the day on which the *Infrastructure Western Australia Act 2019* section 5 comes into operation — when that section comes into operation; or
 - (ii) otherwise — on the day after gazettal day.

3. Regulations amended

Shire of Serpentine-Jarrahdale

VOLUNTEER BUSH FIRE BRIGADES LOCAL LAW 2019

Under the powers conferred by the *Local Government Act 1995*, the *Bush Fires Act 1954* and under all other powers enabling it, the Council of the Shire of Serpentine-Jarrahdale resolved on 17 June 2019 to make the following local law.

1. Citation

This local law may be cited as the *Shire of Serpentine-Jarrahdale Volunteer Bush Fire Brigades Local Law 2019*.

2. Repeal

The *Shire of Serpentine-Jarrahdale By-laws Relating to the Establishment, Maintenance and Equipment of Bush Fire Brigades* published in the *Government Gazette* on 29 March 1985 are repealed.

3. Definitions

(1) In this local law unless the context otherwise requires—

Act means the *Bush Fires Act 1954*;

brigade area is defined in clause 6(1)(b);

bush fire brigade is defined in section 7 of the Act;

CEO means the Chief Executive Officer of the local government;

district means the district of the local government;

local government means the Shire of Serpentine-Jarrahdale;
normal brigade activities is defined by section 35A of the Act; and
Regulations means Regulations made under the Act.

- (2) In this local law, unless the context otherwise requires, a reference to—
- (a) a Captain;
 - (b) a First Lieutenant;
 - (c) a Second Lieutenant; and
 - (d) any additional Lieutenants,

means a person holding that position in a bush fire brigade.

4. Application

This local law applies throughout the district.

5. Establishment of a bush fire brigade

- (1) The local government may establish a bush fire brigade for the purpose of carrying out normal brigade activities.
- (2) A bush fire brigade is established on the date of the local government's decision under subclause (1).
- (3) A bush fire brigade established under subclause (1) is to hold a meeting at least once every financial year to appoint persons to the positions in clause 6(5).

6. Name and officers of bush fire brigade

- (1) On establishing a bush fire brigade under clause 5(1) the local government is to—
- (a) Give a name to the bush fire brigade;
 - (b) Specify the brigade area in which the bush fire brigade is primarily responsible for carrying out the normal brigade activities; and
 - (c) Appoint—
 - (i) a Captain;
 - (ii) a First Lieutenant;
 - (iii) a Second Lieutenant; and
 - (iv) additional Lieutenants if the local government considers it necessary;.
- (2) A person appointed to a position pursuant to subclause (1)(c) is to be taken to be a brigade member.
- (3) The appointments referred to in subclause (1)(c) expire at the completion of the first annual general meeting of the bush fire brigade.
- (4) An election is to be held at the first annual general meeting by the members of the brigade for appointments to the positions referred to in subclause (1)(c).
- (5) If a position referred to in subclause (1)(c) becomes vacant prior to the completion of the first annual general meeting, then the Brigade members are to vote for a replacement member to fill the position.
- (6) The Brigade members may elect, set the term of office, describe the duties of, and dismiss, any person to any other position including secretary, treasurer, equipment officer, training officer or other positions, and may combine those positions; and
- (7) The Brigade members may establish types of brigade membership including fire fighting members, auxiliary members, cadet members, and honorary life members.

7. Duties of Captain and bush fire brigade officers

- (1) The duties of the Captain are to—
- (a) Provide leadership to bush fire brigades;
 - (b) Monitor bush fire brigades' resourcing, equipment and training levels;
 - (c) Liaise with the local government concerning—
 - (i) fire prevention or fire suppression matters generally;
 - (ii) directions to be issued by the local government to bush fire control officers, including those who issue permits to burn; and
 - (iii) bush fire brigade officers;
 - (d) Ensure that a list of bush fire brigade members is maintained;
 - (e) Report annually to the local government the office bearers of the bush fire brigade in accordance with the Regulations;
 - (f) Report to the local government not later than 30 April each year, for consideration and appropriate provision being made in the next local government budget, the status of a bush fire brigade's—
 - (i) training and readiness;
 - (ii) protective clothing;
 - (iii) equipment; and
 - (iv) vehicles and appliances;

- (g) Nominate persons to the CEO for appointment as bush fire control officers by the local government;
 - (h) Arrange for normal brigade activities as authorised by the Act or by the local government; and
 - (i) Where a vacancy occurs in a position appointed under clause 6(1)(c), to—
 - (i) advise the CEO of the vacancy as soon as practicable; and
 - (ii) make alternate suitable arrangements for that position until an appointment is made.
- (2) The duties of other bush fire brigade officers are to support the Captain in his/her role.

8. Appointment, employment, payment, dismissal and duties of bush fire control officers

The appointment, employment, payment, dismissal and duties of bush fire control officers is dealt with by the Act.

9. Maintenance and equipment with appliances and apparatus of bush fire brigades

The local government may provide funds for the maintenance and equipment with appliances and apparatus of bush fire brigades in accordance with Part 6 of the *Local Government Act 1995*.

Areas Closed to Fishing for Prawns in the Shark Bay Prawn Managed Fishery

Notice No. 3 of 2019

I, Rick Fletcher, Executive Director, Fisheries and Agriculture Resource Management of the Department of Primary Industries and Regional Development, Western Australia, in accordance with clause 10 of the *Shark Bay Prawn Managed Fishery Management Plan 1993*, consider it in the better interest of the Shark Bay Prawn Managed Fishery (Fishery) to hereby—

1. Cancel Notice of Areas Closed to Fishing for Prawns in the Shark Bay Prawn Managed Fishery: Notice No. 2 of 2019 dated 4 April 2019.
2. Permit the trialling of gear between 0800 and 1600 hours each day during the fishing season extending from the date of the gazettal of Notice No. 3 of 2019 to 10 October 2019, in that part of the Fishery bounded by a line commencing at the intersection of 24° 50' south latitude and 113° 21.50' east longitude; thence extending due south along the meridian to the intersection of 24° 52.75' south latitude and 113° 21.50' east longitude; thence extending due east along the parallel to the intersection of 24° 52.75' south latitude and 113° 23.50' east longitude; thence extending due north along the meridian to the intersection of 24° 50' south latitude and 113° 23.50' east longitude; thence extending due west along the parallel to the commencement point—**commonly known as the 'gear trial area'**.
3. Prohibit fishing for prawns in those parts of the Fishery, between the times and dates provided for in items (a) to (h) below—
 - (a) fishing for prawns is prohibited from the date of the gazettal of *Notice No. 3 of 2019* to 0800 hours on 10 October 2019—
 - i. in that part of the Fishery bounded by a line commencing at the intersection of 25° 36' south latitude and 113° 01.63' east longitude (on Dirk Hartog Island); thence extending due east along the parallel to the intersection of 25° 36' south latitude and 113° 03.75' east longitude; thence extending due south along the meridian to the intersection of 25° 38' south latitude and 113° 03.75' east longitude; thence extending due west along the parallel to the intersection of 25° 38' south latitude and 113° 02.29' east longitude (on Dirk Hartog Island); thence generally northerly along the high water mark to the commencement point—**commonly known as the 'Withnell Point closure'**;
 - ii. in that part of the Fishery bounded by a line commencing at the intersection of 24° 52.75' south latitude and 113° 37.60' east longitude (on Babbage Island); thence extending due west along the parallel to the intersection of 24° 52.75' south latitude and 113° 21' east longitude; thence extending due south along the meridian to the intersection of 24° 58.10' south latitude and 113° 21' east longitude; thence extending south-easterly along the geodesic to the intersection of 25° 03' south latitude and 113° 22.46' east longitude; thence extending due east along the parallel to the intersection of 25° 03' south latitude and 113° 40.70' east longitude (on the mainland); thence generally northerly along the high water mark to the commencement point—**commonly known as the 'North Carnarvon Peron Line closure'**;
 - iii. in that part of the Fishery bounded by a line commencing at a point at 24° 46' south latitude and 113° 16' east longitude; then extending due east along the parallel to a point at 24° 46' south latitude and 113° 19' east longitude; then extending southerly along the geodesic to a point at 24° 49' south latitude and 113° 20' east longitude; then extending due west along the parallel to a point at 24° 49' south latitude and 113° 17' east longitude; then extending northerly along the geodesic to the commencement point—**commonly known as the 'Northern Scallop Closure'**;
 - iv. in that part of the Fishery bounded by a line commencing at a point at 25° 15.20' south latitude and 113° 25' east longitude; then extending due east along the parallel to a point at 25° 15.20' south latitude and 113° 30.60' east longitude; then extending due south along the meridian to a point at 25° 24' south latitude and 113° 30.60' east longitude; then extending due west along the parallel to a point at 25° 24' south latitude and 113° 25' east longitude; then extending due north along the meridian to the commencement point—**commonly known as the 'NWP Scallop Closure'**;
 - (b) fishing for prawns is prohibited from the date of the gazettal of *Notice No. 3 of 2019* to 1700 hours on 28 July 2019 and from 0800 hours on 12 August 2019 to 1700 hours on 26 August and from 0800 hours on 1 September 2019 to 0800 hours on 10 October 2019 in that part of the Fishery bounded by a line commencing at the intersection of 25° 26' south latitude and 113° 55.55' east longitude (on the mainland); thence extending due west along the parallel to the intersection of 25° 26' south latitude and 113° 40' east longitude; thence extending north-westerly along the geodesic to the intersection of

25° 20.40' south latitude and 113° 30.60' east longitude; thence extending due north along the meridian to the intersection of 25° 15.20' south latitude and 113° 30.60' east longitude; thence extending due east along the parallel to the intersection of 25° 15.20' south latitude and 113° 50.83' east longitude (on the mainland); thence generally southerly along the high water mark to the commencement point—**commonly known as the 'South Carnarvon Peron Line closure'**

- (c) fishing for prawns is prohibited from the date of the gazettal of *Notice No. 3 of 2019* to 1700 hours on 31 July 2019 in that part of the Fishery south of a line commencing at the intersection of 25° 32' south latitude and 113° 29.74' east longitude (on Peron Peninsula); thence extending due west along the parallel to the intersection of 25° 32' south latitude and 113° 25' east longitude; thence extending westerly along the geodesic to the intersection of 25° 31.25' south latitude and 113° 09.75' east longitude; thence extending westerly along the geodesic to the intersection of 25° 30' south latitude and 113° 01.40' east longitude (on Dirk Hartog Island at Cape Levillain); and in that part of the Fishery east of a line commencing at the intersection of 26° 07.30' south latitude and 113° 10.90' east longitude (on Dirk Hartog Island at Surf Point); thence extending south-westerly along the geodesic to the intersection of 26° 08.62' south latitude and 113° 09.60' east longitude (on the mainland at Steep Point)—**commonly known as the 'Denham Sound closure'**.
- (d) fishing for prawns is prohibited from the date of gazettal of *Notice No. 3 2019* to 1700 hours on 28 August to 0800 hours and from 7 September 2019 to 1700 hours on 27 September 2019 and from 0800 hours on 7 October 2019 to 0800 hours on 10 October 2019 in that part of the Fishery south of a line commencing at the intersection of 25° 40.59' south latitude and 113° 02.87' east longitude (on Dirk Hartog Island); thence extending due east along the parallel to the intersection of 25° 40.59' south latitude and 113° 04.80' east longitude; thence extending south-easterly along the geodesic to the intersection of 25° 41' south latitude and 113° 05.63' east longitude; thence extending due east along the parallel to the intersection of 25° 41' south latitude and 113° 08' east longitude; thence extending south-easterly along the geodesic to the intersection of 25° 46' south latitude and 113° 13' east longitude; thence extending due east along the parallel to the intersection of 25° 46' south latitude and 113° 19' east longitude; thence extending due north along the meridian to the intersection of 25° 38' south latitude and 113° 19' east longitude; thence extending north-easterly along the geodesic to the intersection of 25° 32' south latitude and 113° 25' east longitude; thence extending due east along the parallel to the intersection of 25° 32' south latitude and 113° 29.74' east longitude (on Peron Peninsula); and in that part of the Fishery east of a line commencing at the intersection of 26° 07.30' south latitude and 113° 10.90' east longitude (on Dirk Hartog Island at Surf Point); thence extending south-westerly along the geodesic to the intersection of 26° 08.62' south latitude and 113° 09.60' east longitude (on the mainland at Steep Point)—**commonly known as the 'Snapper/Trawl Closure'**
- (e) in parts of the Fishery north of 24° 45.30' south latitude where fishing for prawns is not otherwise prohibited, fishing for prawns is prohibited between 1000 hours and 1700 hours each day between the date of the gazettal of *Notice No. 3 of 2019* and 10 October 2019—**commonly known as the 'area north of Koks Island'**.
- (f) in parts of the Fishery south of 24° 45.30' south latitude where fishing for prawns is not otherwise prohibited, fishing for prawns is prohibited between 0800 hours and 1700 hours each day between the date of the gazettal of *Notice No. 3 of 2019* and 10 October 2019—**commonly known as the 'area south of Koks Island'**.
- (g) fishing for prawns is prohibited in all parts of the Fishery from 0800 hours on 10 October 2019 to 0800 hours on 1 June 2020.

MENTAL HEALTH (AUTHORISED MENTAL HEALTH PRACTITIONERS) ORDER (NO. 7) 2019

Made by the Chief Psychiatrist under section 539 of the *Mental Health Act 2014*.

1. Citation

This order may be cited as the *Mental Health (Authorised Mental Health Practitioners) Order (No. 7) 2019*.

2. Commencement

BUSH FIRES ACT 1954*City of Wanneroo***FIRE HAZARD REDUCTION NOTICE**

Owners and Occupiers of Land Within the City of Wanneroo

Pursuant to Section 33 of the *Bush Fires Act 1954*, you are required to carry out fire prevention works on land that you own or occupy.

The applicable works outlined below must be completed before 1 November 2019 and maintained in this state up to and including 31 May 2020.

The City of Wanneroo may at any time after 1 November 2019 conduct inspections on properties.

Failure to comply with this Notice may result in a penalty of up to \$5,000. Additionally, the City of Wanneroo may carry out the required works at your cost.

1. DEFINITIONS

Trafficable means capable of being driven on from one point to another by any emergency services vehicle on a clear surface, without any obstruction to the vehicle. A fire break is not to terminate or lead to a dead end.

Fire Break means a strip of land which has been cleared of all flammable material and is trafficable. Approved methods include ploughing, grading, cultivating, scarifying, raking, burning and chemical spraying (reticulated and maintained green lawn is acceptable as a fire break).

Flammable Material means any material such as wood, leaves and grass that is likely to be ignited and capable of burning.

Asset Protection Zone refers to an area which includes—

- (a) undertaking measures such as pruning all lower tree branches to prevent fire entering the trees;
- (b) ensuring 3 metres spacing between tree canopies to prevent treetop fires spreading between trees;
- (c) keeping all grasses to a height of not more than 50 millimetres; and
- (d) storing all firewood piles more than 20 metres away from the buildings.

2. FIRE BREAK REQUIREMENTS**LAND AREA—4000sqm or less**

- (a) Installation of a 3 metre wide trafficable fire break with a vertical clearance of not less than 3.5 metres as close as possible to all external boundaries of the property; or
- (b) Removal of all flammable material, with the exception of living trees from the property.

LAND AREA—4000sqm or greater

- (a) Installation of a 3 metre wide trafficable fire break with a vertical clearance of not less than 3.5 metres as close as possible to all external boundaries of the property;
- (b) Where it is not possible to install the fire break adjacent to the external boundary of the property due to naturally occurring obstacles, it is acceptable to install the fire break around the obstacle. If this variation requires the fire break to be greater than 5 metres away from the external boundary, a fire break variation is required; and
- (c) Installing and maintaining a 20 metre asset protection zone surrounding all buildings, large hay stacks and fuel storage areas.

3. BUSHFIRE OR EMERGENCY MANAGEMENT PLANS

All properties that are subject to a Bushfire Management Plan, Emergency Management Plan or an approved Bushfire Attack Level Assessment, approved as part of a District Planning Scheme, a subdivision or development approval or a building permit must comply with the requirements of such plans in its entirety.

4. PROHIBITED AND RESTRICTED BURNING PERIODS**Prohibited Burning Period**

- (a) From 1 December to 31 March (subject to change);
- (b) All burning is prohibited during this period including burning garden waste or lighting fires in the open air for the purpose of camping or cooking;
- (c) The following exemptions apply to—
 - (i) pizza ovens fitted with a spark arrestor; and
 - (ii) purpose built solid fuel BBQs such as kettle barbeques.

These appliances may still be used if they are used at a person's home and are located more than 3 metres away from bush and flammable material.

- (d) These exemptions *do not apply* if a Total Fire Ban or a Harvest and Vehicle Movement Ban has been declared.

Restricted Burning Periods

- (a) From 1 April to 31 May (subject to change) and from 1 September to 30 November (subject to change);
- (b) Permits are required during these periods; and
- (c) Fires for the purpose of cooking are permitted as long as the fire danger rating is not “very high”, “extreme” or “catastrophic”.

The City of Wanneroo may, where necessary, vary burning periods due to weather conditions. It is the owner and/or occupier’s responsibility to ensure that the dates stated above have not been varied.

5. ADDITIONAL WORKS

In addition to the requirements of this Notice, further works may need to be carried out which are considered necessary by the City of Wanneroo’s Authorised Officer. Land owners or occupiers who need to carry out further works will be notified.

6. TOTAL FIRE BANS

A Total Fire Ban is declared on days of extreme weather or when widespread fires are seriously stretching firefighting resources. A Total Fire Ban prohibits the lighting of any fires in the open air and carrying out any other activities that may start a fire.

The ban includes all open air fires for the purpose of cooking or camping. It prohibits the operation of incinerators, welding, grinding, soldering or gas cutting equipment.

7. HARVEST, HOT WORKS AND VEHICLE MOVEMENT BANS

Harvest and Vehicle Movement Bans may be imposed by the City of Wanneroo when, during a Total Fire Ban or when the Chief Bushfire Control Officer is of the opinion that the use of engines, vehicles, plant or machinery is likely to cause a fire or contribute to the spread of a bushfire.

During a Harvest and Vehicle Movement Ban you are not allowed to light, maintain or use a fire in the open air, or to carry out any activity in the open air that causes, or is likely to cause a fire.

This includes a prohibition on the use of engines, vehicles, plant or machinery that can cause or be conducive to the spread of a bushfire.

8. VARIATION TO FIREBREAK REQUIREMENTS

If you consider that it is impracticable for any reason to implement any of the requirements of this Notice, an application must be made no later than 18 October 2019 to the City of Wanneroo for permission to provide alternative fire mitigation measures. An application to vary the requirements does not constitute approval until written permission is granted by the City of Wanneroo.


