- (2) The course of training is the course titled *Council Member Essentials* that —
  - (a) consists of the following modules —
    - (i) Understanding Local Government;

- (ii) Serving on Council;
  - (iii) Meeting Procedures;
  - (iv) Conflicts of Interest;
  - (v) Understanding Financial Reports and Budgets;
- and
- (b) is provided by any of the following bodies —
    - (i) North Metropolitan TAFE;
    - (ii) South Metropolitan TAFE;
    - (iii) WALGA.
- (3) The period within which the course of training must be passed is the period of 12 months beginning on the day on which the council member is elected.

**36. Exemption from Act s. 5.126(1) requirement**

- (1) A council member is exempt from the requirement in section 5.126(1) if —
  - (a) the council member passed either of the following courses within the period of 5 years ending immediately before the day on which the council member is elected —
    - (i) the course of training specified in regulation 35(2);
    - (ii) the course titled 52756WA — *Diploma of Local Government (Elected Member)*;
  - or
  - (b) the council member passed the course titled *LGASS00002 Elected Member Skill Set* before 1 July 2019 and within the period of 5 years ending immediately before the day on which the council member is elected.
- (2) A person who is a council member on the day on which the *Local Government Regulations Amendment (Induction and Training) Regulations 2019* regulation 8 comes into operation is exempt from the requirement in section 5.126(1) until the end of their term of office.

#### SCHOOL EDUCATION ACT 1999

#### DECLARATION OF LOCAL INTAKE AREAS FOR SCHOOLS WITH PRIMARY STUDENTS

(Pursuant to Sections 60, 78, 79 and 80)

The Hon. Minister for Education and Training has declared that the local intake areas for the schools listed hereunder shall be as stated in this notice. Children of compulsory school age who reside within the local intake areas stated shall be entitled to attend the school to which such local intake areas apply if there is an appropriate educational program for them at that school. Children who reside outside these local intake areas may apply to attend the school to which such local intake areas apply.

#### **Dianella Heights Primary School (5144)**

The following will define the local intake area of this school from 2020—

From the intersection of Morley Drive and Dianella Drive, north along Dianella Drive (east side included) to Yirrigan Drive, north-west along Yirrigan Drive (north side included) to Northwood Drive, north-east and north along Northwood Drive (east side included) to Reid Highway, east along Reid Highway (south side included) to a point north of the intersection between Northcliffe Avenue and Bencubbin Crescent, south from this point intersecting between 23 Bencubbin Crescent (included) and 5 Northcliffe Avenue (excluded) to the intersection between Northcliffe Avenue and Bencubbin Crescent, south-west along Northcliffe Avenue (north-west side included) to the eastern arm of Dechaineux Parkway, south and then west along the eastern arm of Dechaineux Parkway (both sides included) to Prevelly Parkway, south along Prevelly Parkway (west side included) to the intersection with Eora Creek Terrace, south-east from this intersection through the park to the intersection between Sattelberg Ramble, Witchcliffe Way, and Pomona Lane, south along Sattelberg Ramble (west side included) to Ajana Way, south-west along Ajana Way (north-west side included) to Qualen Mews, south along Qualen mews (both sides included) and its southern extension to Broadmoor Avenue, south along Broadmoor Avenue (west side included) to Yirrigan Drive, west along Yirrigan Drive (north side included) to Avocado Drive, south and east along Avocado Drive (west and south side included) to a point north of the laneway between 97 Avocado Drive and 91 Avocado Drive, south from this point through the laneway to Gordon Road West, south-west along Gordon Road West (north side included) to Light Street, south-east along Light street (both sides excluded) to Morley Drive, and then west along Morley Drive (north side included) to the intersection with Dianella Drive.

A sibling of a student who is enrolled at Dianella Heights Primary School, will be entitled to enrol at Dianella Heights Primary School provided there is at least one sibling already enrolled at the school for the year in which the younger sibling enrolls.

#### **Dianella Primary College (5309)**

The following will define the local intake area of this school from 2020—

From the intersection of Reid Highway and Mirrabooka Avenue, east along Reid Highway to Northwood Drive, south along Northwood Drive (west side included) to Yirrigan Drive, south-east along Yirrigan Drive (south side included) to Dianella Drive, south along Dianella Drive (west side included) to Morley Drive, west along Morley Drive (north side included) to Flinders Street, north along Flinders Street (east side included) to Ravenswood Drive, east along Ravenswood Drive (south side included) to Mirrabooka Avenue, and north along Mirrabooka Avenue (east side included) to the intersection with Reid Highway.

The following defines an optional area between Dianella Primary College, Balga Primary School, Westminster Junior Primary School, and Westminster Primary School—

From the intersection of Majella Road and Ravenswood Drive, north along Majella Road (east side included) and its extension to Reid Highway, east along Reid Highway to Mirrabooka Avenue, south along Mirrabooka Avenue (west side included) to Ravenswood Drive, and east along Ravenswood Drive (north side included) to Majella Road.

A sibling of a student who is enrolled at Dianella Primary College, will be entitled to enrol at Dianella Primary College provided there is at least one sibling already enrolled at the school for the year in which the younger sibling enrolls.

**North Morley Primary School (5522)**

The following will define the local intake area of this school from 2020—

From the intersection of Light Street and Alexander Drive, south-east along Light Street (both sides included) to Lyndhurst Street, north-east along Lyndhurst Street (both sides included) to Cheviot Street, south-east along Cheviot Street (both sides excluded) to Cheviot Place, north-east along Cheviot Place (both sides excluded) to Wellington Road, south-east along Wellington Road (both sides included) to Lincoln Road, east along Lincoln Road (both sides excluded) to Camboon Road, north along Camboon Road (west side included) to Wolseley Road, west along Wolseley Road (both sides excluded) to Hookwood Street, north along Hookwood Street (both sides excluded) to Noranda Avenue, west along Noranda Avenue (both sides included) to a point due south of a line between Hayden Close on the west and Sunderland Place on the east, north and north-west along this line between Hayden Close, Farmer Court, Monk Place and Callaghan Way on the west and Sunderland Place, Hepworth Way and Newell Way on the east to Bramwell Road, east along Bramwell Road (both sides excluded) to the eastern boundary of the Morley Senior High School site, north along the eastern boundary of the Morley Senior High School site to Widgee Road, west along Widgee Road (both sides excluded) to the north-western corner of the Morley Senior High School site, due north along a line between Bohemia Place on the west and Luderman Road and Ing Place on the east to Reid Highway, west along Reid Highway to a point north of the intersection between Northcliffe Avenue and Bencubbin Crescent, south from this point intersecting between 23 Bencubbin Crescent (excluded) and 5 Northcliffe Avenue (included) to the intersection between Northcliffe Avenue and Bencubbin Crescent, south-west along Northcliffe Avenue (south-east side included) to the eastern arm of Dechaineux Parkway, south and then west along the eastern arm of Dechaineux Parkway (both sides excluded) to Prevelly Parkway, south along Prevelly Parkway (east side included) to the intersection with Eora Creek Terrace, south-east from this intersection through the park to the intersection between Sattelberg Ramble, Witchcliffe Way, and Pomona Lane, south along Sattelberg Ramble (east side included) to Ajana Way, south-west along Ajana Way (south-east side included) to Qualen Mews, south along Qualen mews (both sides excluded) and its southern extension to Broadmoor Avenue, south along Broadmoor Avenue (east side included) to Yirrigan Drive, west along Yirrigan Drive (south side included) to Avocado Drive, south and east along Avocado Drive (east and north side included) to a point north of the laneway between 97 Avocado Drive and 91 Avocado Drive, south from this point through the laneway to Gordon Road West, south-west along Gordon Road West (south-east side included) to Light Street, and south-east along Light street (both sides included) to the intersection with Alexander Drive.

A sibling of a student who is enrolled at North Morley Primary School, will be entitled to enrol at North Morley Primary School provided there is at least one sibling already enrolled at the school for the year in which the younger sibling enrolls.

The following defines an optional area between North Morley Primary School and West Morley Primary School—

From the intersection of Camboon Road, Morley Drive and Wellington Road, north along Camboon Road (west side included) to Lincoln Road, west along Lincoln Road (both sides included) to Wellington Road, north-west along Wellington Road (both sides excluded) to Cheviot Place, south-west along Cheviot Place (both sides included) to Cheviot Street, north-west along Cheviot Street (both sides included) to Lyndhurst Street, south-west along Lyndhurst Street (both sides excluded) to Light Street, south-east along Light Street (both sides included) to Morley Drive and in a general north-easterly direction along Morley Drive (north side included) to the intersection of Camboon Road, Morley Drive and Wellington Road.

**Westminster Junior Primary School (5467)**

The following will define the local intake area of this school from 2020—

From the intersection of Wanneroo Road and Reid Highway, east along Reid Highway to a point north of the northern extension of Majella Road, south from this point to Majella Road, south along Majella Road (west side included) to Ravenswood Drive, west along Ravenswood Drive (north side included) to Flinders Street, south along Flinders Street (west side included) to Ilumba Road, west along Ilumba Road (both sides excluded) to the intersection with Carcoola Street, across the park/reserve to the intersection of Ravenswood Court and Lemana Road, south-west along Lemana Road (both sides excluded) to Hillsborough Drive, north-west along Hillsborough Drive (both sides excluded) to Ravenswood Drive, west along Ravenswood Drive (both sides excluded) to Wanneroo Road, and north along Wanneroo Road (east side included) to the intersection of Wanneroo Road and Reid Highway.

A sibling of a student who is enrolled at Westminster Junior Primary School, will be entitled to enrol at Westminster Junior Primary School provided there is at least one sibling already enrolled at the school for the year in which the younger sibling enrolls.

The following defines an optional area between Westminster Junior Primary School, Balga Primary School, and Dianella Primary College—

From the intersection of Majella Road and Ravenswood Drive, north along Majella Road (east side included) and its extension to Reid Highway, east along Reid Highway to Mirrabooka Avenue, south along Mirrabooka Avenue (west side included) to Ravenswood Drive, and east along Ravenswood Drive (north side included) to Majella Road.

**Westminster Primary School (5466)**

The following will define the local intake area of this school from 2020—

From the intersection of Wanneroo Road and Reid Highway, east along Reid Highway to a point north of the northern extension of Majella Road, south from this point to Majella Road, south along Majella Road (west side included) to Ravenswood Drive, west along Ravenswood Drive (north side included) to Flinders Street, south along Flinders Street (west side included) to Ilumba Road, west along Ilumba Road (both sides excluded) to the intersection with Caroola Street, across the park/reserve to the intersection of Ravenswood Court and Lemana Road, south-west along Lemana Road (both sides excluded) to Hillsborough Drive, north-west along Hillsborough Drive (both sides excluded) to Ravenswood Drive, west along Ravenswood Drive (both sides excluded) to Wanneroo Road, and north along Wanneroo Road (east side included) to the intersection of Wanneroo Road and Reid Highway.
