CONSERVATION AND LAND MANAGEMENT ACT 1984

LALANG-GARRAM / CAMDEN SOUND MARINE PARK (CLASSIFIED WATERS) NOTICE 2020

Made by the Minister for Environment under section 62(1a) of the Act.

1. Citation

This is the *Lalang-garram / Camden Sound Marine Park (Classified Waters) Notice 2020*.

2. Interpretation

(1) In this notice—

approved joint management plan means the joint management plan for the Lalang-garram / Camden Sound Marine Park, set out in the *Lalang-garram / Camden Sound Marine Park management plan 73 2013-2023*, approved by the Minister under sections 14 and 60 of the Act as notified in the *Gazette* of 5 November 2013.

coastal waters of the State has the meaning given to that term in the *Coastal Waters (State Powers) Act 1980* (Commonwealth) section 3(1).

Determination Area has the meaning given to that term in the Federal Court of Australia *Barunga v State of Western Australia [2011] FCA 518*, Schedule One, pages 16-38.

high water mark means the ordinary (mean of) high water mark at spring tides as defined in the *Land Administration Act 1997* section 3(1).

Lalang-garram / Camden Sound Marine Park means the area reserved as Lalang-garram / Camden Sound Marine Park under section 13 of the Act and classified as Class A by the *Lalang-garram / Camden Sound Marine Park (Alteration of Boundaries) Order 2017*, published in the *Gazette* of 14 July 2017.

low water mark means the ordinary (mean of) low water mark at spring tides, unless otherwise defined.

Table 7 means *Table 7: Permitted uses in the marine park* set out in the approved management plan.

(2) All geographic coordinates are expressed in terms of the World Geodetic System 1984 (WGS84).

3. Classification of general use areas

All waters of the Lalang-garram / Camden Sound Marine Park described in Schedule 1 are classified under section 62(1a)(b) of the Act as general use areas.

4. Classification of sanctuary areas

All waters of the Lalang-garram / Camden Sound Marine Park described in Schedule 2 are classified under section 62(1a)(c) of the Act as sanctuary areas.

5. Classification of special purpose areas

All waters of the Lalang-garram / Camden Sound Marine Park described in Schedule 3 are classified under section 62(1a)(d) of the Act as special purpose areas.

6. Declaration of aquaculture as incompatible with a specified conservation purpose of certain special purpose areas

Under section 13B(3B)(a) of the Act, aquaculture is declared to be incompatible with the conservation purpose of—

- (a) providing protection to representative examples of marine biodiversity, including coral and sponge species, for the area classified as special purpose area under clause 5 and described in Schedule 3 item 1 Jungulu Special Purpose Zone (wilderness conservation); and
- (b) providing protection to humpback whale calving, nursing and resting areas for the area classified as special purpose area under clause 5 and described in Schedule 3 item 3 Camden Sound Special Purpose Zone (whale conservation).

7. Declaration of commercial fishing as incompatible with a specified conservation purpose of certain special purpose areas

Under section 13B(3B)(b) of the Act, commercial fishing is declared to be incompatible with the conservation purpose of providing protection to representative examples of marine biodiversity, including reef systems, habitats, species and natural processes, for the area classified as special purpose area under clause 5 and described in Schedule 3 item 1 Jungulu Special Purpose Zone (wilderness conservation).

8. Declaration of certain types of commercial fishing as incompatible with a specified conservation purpose of certain special purpose areas

Under section 13B(3B)(c) of the Act, commercial fishing of the type described in Table 7 as commercial trawling is declared to be incompatible with the conservation purpose of providing protection to humpback whale calving, nursing and resting areas for the area classified as special purpose area under clause 5 and described in Schedule 3 item 3 Camden Sound Special Purpose Zone (whale conservation).

9. Declaration of certain types of commercial fishing as incompatible with a specified conservation purpose of certain special purpose areas

Under section 13B(3B)(c) of the Act, commercial fishing of the type described in Table 7 as commercial coral, live rock and live sand collection is declared to be incompatible with the conservation purpose of—

- (a) providing protection to representative examples of marine biodiversity, including reef systems, habitats, species and natural processes, for the area classified as special purpose area under clause 5 and described in Schedule 3 item 2 Kuri Bay Special Purpose Zone (pearling); and
- (b) providing protection to humpback whale calving, nursing and resting areas for the area classified as special purpose area under clause 5 and described in Schedule 3 item 3 Camden Sound Special Purpose Zone (whale conservation).

10. Declaration of pearling activity as incompatible with a specified conservation purpose of certain special purposes areas

Under section 13B(3B)(f) of the Act, pearling activity is declared to be incompatible with the conservation purpose of—

- (a) providing protection to representative examples of marine biodiversity, including coral and sponge species, for the area classified as special purpose area under clause 5 and described in Schedule 3 item 1 Jungulu Special Purpose Zone (wilderness conservation); and
- (b) providing protection to humpback whale calving, nursing and resting areas for the area classified as special purpose area under clause 5 and described in Schedule 3 item 3 Camden Sound Special Purpose Zone (whale conservation).

11. Declaration of exploratory drilling for, or production of, petroleum, geothermal energy resources or geothermal energy as incompatible with a specified conservation purpose of certain special purpose areas

Under section 13B(3B)(g) of the Act, activities of the type described in Table 7 as mineral or petroleum exploration, drilling and production are declared to be incompatible with the conservation purpose of—

- (a) providing protection to representative examples of marine biodiversity, including coral and sponge species, for the area classified as special purpose area under clause 5 and described in Schedule 3 item 1 Jungulu Special Purpose Zone (wilderness conservation); and
- (b) providing protection to humpback whale calving, nursing and resting areas for the area classified as special purpose area under clause 5 and described in Schedule 3 item 3 Camden Sound Special Purpose Zone (whale conservation).

SCHEDULE 1—GENERAL USE AREAS

1. St George Basin General Use Zone

All that portion of Lalang-garram / Camden Sound Marine Park—

- (a) contained within and bounded by a line—
 - (i) commencing offshore generally north of Augustus Island at the point located at Latitude 15°12'00" South, Longitude 124°34'00" East, and from that point;
 - (ii) extending east along that latitude to the point located at the intersection of that latitude and Longitude 124°48'45" East;
 - (iii) thence north-easterly along the geodesic joining the co-ordinates at that point offshore and at Latitude 15°10'51.60" South, Longitude 124°50'06" East on the mainland, to the point located at the intersection of that geodesic and the mainland low water mark that is the boundary of Reserve 27164 (Prince Regent National Park);
 - (iv) thence generally south-easterly along that reserve boundary, and continuing along that boundary past Rothsay Water and Saint George Basin, and east-south-easterly along the northernmost north-eastern boundary of the Determination Area where that reserve boundary intersects and extends generally north-east of that determination boundary, and including those subtidal areas that are isolated by those two boundaries but remain generally south-west of that determination boundary, and further continuing along that reserve boundary up the north-eastern bank of Prince Regent River, to the southernmost western straight line boundary of that reserve, that boundary being approximately located at Longitude 125°13'37.20" East;
 - (v) thence southerly along that boundary, across Prince Regent River, to the point located at the intersection of that boundary and the high water mark on the south-western bank of that river;
 - (vi) thence generally south-westerly and generally north-westerly along that water mark down that bank of the river, and further continuing along that water mark past Saint

George Basin, Munster Water, Halfway Bay and Hanover Bay to the point located at the intersection of that water mark and Latitude 15°15'19.680" South, that intersection point being the one nearest Longitude 124°40'27" East generally west of High Bluff;

- (vii) thence west along that latitude, and along the northern high water mark of islands where that latitude intersects islands, and continuing west along that latitude to the point located at the first intersection of that latitude and the high water mark on Augustus Island, that point being generally south-west of Adieu Point;
- (viii) thence generally north-easterly along that water mark, and continuing along that water mark around Adieu Point, to the point located at the intersection of that water mark and Longitude 124°34'00" East, that intersection point being the one nearest Latitude 15°14'49.20" South at the northern end of that island;
- (ix) thence north along that longitude to the point of commencement;
- (b) and within that line—
 - (i) excludes that portion of Reserve 15530 that is seaward of the high water mark;
 - (ii) excludes that portion of Reserve 23079 that is seaward of the high water mark.

2. Hall Point General Use Zone

All that portion of Lalang-garram / Camden Sound Marine Park—

- (a) contained within and bounded by a line—
 - (i) commencing offshore generally north-west of Hall Point at the point located at Latitude 15°39'00" South, Longitude 124°21'00" East, and from that point;
 - (ii) extending east along that latitude to the point located at the first intersection of that latitude and the mainland high water mark;
 - (iii) thence generally southerly along that water mark, and continuing along that water mark past Parin Peninsula, Prior Point and Freshwater Cove, to the point located at the intersection of that water mark and Longitude 124°25'00" East, that intersection point being the one nearest Latitude 15°52'36" South;
 - (iv) thence south along that longitude, past Lizard Island, to the point located at the intersection of that longitude and Latitude 16°03'00" South;
 - (v) thence west along that latitude to the point located at the intersection of that latitude and Longitude 124°21'00" East;
 - (vi) thence north along that longitude, past High Cliffy Islands, to the point of commencement;
- (b) and within that line, excludes that portion of Reserve 23079 that is seaward of the high water mark.

3. Montgomery Reef General Use Zone

All that portion of Lalang-garram / Camden Sound Marine Park contained within and bounded by a line—

- (i) commencing offshore generally south-east of Montgomery Islands at the point located at Latitude 16°00'00" South, Longitude 124°18'00" East, and from that point;
- (ii) extending west along that latitude to the point located at the intersection of that latitude and Longitude 124°17'00" East;
- (iii) thence north along that longitude to the point located at the intersection of that longitude and the most seaward low water mark on the edge of Montgomery Reef, that intersection point being the one nearest Latitude 15°59'36" South on the southern side of a channel in that reef, that channel being exposed at low tide;
- (iv) thence generally west-north-westerly along that water mark, and continuing along that water mark up, across and down that channel, and further continuing along that water mark generally easterly and generally northerly, then up, across and down the large adjacent channel in Montgomery Reef, that channel being the one commonly referred to as "The River" that is exposed at low tide;
- (v) thence generally easterly and generally north-westerly along that water mark on the edge of that reef, to the point located at the intersection of that water mark and Longitude 124°18'00" East, that intersection point being no further north than Latitude 15°59'00" South;
- (vi) thence south along that longitude to the point of commencement.

4. Western Shoals General Use Zone

All that portion of Lalang-garram / Camden Sound Marine Park contained within and bounded by a line—

- (i) commencing offshore in the Indian Ocean generally west of Camden Sound at the point located at the intersection of the seaward limit of the coastal waters of the State and Latitude 15°26'00" South, and from that point;
- (ii) extending east along that latitude to the point located at the intersection of that latitude and Longitude 124°03'00" East;
- (iii) thence south along that longitude, past Lorikeet Shoal, Cockell Reefs, The Breakwater and Viney Island, to the point located at the intersection of that longitude and Latitude 16°03'00" South;

- (iv) thence west along that latitude, past Muir and Caesar islands, to the point located at the intersection of that latitude and Longitude 123°45'00" East;
- (v) thence north along that longitude, past Gibbings Reefs, to the point located at the intersection of that longitude and Latitude 15°55'00" South;
- (vi) thence west along that latitude, past MacLeay Islands, to the point located at the intersection of that latitude and the seaward limit of the coastal waters of the State;
- (vii) thence generally north-easterly along that limit, past Rosella Shoal, to the point of commencement.

SCHEDULE 2—SANCTUARY AREAS

1. Champagne Sanctuary Zone

All that portion of Lalang-garram / Camden Sound Marine Park contained within and bounded by a line—

- (i) commencing offshore generally north-north-west of Champagne Island at the point located at the intersection of the seaward limit of the coastal waters of the State and Latitude 15°12'00" South, and from that point;
- (ii) extending east along that latitude to the point located at the intersection of that latitude and Longitude 124°19'00" East;
- (iii) thence south along that longitude, and along the western high water mark of Heywood and other islands where that longitude intersects those islands, and continuing south along that longitude to the point located at the intersection of that longitude and Latitude 15°26'00" South;
- (iv) thence west along that latitude to the point located at the intersection of that latitude and the seaward limit of the coastal waters of the State;
- (v) thence generally north-easterly along that limit to the point of commencement.

2. Montgomery Reef Sanctuary Zone

All that portion of Lalang-garram / Camden Sound Marine Park—

- (a) contained within and bounded by a line—
 - (i) commencing offshore generally north-west of Montgomery Islands at the point located at Latitude 15°50'00" South, Longitude 124°03'00" East, and from that point;
 - (ii) extending east along that latitude to the point located at the intersection of that latitude and Longitude 124°21'00" East, that point being offshore generally north-east of Montgomery Islands;
 - (iii) thence south along that longitude, past High Cliffy Islands, to the point located at the intersection of that longitude and Latitude 16°03'00" South, that point being offshore generally south-east of Montgomery Islands;
 - (iv) thence west along that latitude to the point located at the intersection of that latitude and Longitude 124°03'00" East, that point being offshore generally south-west-of Montgomery Islands;
 - (v) thence north along that longitude to the point of commencement;
- (b) and within that line, excludes Montgomery Reef General Use Zone.

SCHEDULE 3—SPECIAL PURPOSE AREAS

1. Jungulu Special Purpose Zone (wilderness conservation)

All that portion of Lalang-garram / Camden Sound Marine Park contained within and bounded by a line—

- (i) commencing offshore generally north-west of Jungulu Island at the point located at Latitude 15°12'00" South, Longitude 124°19'00" East, and from that point;
- (ii) extending east along that latitude, past Miawaja and Lucas islands, to the point located at the intersection of that latitude and Longitude 124°34'00" East;
- (iii) thence south along that longitude to the point located at the first intersection of that longitude and the high water mark on Augustus Island, that point being near Adieu Point at the northern end of that island;
- (iv) thence generally north-westerly, generally south-westerly and generally south-easterly along that water mark to the point located at the first intersection of that water mark and Latitude 15°18'00" South;
- (v) thence west along that latitude to the point located at the first intersection of that latitude and the high water mark on Jungulu Island;
- (vi) thence generally north-north-westerly along that water mark, and continuing along that water mark around the eastern and north-western sides of that island, to the point located at the intersection of that water mark and Longitude 124°20'36" East, that intersection point being the one nearest Latitude 15°18'34.80" South on the northern side of the channel between Jungulu and Heywood islands;
- (vii) thence south along that longitude, across that channel, and along the western high water mark of islands where that longitude intersects islands, and continuing south along that longitude to the point located at the first intersection of that longitude and the high water mark at the northern end of Heywood Island;

- (viii) thence generally westerly and generally south-westerly along that water mark around the northern and north-western sides of that island, to the point located at the first intersection of that water mark and Longitude 124°19'00" East;
- (ix) thence north along that longitude, and along the eastern high water mark of islands where that longitude intersects islands, and continuing north along that longitude to the point of commencement.

2. Kuri Bay Special Purpose Zone (pearling)

All that portion of Lalang-garram / Camden Sound Marine Park—

- (a) contained within and bounded by a line—
 - (i) commencing onshore near the southern end of Heywood Island at the point located at the intersection of Longitude 124°19'00" East and the high water mark of that island, that intersection point being the one nearest Latitude 15°21'22.20" South, and from that point;
 - (ii) extending generally south-easterly, generally north-easterly, generally northerly and generally westerly along that water mark, around that island, to the point located at the intersection of that water mark and Longitude 124°20'36" East, that intersection point being the one nearest Latitude 15°18'51" South on the southern side of the channel between Heywood and Jungulu islands;
 - (iii) thence north along that longitude, across that channel, and along the eastern high water mark of islands where that longitude intersects islands, and continuing north along that longitude to the point located at the intersection of that longitude and the high water mark on Jungulu Island, that intersection point being the one nearest Latitude 15°18'34.80" South;
 - (iv) thence generally south-easterly along that watermark, and continuing along that water mark around the southern and eastern sides of that island, to the point located at the intersection of that water mark and Latitude 15°18'00" South, that intersection point being the one nearest Longitude 124°27'35.40" East on the western side of the channel between Jungulu and Augustus islands;
 - (v) thence east along that latitude, across that channel, to the point located at the first intersection of that latitude and the high water mark on Augustus Island;
 - (vi) thence generally south-easterly along that water mark, and continuing along that water mark around that island, past Wurrulgu Inlet, North Entrance, Brecknock Harbour, Quinlan Channel, Port George IV and Square Hill, to the point located at the intersection of that water mark and Latitude 15°15'19.680" South near the northern end of that island, that intersection point being the one nearest Longitude 124°33'27" East;
 - (vii) thence east along that latitude, and along the southern high water mark of islands where that latitude intersects islands, and continuing east along that latitude to the point located at the intersection of that latitude and the mainland high water mark, that intersection point being the one nearest Longitude 124°40'27" East generally west of High Bluff;
 - (viii) thence generally southerly and generally westerly along that water mark, past Port George IV, Augustus Water, Rogers Strait, Camden Harbour, Brecknock Harbour, Kuri Bay and South Entrance, to the point located at the intersection of that water mark and Longitude 124°28'00" East;
 - (ix) thence north along that longitude to the point located at the intersection of that longitude and Latitude 15°26'00" South;
 - (x) thence west along that latitude to the point located at the intersection of that latitude and Longitude 124°19'00" East;
 - (xi) thence north along that longitude to the point of commencement;
- (b) and within that line—
 - (i) excludes that portion of Reserve 15530 that is seaward of the high water mark;
 - (ii) excludes that portion of Reserve 23079 that is seaward of the high water mark.

3. Camden Sound Special Purpose Zone (whale conservation)

All that portion of Lalang-garram / Camden Sound Marine Park—

- (a) contained within and bounded by a line—
 - (i) commencing offshore in the Indian Ocean generally west of Camden Sound at the point located at Latitude 15°26'00" South, Longitude 124°03'00" East, and from that point;
 - (ii) extending east along that latitude to the point located at the intersection of that latitude and Longitude 124°28'00" East;
 - (iii) thence south along that longitude to the point located at the first intersection of that longitude and the mainland high water mark;
 - (iv) thence generally south-westerly along that water mark, and continuing along that water mark past Battery Point, Sampson Inlet, Wilson Point, Hope Point, Deception Bay and Buckland Point, to the point located at the intersection of that water mark and Latitude 15°39'00" South, that intersection point being the one nearest Longitude 124°24'47.40" East;

- (v) thence west along that latitude to the point located at the intersection of that latitude and Longitude 124°21'00" East;
- (vi) thence south along that longitude to the point located at the intersection of that longitude and Latitude 15°50'00" South;
- (vii) thence west along that latitude, past Montgomery Reef, to the point located at the intersection of that latitude and Longitude 124°03'00" East;
- (viii) thence north along that longitude, past Cockell Reefs, to the point of commencement;
- (b) and within that line, excludes that portion of Reserve 23079 that is seaward of the high water mark.

Made by the deputy of the Governor in Executive Council under section 10A of the Act.

1. Citation

This proposal is the *Conservation and Land Management (Changes to State Forest No. 14 and 15) Proposal 2019*.

2. Terms used

In this proposal—

Act means the *Conservation and Land Management Act 1984*;

Deposited Plan, followed by a number, means the deposited plan of that number—

- (a) lodged with Landgate; and
- (b) certified by an authorised land officer (as defined in the *Land Administration Act 1997* section 3(1)); and
- (c) available—
 - (i) In paper form at Landgate's head office; and
 - (ii) In electronic form on Landgate's official website;

Landgate mean the Western Australian Land Information Authority established by the *Land Information Authority Act 2006* section 5.

3. Proposal to change State Forest No. 14

Under section 10A(1)(a) of the Act, it is proposed that the land identified as Lots 511-512 on Deposited Plan 411011 version 1 and Lots 522-524 on Deposited Plan 415490 version 1 cease to be State forest.
