### Restraining Orders Amendment Regulations 2020

SL 2020/63

Made by the Governor in Executive Council.

**1. Citation**

These regulations are the *Restraining Orders Amendment Regulations 2020*.

**2. Commencement**

These regulations come into operation as follows —

- (a) regulations 1 and 2 — on the day on which these regulations are published in the *Gazette*;
- (b) the rest of the regulations — on the day after that day.

**3. Regulations amended**

These regulations amend the *Restraining Orders Regulations 1997*.

**4. Regulation 9B inserted**

After regulation 9A insert:

**9B. Procedure for effecting substituted service of FVRO without court order (Act s. 60(1A)(b) and (2)(b))**

- (1) In this regulation —  
*senior officer* means a police officer who is, or is acting as, a sergeant or an officer above the rank of sergeant.
- (2) For the purposes of section 60(1A)(b) of the Act, the following steps are prescribed for a person attempting

to serve an FVRO who has failed to achieve personal service (the *latest attempt*) —

- (a) the person must ensure that at least 2 unsuccessful attempts, in addition to the latest attempt, have been made to achieve personal service of the FVRO;
  - (b) the person must obtain a senior officer's approval of service of the FVRO by substituted service.
- (3) Subregulation (2)(a) does not apply if a state of emergency declaration is in force under the *Emergency Management Act 2005* section 56.
- (4) A senior officer who approves substituted service of an FVRO under subregulation (2)(b) must keep a record of —
- (a) any unsuccessful attempts to serve the FVRO; and
  - (b) the senior officer's approval of service of the FVRO by substituted service.
- (5) For the purposes of section 60(2)(b) of the Act, an FVRO is served by substituted service if the person serving it effects oral service in accordance with section 55(5) to (7) of the Act.

**CO-OPERATIVES ACT 2009**  
**CO-OPERATIVES NATIONAL LAW (WA)**  
APPROVAL BY THE REGISTRAR OF CO-OPERATIVES  
Sections 11(1)(ef), 316 and 337 of the *Co-operatives Act 2009*

#### 1. Approvals

In accordance with section 11(1)(ef) of the *Co-operatives Act 2009* (WA) I, Lanie Chopping, Registrar of Co-operatives, approve the following for the purposes of Part 5.4 of the *Corporations Act 2001* (Commonwealth) as applied to co-operatives in Western Australia by sections 316 and 337 of the *Co-operatives Act 2009*—

- (a) For the purposes of paragraph (a) of the definition of statutory minimum in section 9 of the *Corporations Act 2001*, the amount approved is \$20 000.
- (b) For the purposes of paragraph (b) of the definition of statutory period in section 9 of the *Corporations Act 2001*, the period approved is 6 months.
- (c) For the purposes of section 459E(2)(e) of the *Corporations Act 2001*, the approved form is Form 509H of Schedule 2 of the *Corporations Regulations 2001* (Commonwealth) as in force from time to time, modified in the same manner as if Form 509H was an 'applied provision' for the purposes of section 11 of the *Co-operatives Act 2009*.

These approvals are made under section 11(1)(ef) of the *Co-operatives Act 2009*.

#### 2. Application

- (a) The approvals in paragraph 1(a) and paragraph 1(c) apply to all statutory demands served on co-operatives in Western Australia on or after the date on which this approval is published in the *Western Australian Government Gazette*.
- (b) The approval in paragraph 1(b) applies to all statutory demands served on co-operatives in Western Australia on or after 25 March 2020.

#### 3. Expiry

The approvals in paragraph 1(a) and 1(b) expire at the end of the period of 6 months starting on 25 March 2020.

**FISH RESOURCES MANAGEMENT ACT 1994**  
PROHIBITION ON FISHING (MONTEBELLO ISLANDS AND BARROW ISLAND  
MARINE PARK) ORDER 2020  
Order No. 8 of 2020

FD 1690/18 [CID 181380]

Made by the Minister under section 43.

#### 1. Citation

This instrument is the *Prohibition on Fishing (Montebello Islands and Barrow Island Marine Park) Order 2020*.

#### 2. Interpretation

In this order—

**benthic protection special purpose zone** means an area of water described in Schedule 3;

**coral** means fish of that common name described by the scientific classification opposite that name in Division 5 of Schedule 7 to the regulations;

**crab** means fish of that common name described by the scientific classification opposite that name in Division 3 of Schedule 7 to the regulations;

**handline** means a line which, when used for fishing, has one end in constant contact with a boat, or is attached to a fishing rod or reel, or is held in the hand;

**line** means a handline or troll line;

**live rock** means the fish of that common name described by the scientific classification opposite that name in Division 5 of Schedule 7 to the regulations;

**marine aquarium fish** has the same meaning as in the *Marine Aquarium Fish Managed Fishery Management Plan 2018*, excluding coral and live rock;

**pearling special purpose zone** means an area of water described in Schedule 4;

**pointed instrument** means a speargun, harpoon, gidgie, Hawaiian sling, or any similar instrument capable of acting as, or launching, a projectile;

**recreation zone** means an area of water described in Schedule 2;

**regulations** means the *Fish Resources Management Regulations 1995*;

**rock lobster** means fish of that common name described by the scientific classification opposite that name in Division 3 of Schedule 7 to the regulations;

**sanctuary zone** means an area of water described in Schedule 1;

**sea cucumber** means fish of that common name described by the scientific classification opposite that name in Division 5 of Schedule 7 to the regulations;

**specimen shell** has the same meaning as in the *Specimen Shell Managed Fishery Management Plan 1995*;

**troll line** means a handline towed by a boat.

### 3. Prohibition on fishing in a sanctuary zone

A person must not fish in a sanctuary zone.

### 4. Prohibition on fishing in a recreation zone

A person must not fish in a recreation zone unless that person is engaging in recreational fishing—

- (a) for crab or rock lobster; or
- (b) by use of a line, throw net or pointed instrument.

### 5. Prohibition on fishing in a benthic protection special purpose zone

A person must not fish in a benthic protection special purpose zone unless that person is fishing by the use of a troll line.

### 6. Prohibition on fishing in a pearling special purpose zone

A person must not fish in a pearling special purpose zone unless that person is—

- (a) fishing for a commercial purpose for sea cucumber, specimen shell or marine aquarium fish; or
- (b) fishing from a charter vessel; or
- (c) engaging in recreational fishing for crab or rock lobster; or
- (d) engaging in recreational fishing by the use of a line, throw net or pointed instrument.

### 7. Revocation

The following orders are revoked—
