This order is the *Health Services (Health Service Providers) Amendment Order 2021*.

2. Commencement

This order comes into operation as follows —

- (a) clauses 1 and 2 — on the day on which this order is published in the *Gazette*;
- (b) the rest of the order — on the day after that day.

3. Order amended

This order amends the *Health Services (Health Service Providers) Order 2016*.

4. Clause 11 amended

After clause 11(2) insert:

- (3) The following public health services are declared to be health service areas —
 - (a) the provision on a statewide basis of vaccines for COVID-19 to persons;
 - (b) the distribution on a statewide basis of vaccines for COVID-19.

5. Clause 12 amended

Delete clause 12(2) and insert:

- (2) Despite subclause (1), Child and Adolescent Health Service is not the health service provider for the following public health services that are provided in Perth Children's Hospital —
- (a) the public health services described in clauses 7, 13 and 17;

City of Fremantle

LOCAL GOVERNMENT PROPERTY AMENDMENT LOCAL LAW 2021

Under the powers conferred by the *Local Government Act 1995* and by all other powers, the Council of the City of Fremantle resolved on 27 January 2021 to make the following local law.

1. Citation

This local law may be cited as the *City of Fremantle Local Government Property Amendment Local Law 2021*.

2. Commencement

This local law comes into operation 14 days after the date of its publication in the *Government Gazette*.

3. Principal Local Law amended

This local law amends the *City of Fremantle Local Government Property Local Law 2002* as published in the *Government Gazette* on 11 November 2002 as amended on 12 March 2019.

4. Clause 1.2 amended

(1) In clause 1.2, definition of local government property, delete the words “except a thoroughfare”.

(2) In clause 1.2, definition of local government property, insert the words “or is leased or licensed by” after the words “which belongs to” in paragraph (a).

5. Clause 2.8 amended

(1) In clause 2.8(1)(i) delete “and”.

(2) In clause 2.8(1)(j) delete the full stop and replace with “; and”.

(3) In clause 2.8(1) insert subclause (k) following subclause (j) as follows—

“(k) smoking in contravention of a sign which prohibits the act of smoking.”

6. Clause 3.2 amended

In clause 3.2(5) delete the full stop and replace with “or where the requirements of subclause (3) or (4) have not been satisfied.”

7. Clause 3.3 amended

In clause 3.3 insert subclause (4) following subclause (3)—

“(4) The local government may, at any time, amend a condition of approval and the amended condition takes effect 30 days after written notice of it is given to the permit holder.”

8. Clause 3.9 amended

In clause 3.9(2) delete “mutatis mutandis” and replace with “as though it was a new application for a permit”.

9. Clause 4.1 amended

(1) In clause 4.1(1)(a) delete “or”.

(2) In clause 4.1(1)(b) delete the full stop and replace with “; or”.

(3) In clause 4.1(1) insert new subclause (c) following subclause (b)—

“(c) places the public at risk or interferes with the safety of others.”

10. Clause 4.3 amended

(1) In clause 4.3 delete the clause title and replace with “Taking, injuring or damaging any fauna or flora”.

(2) In clause 4.3 insert new subclauses (3) and (4) following subclause (2) as follows—

“(3) A person must not remove or damage or attempt to remove or damage any flora which is on or above any local government property, unless that person is authorised to do so under a written law or with the written approval of the local government.

(4) In this clause “flora” means all vascular plants.”

11. Part 5 Division 1 deleted

Delete Part 5 Division 1—Swimming pool areas

12. Part 5 Division 4 deleted

Delete Part 5 Division 4—Toilet blocks and change rooms

13. Part 5 divisions renumbered

(1) Re-number Part 5 “Division 2” as “Division 1”

(2) Re-number Part 5 “Division 3” as “Division 2”

(3) Re-number Part 5 “Division 5” as “Division 3”

14. Causes 5.3—5.9 renumbered

(1) Re-number clauses “5.3—5.6” as “5.1—5.4.”

(2) Re-number clauses “5.8 and 5.9” as “5.5 and 5.6”

15. Clause 9.2 amended

In clause 9.2 delete subclause (1) and insert—

“(1) If the CEO or an authorised person reasonably suspects that a person is breaching, or has just breached, a provision of this local law or any other written law, the CEO or authorised person may—

(a) refuse to allow that person to enter local government property; and

(b) if the person is on local government property, direct the person to leave the local government property.

- (2) A person who has been refused entry or who has been directed to leave under subclause (1) must immediately leave the local government property quickly and peaceably.
- (3) If a person fails to comply with subclause (2), the CEO or and authorised person may remove the person, or arrange for the person to be removed, from the local government property.”

16. Clause 9.3 amended

(1) Delete subclause 9.3(1) and insert—

- “(1) An article left on any local government property, and not claimed within a period of 1 month, may be disposed of by the CEO or an authorised person—
- (a) if the value of the property is reasonably believed to exceed the amount prescribed by regulation 30(3) of the *Local Government (Functions and General) Regulations 1996*, using the process under section 3.58 of the Act for the sale of the article as if it was property referred to in that section;
- (b) if the article is reasonably believed to be of a negligible or little value or likely to be of no interest to a not for profit body, in any manner they think fit; or
- (c) in any other case, by donation to a not for profit body incorporated under the *Association Incorporations Act 1987*.”
