Supreme Court Act 1935

Supreme Court (Attorney General Designation and Delegation) Order 2021

Made by the Governor in Executive Council.

1. Citation

This order is the *Supreme Court (Attorney General Designation and Delegation) Order 2021*.

2. Minister designated

- (1) Under the *Supreme Court Act 1935* section 154(3), the Honourable Mark McGowan MLA, Premier of the State —
 - (a) is designated as the Minister of the State for the purposes of that section; and
 - (b) may exercise all or any of the powers that would be exercisable by the Attorney General, whether by statute or otherwise, in respect of the Family Court of Western Australia or judicial officers of that Court.
- (2) Under the *Supreme Court Act 1935* section 154(4) —
 - (a) the Honourable Mark McGowan MLA, Premier of the State, is designated as the Minister of the State for the purposes of that section; and
 - (b) where under any statute or otherwise any act in respect of the Family Court of Western Australia, or judicial officers of that Court, is required or permitted to be done by, to, or with reference to the Attorney General, the act may be done by, to, or with reference to the Honourable Mark McGowan MLA, Premier of the State.

3. Delegation

- (1) This clause applies to the extent that a power, function or duty in respect of the Family Court of Western Australia, or judicial officers of that Court, vested in or imposed on the Attorney General by a law of the State is not covered by clause 2.

- (2) Under the *Supreme Court Act 1935* section 154(5), the power, function or duty is delegated to the Honourable Mark McGowan MLA, Premier of the State.

4. Expiry of order

Unless sooner revoked, this order expires at the end of the period of 12 months beginning on the day on which the order is made by the Governor.
