BUSH FIRES (PROHIBITED BURNING TIMES) AMENDMENT NOTICE (NO. 3) 2021

Made by the FES Commissioner of the Department of Fire and Emergency Services under section 17(1) of the *Bush Fires Act 1954*.

1. Citation

This notice is the *Bush Fires (Prohibited Burning Times) Amendment Notice (No. 3) 2021*.

2. Commencement

This notice comes into operation as follows—

- (a) clauses 1 and 2—on the day on which this notice is published in the *Gazette*;
- (b) the rest of the notice—on the day after that day.

3. The notice amended

The amendments in this notice are to the Bush Fires (Prohibited Burning Times) Declaration 2012*.

PROHIBITION ON FISHING (LALANG-GARRAM / CAMDEN SOUND MARINE PARK) ORDER 2021

Order No. 6 of 2021

Actionstep 867

Made by the Minister under section 43.

1. CitationThis instrument is the *Prohibition on Fishing (Lalang-garram / Camden Sound Marine Park) Order 2021*.**2. Interpretation**

In this order—

coral and 'live rock' have the same meaning as in the *Prohibition on Fishing (Coral, 'Live Rock' and Algae) Order 2007*;

Sanctuary area means a zone or zones specified in Schedule 1;

Special Purpose area means a zone or zones specified in Schedule 2;

trawling means fishing by means of net towed by boat.

3. Prohibition on fishing

(1) A person must not fish by any means in a Sanctuary area.

(2) A person must not fish for a commercial purpose—

(a) in the Special Purpose area (wilderness conservation); or

(b) in the Special Purpose area (whale conservation)—

(i) by means of trawling; or

(ii) for coral, 'live rock' or sand; or

(c) in the Special Purpose area (pearling) for coral, 'live rock' or sand.

(3) Subclause (1) does not apply with respect to a person engaged in customary fishing.

Note for this clause—

Subclause 2 does not affect the operation of the Prohibition on Fishing (Coral, 'Live Rock' and Algae) Order 2007

Schedule 1—Sanctuary areas**Champagne Sanctuary Zone**

All waters bounded by a line commencing at a point at 15° 12' south latitude and 124° 11.873' east longitude; then extending due east along the parallel to a point at 15° 12' south latitude and 124° 19' east longitude; then due south along the meridian towards a point at 15° 20.28' south latitude and 124° 19' east longitude (on Heywood Island) until its intersection with the high water mark on Heywood Island; then generally south-westerly and south-easterly along the high water mark until its intersection with the meridian between a point at 15° 21.36' south latitude and 124° 19' east longitude (on Heywood Island) and a point at 15° 26' south latitude and 124° 19' east longitude; then due south along the meridian to a point at 15° 26' south latitude and 124° 19' east longitude; then due west along the parallel to a point at 15° 26' south latitude and 124° 00.906' east longitude; then north-easterly along the geodesic to a point at 15° 19.79' south latitude and 124° 07.106' east longitude; then north-westerly along the geodesic to a point at 15° 18.897' south latitude and 124° 06.387' east longitude; then northerly along the geodesic to a point at 15° 17.65' south latitude and 124° 06.032' east longitude; then northerly along the geodesic to a point at 15° 15.985' south latitude and 124° 06.146' east longitude; then north-easterly along the geodesic to a point at 15° 14.698' south latitude and 124° 06.918' east longitude; then north-easterly along the geodesic to a point at 15° 13.741' south latitude and 124° 07.733' east longitude; then north-easterly along the geodesic to a point at 15° 13.146' south latitude and 124° 08.93' east longitude; then easterly along the geodesic to a point at 15° 12.693' south latitude and 124° 10.334' east longitude; then easterly along the geodesic to a point at 15° 12.781' south latitude and 124° 11.586' east longitude; then north-easterly along the geodesic to a point at 15° 12.212' south latitude and 124° 11.825' east longitude; then northerly along the geodesic to the commencement point.

Montgomery Reef Sanctuary Zone

All waters bounded by a line commencing at a point at 15° 50' south latitude and 124° 03' east longitude; then extending due east along the parallel to a point at 15° 50' south latitude and 124° 21' east longitude; then due south along the meridian to a point at 16° 03' south latitude and 124° 21' east longitude; then due west along the parallel to a point at 16° 03' south latitude and 124° 03' east longitude; then due north along the meridian to the commencement point; but excluding all waters bounded by a line commencing at a point at 16° 00' south latitude and 124° 18' east longitude; then extending due west along the parallel to a point at 16° 00' south latitude and 124° 17' east longitude; then due north along the meridian until its intersection with the low water mark on the edge of Montgomery Reef being the point closest to 15° 59.60' south latitude and 124° 17' east longitude; then

generally westerly and easterly (up, across and down the channel) along the low water mark; then generally easterly, northerly and southerly (up, across and down the adjacent channel commonly referred to as 'The River') along the low water mark; then generally easterly and north-easterly along the low water mark until its intersection with the meridian between a point at 15° 59' south latitude and 124° 18' east longitude and a point at 16° 00' south latitude and 124° 18' east longitude; then due south along the meridian to the commencement point.

Schedule 2—Special Purpose areas

Camden Sound Special Purpose Zone (whale conservation)

All waters bounded by a line commencing at a point at 15° 26' south latitude and 124° 03' east longitude; then extending due east along the parallel to a point at 15° 26' south latitude and 124° 28' east longitude; then due south along the meridian towards a point at 15° 29.26' south latitude and 124° 28' east longitude (on the mainland) until its intersection with the high water mark; then generally south-westerly along the high water mark, past Battery Point, Sampson Inlet, Wilson Point, Hope Point, Deception Bay and Buckland Point, until its intersection with the parallel between a point at 15° 39' south latitude and 124° 24.817' east longitude (on the mainland) and a point at 15° 39' south latitude and 124° 21' east longitude; then due west long the parallel to a point at 15° 39' south latitude and 124° 21' east longitude; then due south along the meridian to a point at 15° 50' south latitude and 124° 21' east longitude; then due west along the parallel to a point at 15° 50' south latitude and 124° 03' east longitude; then due north along the meridian to the commencement point.

Jungulu Special Purpose Zone (wilderness conservation)

All waters bounded by a line commencing at a point at 15° 12' south latitude and 124° 19' east longitude; then extending due east along the parallel to a point at 15° 12' south latitude and 124° 34' east longitude; then due south along the meridian towards a point at 15° 14.84' south latitude and 124° 34' east longitude (on Augustus Island near Adieu Point) until its intersection with the high water mark; then generally south-westerly and south-easterly along the high water mark until its intersection with the parallel between a point at 15° 18' south latitude and 124° 29.69' east longitude (on Augustus Island) and a point at 15° 18' south latitude and 124° 27.56' east longitude (on Jungulu Island); then due west along the parallel towards a point at 15° 18' south latitude and 124° 27.56' east longitude (on Jungulu Island) until its intersection with the high water mark; then generally north-westerly and south-westerly along the high water mark until its intersection with the meridian between a point at 15° 18.55' south latitude and 124° 20.60' east longitude (on Jungulu Island) and a point at 15° 18.87' south latitude and 124° 20.60' east longitude (on Heywood Island); then due south along the meridian towards a point at 15° 18.87' south latitude and 124° 20.60' east longitude (on Heywood Island) until its intersection with the high water mark; then generally south-westerly along the high water mark until its intersection with the meridian between a point at 15° 20.28' south latitude and 124° 19' east longitude (on Heywood Island) and a point at 15° 12' south latitude and 124° 19' east longitude; then due north along the meridian to the commencement point.

Kuri Bay Special Purpose Zone (pearling)

All waters bounded by a line commencing at a point at 15° 26' south latitude and 124° 19' east longitude; then extending due north along the meridian towards a point at 15° 21.36' south latitude and 124° 19' east longitude (on Heywood Island) until its intersection with the high water mark on Heywood Island; then generally north-easterly and north-westerly along the high water mark until its intersection with the meridian between a point at 15° 18.87' south latitude and 124° 20.60' east longitude (on Heywood island) and a point at 15° 18.55' south latitude and 124° 20.60' east longitude (on Jungulu Island); then due north along the meridian towards a point at 15° 18.55' south latitude and 124° 20.60' east longitude (on Jungulu Island) until its intersection with the high water mark; then generally south-easterly, north-easterly, south-easterly and north-easterly along the high water mark until its intersection with the parallel between a point at 15° 18' south latitude and 124° 27.56' east longitude (on Jungulu Island) and a point at 15° 18' south latitude and 124° 29.69' east longitude (on Augustus Island); then due east along the parallel towards a point at 15° 18' south latitude and 124° 29.69' east longitude (on Augustus Island) until its intersection with the high water mark; then generally south-easterly along the high water mark, and continuing along that water mark around that island, past Wurrulgu Inlet, North Entrance, Brecknock Harbour, Quinlan Channel, Port George IV and Square Hill, until its intersection with the parallel between a point at 15° 15.328' south latitude and 124° 33.43' east longitude (on Augustus Island) and a point at 15° 15.328' south latitude and 124° 40.48' east longitude (on the mainland near High Bluff); then due east along the parallel towards a point at 15° 15.328' south latitude and 124° 40.48' east longitude (on the mainland near High Bluff) until its intersection with the high water mark on the mainland; then generally southerly and westerly along the high water mark, past Port George IV, Augustus Water, Rogers Strait, Camden Harbour, Brecknock Harbour, Kuri Bay and South Entrance, until its intersection with the meridian between a point at 15° 29.26' south latitude and 124° 28' east longitude (on the mainland) and a point at 15° 26' south latitude and 124° 28' east longitude; then due north along the meridian to a point at 15° 26' south latitude and 124° 28' east longitude; then due west along the parallel to the commencement point.

PROHIBITION ON FISHING (LALANG-GARRAM / CAMDEN SOUND MARINE PARK) JOINT
AUTHORITY ORDER 2021

Order No. 7 of 2021

Actionstep 866

Made by the person holding or performing the functions of the office of the Minister, as delegate of the Western Australian Fisheries Joint Authority, under section 43.

1. Citation

This instrument is the *Prohibition on Fishing (Lalang-garram / Camden Sound Marine Park) Joint Authority Order 2021*.

2. Interpretation

In this order—

demersal gillnet means any gillnet that, when set, is wholly or partially in continuous or intermittent contact with the sea bed;

demersal longline means a longline that, when set, is laid wholly or partially in continuous or intermittent contact with the seabed, other than—

- (a) a hand line;
- (b) a trawl line;
- (c) a drop line; or
- (d) a pelagic longline;

Joint Authority fishery means the Northern Shark Fishery;

pelagic gillnet means any gillnet that, when set, makes no contact with the sea bed;

Sanctuary area means a zone or zones specified in Schedule 1;

Special Purpose area (wilderness conservation) means the zone specified in Schedule 2;

3. Prohibition on fishing

A person fishing in a Joint Authority fishery must not fish for a commercial purpose by means of demersal longline, demersal gillnet or pelagic gillnet in—

- (a) a Sanctuary area; or
- (b) the Special Purpose area (wilderness conservation).

Schedule 1—Sanctuary areas**Champagne Sanctuary Zone**

All waters bounded by a line commencing at a point at 15° 12' south latitude and 124° 11.873' east longitude; then extending due east along the parallel to a point at 15° 12' south latitude and 124° 19' east longitude; then due south along the meridian towards a point at 15° 20.28' south latitude and 124° 19' east longitude (on Heywood Island) until its intersection with the high water mark on Heywood Island; then generally south-westerly and south-easterly along the high water mark until its intersection with the meridian between a point at 15° 21.36' south latitude and 124° 19' east longitude (on Heywood Island) and a point at 15° 26' south latitude and 124° 19' east longitude; then due south along the meridian to a point at 15° 26' south latitude and 124° 19' east longitude; then due west along the parallel to a point at 15° 26' south latitude and 124° 00.906' east longitude; then north-easterly along the geodesic to a point at 15° 19.79' south latitude and 124° 07.106' east longitude; then north-westerly along the geodesic to a point at 15° 18.897' south latitude and 124° 06.387' east longitude; then northerly along the geodesic to a point at 15° 17.65' south latitude and 124° 06.032' east longitude; then northerly along the geodesic to a point at 15° 15.985' south latitude and 124° 06.146' east longitude; then north-easterly along the geodesic to a point at 15° 14.698' south latitude and 124° 06.918' east longitude; then north-easterly along the geodesic to a point at 15° 13.741' south latitude and 124° 07.733' east longitude; then north-easterly along the geodesic to a point at 15° 13.146' south latitude and 124° 08.93' east longitude; then easterly along the geodesic to a point at 15° 12.693' south latitude and 124° 10.334' east longitude; then easterly along the geodesic to a point at 15° 12.781' south latitude and 124° 11.586' east longitude; then north-easterly along the geodesic to a point at 15° 12.212' south latitude and 124° 11.825' east longitude; then northerly along the geodesic to the commencement point.

Montgomery Reef Sanctuary Zone

All waters bounded by a line commencing at a point at 15° 50' south latitude and 124° 03' east longitude; then extending due east along the parallel to a point at 15° 50' south latitude and 124° 21' east longitude; then due south along the meridian to a point at 16° 03' south latitude and 124° 21' east longitude; then due west along the parallel to a point at 16° 03' south latitude and 124° 03' east longitude; then due north along the meridian to the commencement point; but excluding all waters bounded by a line commencing at a point at 16° 00' south latitude and 124° 18' east longitude; then extending due west along the parallel to a point at 16° 00' south latitude and 124° 17' east longitude; then due north along the meridian until its intersection with the low water mark on the edge of Montgomery Reef being the point closest to 15° 59.60' south latitude and 124° 17' east longitude; then generally westerly and easterly (up, across and down the channel) along the low water mark; then generally easterly, northerly and southerly (up, across and down the adjacent channel commonly

referred to as 'The River') along the low water mark; then generally easterly and north-easterly along the low water mark until its intersection with the meridian between a point at 15° 59' south latitude and 124° 18' east longitude and a point at 16° 00' south latitude and 124° 18' east longitude; then due south along the meridian to the commencement point.

Schedule 2—Special Purpose areas (wilderness conservation)

Jungulu Special Purpose Zone (wilderness conservation)

All waters bounded by a line commencing at a point at 15° 12' south latitude and 124° 19' east longitude; then extending due east along the parallel to a point at 15° 12' south latitude and 124° 34' east longitude; then due south along the meridian towards a point at 15° 14.84' south latitude and 124° 34' east longitude (on Augustus Island near Adieu Point) until its intersection with the high water mark; then generally south-westerly and south-easterly along the high water mark until its intersection with the parallel between a point at 15° 18' south latitude and 124° 29.69' east longitude (on Augustus Island) and a point at 15° 18' south latitude and 124° 27.56' east longitude (on Jungulu Island); then due west along the parallel towards a point at 15° 18' south latitude and 124° 27.56' east longitude (on Jungulu Island) until its intersection with the high water mark; then generally north-westerly and south-westerly along the high water mark until its intersection with the meridian between a point at 15° 18.55' south latitude and 124° 20.60' east longitude (on Jungulu Island) and a point at 15° 18.87' south latitude and 124° 20.60' east longitude (on Heywood Island); then due south along the meridian towards a point at 15° 18.87' south latitude and 124° 20.60' east longitude (on Heywood Island) until its intersection with the high water mark; then generally south-westerly along the high water mark until its intersection with the meridian between a point at 15° 20.28' south latitude and 124° 19' east longitude (on Heywood Island) and a point at 15° 12' south latitude and 124° 19' east longitude; then due north along the meridian to the commencement point.

Order No. 8 of 2021

Actionstep 853

Made by the Minister under section 43.

1. Citation

This instrument is the *Prohibition on Fishing (Lalang-garram / Horizontal Falls Marine Park) Order 2021*.

2. Interpretation

In this order—

demersal gillnet means any gillnet that when set is wholly or partially in continuous or intermittent contact with the sea bed;

Sanctuary area means a zone or zones specified in Schedule 1;

Special Purpose area means a zone or zones specified in Schedule 2;

trawling means fishing by means of nets towed by boat.

3. Prohibition on fishing

(1) A person must not fish by any means in a Sanctuary area.

(2) A person must not fish for a commercial purpose in a Special Purpose area (recreation and conservation) by means of—

(a) demersal gillnet; or

(b) trawling.

Schedule 1—Sanctuary areas

Dirindja Sanctuary Zone

All waters bounded by a line commencing at the intersection of the high water mark and the meridian between a point at 15° 40.45' south latitude and 124° 46.10' east longitude (on the mainland) and a point at 15° 40.70' south latitude and 124° 46.10' east longitude; then extending due south along the meridian towards a point at 15° 40.97' south latitude and 124° 46.10' east longitude (on the unnamed island) until its intersection with the high water mark; then generally westerly and south-easterly along the high water mark until its intersection with the geodesic between a point at 15° 41.20' south latitude and 124° 46.10' east longitude (on the unnamed island) and a point at 15° 43.25' south latitude and 124° 44.65' east longitude (on the mainland); then south-westerly along the geodesic towards a point at 15° 43.25' south latitude and 124° 44.65' east longitude (on the mainland) until its intersection with the high water mark; then generally northerly, north-westerly, south-easterly and southerly along

the high water mark of the Gairdner River, and the tributaries draining into the Gairdner River, to the commencement point.

Ganjaal Sanctuary Zone

Order No. 9 of 2021

Actionstep 851

Made by the person holding or performing the functions of the office of the Minister, as delegate of the Western Australian Fisheries Joint Authority, under section 43.

1. Citation

This instrument is the *Prohibition on Fishing (Lalang-garram / Horizontal Falls Marine Park) Joint Authority Order 2021*.

2. Interpretation

In this order—

demersal gillnet means any gillnet that, when set, is wholly or partially in continuous or intermittent contact with the sea bed;

Joint Authority fishery means the Northern Shark Fishery;

Sanctuary area means a zone or zones specified in Schedule 1;

Special Purpose area (recreation and conservation) means the zone or zones specified in Schedule 2.

3. Prohibition on fishing

A person fishing in a Joint Authority fishery must not fish—

- (a) in a Sanctuary area; or
- (b) by means of demersal gillnet in a Special Purpose area (recreation and conservation).

Schedule 1

Sanctuary areas

Dirindja Sanctuary Zone

These are your legal requirements. Please read carefully and retain for future reference.

This notice sets out the actions that you must take to prepare your property for the fire season. As a measure for preventing the spread or extension of a bush fire which may occur, all owners and occupiers of the land within the Shire's district are required before Thursday, 28 October 2021; to clear firebreaks or to take measures in accordance with this Notice and maintain those firebreaks and measures in accordance with this Notice up to and including Friday, 22 April 2022.

It is the responsibility of ALL landowners/occupiers within the Shire of Ravensthorpe to read and fully understand their requirements mentioned within this Notice.

This Notice constitutes the Shire of Ravensthorpe Fire Break Notice and is issued under Section 33(1) *Bush Fires Act 1954*.

Town Site: Residential, Industrial and Commercial Areas

*(Please refer to the definition section of this Notice for words marked with *).*

Applied to all land zoned with the town sites of Fitzgerald, Hopetoun, Jerdacuttup, Munglinup and Ravensthorpe, you must—

- a. Where the area of land is 3,000m² or less—
 - i. Reduce fire fuel* from the whole of land such that fuel loads are maintained to a maximum of 2 tonnes per hectare. Isolated trees and managed shrubs may generally be retained.
- b. Where the area of land exceeds 3,000m²—
 - i. Establish and maintain an Asset Protection Zone* around all habitable buildings;
 - ii. Grassed areas (dry or reticulated) to be maintained to a maximum height of 100mm; and
 - iii A 3 metre wide bare earth firebreak* shall be constructed and maintained inside ALL external boundaries where practicable. Located around fuel storage tanks, sheds, gas cylinders and within 6 metres of haystacks. Haystacks cannot be situated on the external boundary.
- c. Where a Bushfire Management Plan* which relates to the property has been adopted by Council, clear firebreaks and take measures in accordance with that Bushfire Management Plan* as an alternative to the standard requirements listed in this Notice.
- d. Where the land has been cleared for the purpose of development and the land remains vacant it must be maintained in that cleared state,

NOTE: Where any conditions listed in requirements a and b of the above are physically impractical on a property, the Shire may approve a Variation* in place of the standard requirement (refer to Application to Vary Request of this Notice).

Rural Areas

*(Please refer to the definition section of this Notice for word marked with *).*

Applies to all land zoned as Rural, you must—

- a. Any rural land abutting or adjacent to land zoned as Rural Residential, Urban, Industrial or Commercial must have a 3 metre wide bare earth firebreak* constructed and maintained inside ALL external boundaries. Breaks should also have a 5 metre vertical clearance so that the firebreak provides unrestricted vehicular access or;

- b. Any Rural Land, Rural Conservation, Rural Small Holdings less than 100Ha—
 - i. Areas of unmanaged pasture or grassland must have a 3 metre wide bare earth firebreak* constructed and maintained inside ALL external boundaries.
 - ii. Breaks to provide a 5 metre vertical clearance so that the firebreak provides unrestricted vehicular access; and
 - iii. Driveways must be cleared to a minimum of 4 metres wide and 5 metres in height that can provide unrestricted access to emergency service vehicles.
- c. A 3 metre wide bare earth firebreak* shall be located around fuel storage tanks, sheds, gas cylinders and within 6 metres of haystacks. Haystacks cannot be situated on the external boundary.

Rural Residential

*(Please refer to the definition section of this Notice for word marked with *).*

Applies to all land zoned Rural Residential which includes areas known as Blue-Vista, Dunns Swamp, Krystal Park, Lakes Entrance, Seaview Estate, Steeredale Estate and Whale Bay Estate, you must—

- a. Clear either a 3 metre wide bare earth firebreak* or a 3 metre wide mulched/slashed fire break immediately inside on ALL external boundaries. Breaks should also have a 5 metre vertical clearance so that the firebreak provides unrestricted vehicular access.
- b. Parkland clearing must be carried out in all open paddocks and along the boundary of the property. Clearing means that all dead vegetation and flammable material* (excluding approved crops, pasture areas and living trees/shrubs) are removed;
- c. Unmanaged pasture and grasslands must be maintained to a height no greater than 100 millimetres.
- d. A 3 metre wide bare earth firebreak* shall be located around fuel storage tanks, sheds, gas cylinders and within 6 metres of haystacks. Haystacks cannot be situated on the external boundary.
- e. Establish and maintain a Low Fuel Zone (parkland cleared) 1 metre wide, around Power Infrastructure eg. Metre Box, Poles and Underground Power Domes;
- f. Driveways must be cleared to a minimum of 4 metres wide and 5 metres in height, that can provide unrestricted access to emergency service vehicles;
- g. Properties to establish and maintain an Asset Protection Zone* around all habitable buildings (refer to section of the Notice on Asset Protection Zone; and
- h. Where a Bushfire Management Plan* which relates to the property has been adopted by Council, clear firebreaks and take measures in accordance with that Bushfire Management Plan as an alternative to the standard requirement listed into this notice.

NOTE: Where any conditions listed in requirements a, b and f of the above are impractical for site-specific, topographical or environmental reasons on a property, the Shire may approve a Bushfire Management Plan* or Variation* in place of the standard requirement (refer to Application to Vary Request of this Notice).

Plantations

*(Please refer to the definition section of this Notice for word marked with *).*

All Plantations MUST—

- a. Maintain a 15 metre wide bare earth firebreak* inside all external boundaries with a 5 metre vertical clearance so that the firebreak provides unrestricted vehicular access; and
- b. Have an approved Bushfire Management Plan* with the Shire of Ravensthorpe; or
- c. Plantations are to abide by the Guidelines for Plantation Fire Protection developed by the Department of Fire and Emergency Services.

Non Compliance

Pursuant to Section 33(3)(4)(5) *Bush Fires Act 1954*, failure to comply to the requirements mentioned within this notice, by the requirement compliance dates will result in the following—

- a. An infringement Notice—
 - A \$250 infringement will be issued to the landowner for non-compliance to this Notice. Landowner/occupiers will have 7 calendar days for the property to be compliant to this Notice. Failure to comply to this Notice will result in; and,
- b. A Work Order—
 - Shire will engage an available contractor on your behalf and authorise the contractor to enter the property to carry out the required works in accordance with this Fire Break Notice.

NOTE: Landowner/occupiers will NOT be provided with a warning notice for non-compliance to this Notice. Additionally Landowner/occupiers will NOT be provided an additional 14 calendar days to comply.

Landowners/occupiers issued with an Infringement Notice will have 28 days to arrange payment with the Shire, otherwise infringement notices may be referred to Department of Justice Fines Enforcement Registry for follow up payment, which can lead to the suspension of your Drivers Licence.

A Works Order can be issued at any time throughout the compliance period, for properties not maintained to the requirements within the Fire Break Notice. As such the Shire of Ravensthorpe will recover ALL cost incurred against the Landowner as permissible under the *Bush Fires Act 1954*.

Application to Vary Request

(Please refer to the definition section of this Notice for word marked with *).

a. Variations—

If it is impracticable for any reason to clear firebreaks or to take measures in accordance with this Notice, you may apply to the Shire in writing before 1 October each year for permission to provide firebreaks in alternative locations or take alternative measures to prevent the outbreak or spread of a bush fire. If permission is not granted in writing by the Shire, you shall comply with the requirements of this Notice.

The requirement for an Asset Protection Zone* may be varied by Council on application. Where it is not practical for an existing dwelling to provide a 20 metre Asset Protection Zone* a landowner may apply for a variation to the Firebreak Notice. In considering any such request regard will be given to—

- a. The topography of the site or privacy issues;
- ii. Potential environmental impacts; and
- iii. Provision of alternative low or management fuel zones.

The Shire may approve variations to the Asset Protection Zone for a period not more than 5 years.

b. Bushfire Management Plan—

As an alternative to lodging a request for a variation, a landowner may have a site-specific Bushfire Management Plan* prepared by a Bushfire Planning Practitioner* that fully complies with the requirements of State Planning Policy 3.7 Planning in Bushfire Prone Areas (SPP3.7) and associated Guidelines. This Bushfire Management Plan* is to be approved by the Shire of Ravensthorpe.

Proposals for a Bushfire Management Plan* (BMP) must be provided to the Shire no later than 1 September for permission to provide alternative fire mitigation measures on the land—

- i. If a BMP has been approved by the Shire, it will thereafter replace and totally extinguish the landowner's obligations to otherwise implement the standard regulations as described in the Fire Regulation Notice, appropriate to the zoning of the property; or
- ii. If a BMP has not been approved then the standard Regulations must be implemented by the due dates.

NOTE: A number of properties developed since 2015 will have an adopted BMP as part of their existing planning approval.

Driveways

Driveways must be cleared to a minimum of 4 metres wide and 5 metres in height that can provide unrestricted access to emergency service vehicles gaining entrance and trans-versing your property during an emergency.

Definitions

- a. Asset Protection Zone—Asset Protection Zones (formally Building Protection Zone) is a low fuel area immediately surrounding a building. These requirements are designed to reduce the fire's intensity and minimise the likelihood of flame contact with buildings. APZ gives more protection to families should a fire threaten suddenly and they cannot leave—
- b. Bare Earth Fire Breaks—A strip of land that has been cleared of all trees, bushes, grasses and any other object or thing or flammable vegetation material leaving clear bare mineral earth—Achievable by ploughing, grading or early spraying.
- c. Bushfire Management Plan (BMP)—Is a document that sets out short, medium and long-term risk management strategies for the life of the development. It is to be prepared by an accredited Bushfire Planning Practitioner in accordance with the requirements of State Planning Policy 3.7 Planning in Bushfire Prone Areas (SPP3.7) and associated Guidelines.
- d. Bushfire Planning Practitioner—A person who holds Level Two or Level Three accreditation under the Western Australian Bushfire Accreditation Framework.
- e. Flammable Materials—Any material that is easily ignited, capable of burning and of carrying a fire.
- f. Tonnes per Hectare—
 - 2 tonnes per hectare = 200 grams (2 handfuls) fire fuel per square metre.
 - 8 tonnes per hectare = 800 grams (8 handfuls) fire fuel per square metre.
- g. Fire Fuel—Any combustible material, dead or alive, in isolation or clusters or aggregation with other combustible materials that, in the opinion of an authorised office of the Shire of Ravensthorpe, is likely to fuel a bushfire. Including but not limited to—
 - Heavy leaf litter on the ground, dead leaves in gutters, fallen branches and any combustible vegetation in clusters. Of particular concern are combustible materials suspended off the ground;

- All dry grasses exceeding a height of 100mm; and
- Any tree within the APZ or branch of a tree that may fall onto a building which in the opinion of an authorised officer of the Shire of Ravensthorpe constitutes an unacceptable fire risk.

It does not include—

- Vegetable gardens, tended lawns, landscaped gardens (including deciduous or ornamental planted trees), isolated planted shrubs, established natural or planted trees that, in the opinion of an authorised officer of the Shire of Ravensthorpe do not constitute an unacceptable fire risk;
- Well compacted dead vegetative material e.g. mulch that in the opinion of an authorised officer of the Shire of Ravensthorpe does not constitute an unacceptable fire risk.

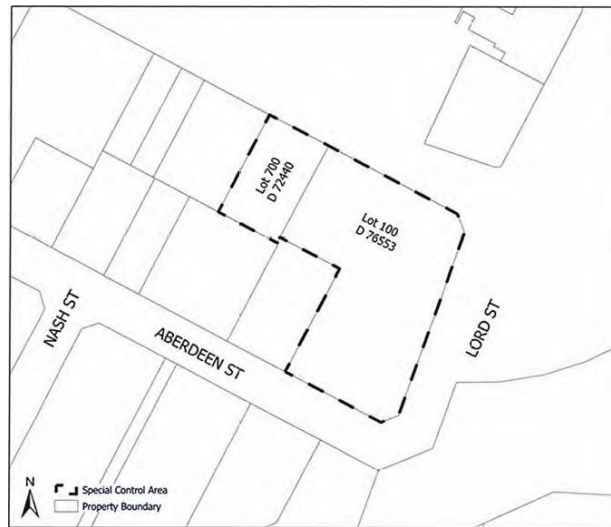


Figure 32: 11 and 27 Newcastle Street Special Control Area
