Coroners Act 1996

## Coroners Amendment Regulations 2021

SL 2021/150

Made by the Governor in Executive Council.

**1. Citation**

These regulations are the *Coroners Amendment Regulations 2021*.

**2. Commencement**

These regulations come into operation as follows —

- (a) regulations 1 and 2 — on the day on which these regulations are published in the *Gazette*;
- (b) the rest of the regulations — on the day after that day.

**3. Regulations amended**

These regulations amend the *Coroners Regulations 1997*.

**4. Regulation 3A amended**

In regulation 3A insert in alphabetical order:

*authorised user*, of the ECMS, means a person who is registered with the court to send documents to the court, and to receive documents from the court, by means of the ECMS;

*ECMS* means the electronic case management system for the management of proceedings in Western Australian courts and tribunals;

**5. Regulations 5A to 5E inserted**

After regulation 5 insert:

**5A. Applying court's seal electronically**

For the purposes of the *Courts and Tribunals (Electronic Processes Facilitation) Act 2013*

section 10, a document issued by the court in accordance with regulation 5C is authenticated if the electronic document bears a facsimile of the court's seal.

**5B. Applying signatures electronically**

For the purposes of the *Courts and Tribunals (Electronic Processes Facilitation) Act 2013* section 10 —

- (a) a document issued by the court in accordance with regulation 5C is authenticated if the electronic document identifies the person who issued it; and
- (b) a document filed with the court in accordance with regulation 5D is authenticated if the name of the person who signed the document is stated in the electronic version of the document at any place where a signature appears in the paper version of the document.

**5C. Documents issued by court in electronic form**

For the purposes of the *Courts and Tribunals (Electronic Processes Facilitation) Act 2013* section 12, if the court is required, permitted or authorised under the Act to issue a person a record, notice, order, report, summons, authorisation or other document that is not required to be served personally, the court may issue the document to the person in electronic form —

- (a) if the person is an authorised user of the ECMS — by means of the ECMS; or
- (b) if the person provides an email address for service — by email.

**5D. Documents filed with court in electronic form**

- (1) For the purposes of the *Courts and Tribunals (Electronic Processes Facilitation) Act 2013* section 12, a person who is required or authorised under the Act to file a document with the court may file the document in electronic form —

- (a) if the person is an authorised user of the ECMS — by means of the ECMS; or
- (b) by email to an email address provided by the court.

- (2) A document that does not comply with the requirements of the ECMS is taken —

- (a) not to have been filed with the court; and
- (b) not to be part of the court's record.

- (3) If an authorised user of the ECMS files a document with the court in electronic form by means of the ECMS but does so in error, the court may, with the consent of the authorised user, remove the document from the court's record.

**5E. Time of electronic issue and lodgment**

A document issued in accordance with regulation 5C or filed in accordance with regulation 5D —

- (a) by means of the ECMS, is taken to have been issued or filed on the day and at the time recorded by the ECMS; or
- (b) by email, is taken to have been issued or filed —
  - (i) if the email is sent before 4 pm on a working day — on that day;
  - (ii) otherwise, on the next working day after the day on which the email is sent.

**6. Regulation 23A (1<sup>st</sup> occurrence) renumbered**

Renumber regulation 23A (1<sup>st</sup> occurrence) as regulation 22A.

#### BUSH FIRE ACT 1954

##### *Shire of Esperance*

##### FIRE HAZARD REDUCTION NOTICE

First and Final Notice has been served to all Owners and/or Occupiers of Land situated within the Shire of Esperance.

As a measure to assist in the control and prevention of bush fires, and pursuant to the powers contained in Section 33 *Bush Fires Act 1954* you have a legal obligation to meet the requisitions of this Notice and keep the property compliant from 1 October 2021 until 31 March 2022.

Take Notice, pursuant to Section 33(4) *Bush Fires Act 1954*, where the landowner and/or occupier fails or neglects to comply with the requirements of this Notice within the specified times, the Shire of Esperance may, by its Authorised Officers and with such servants, workmen and contractors, vehicles and machinery as the Authorised Officers deem fit, enter upon the land and carry out the requisitions of this Notice. Pursuant to Section 33(5) of the *Bush Fires Act 1954*, the amount of any costs and expenses incurred may be recovered from you as the owner and/or occupier of the land.

Failure to comply with the Shire's Fire Hazard Reduction Notice may result in a penalty up to \$5,000, with additional contractor and administrations costs to carry out fire prevention works on your property.

**Bush Fire Management Plans (may be required)**

All properties that are subject to a Bush Fire Management Plan as a result of a subdivision, development application or a Shire approved treatment plan must comply with the requirements of such plans in their entirety.

**Urban and Rural Residential**

Including Residential, Commercial and Industrial Land within a town site or any other subdivided area for residential purposes—

- Where the land is 2000 square metres or less, remove all flammable material and where the land is vacant, mow or slash the whole of the land to achieve a low fuel condition.
- Where the land is 2000 square metres or more, install and maintain, a trafficable low fuel fire-break not less than 4 metres (m) wide and 4m high immediately on the inside of all property boundaries.

**Rural Land**

Cleared Land—Boundary fire-breaks are not compulsory.

**Uncleared Land** (except areas set aside for conservation purposes)—install 6m wide by 4m high trafficable, fire-breaks immediately inside all external property boundaries. In cases where a property is partially cleared, fire-breaks are required where the uncleared land abuts the property boundary.

Properties are to be compliant to the above, as at 1 October 2021 and maintained to 31 March 2022.

**Variation to Notice Requirements**

If it is, for any reason, impractical to install trafficable fire-breaks adjacent or within 5m to your external boundary, or remove flammable material as required by this Notice, you may apply to the Shire, before 24 September 2021, for permission to take alternative action to remove or minimize the fire hazard. Should permission for Variation not be granted, you must comply with the requirements of this Notice.

**Definitions**

For the purpose of this Notice, the following definitions apply—

**Authorised Officer** means a person appointed by the Shire of Esperance as a Bush Fire Control Officer.

**Fire-break** means a strip of land achieving a low fuel condition to the specified width and height as required by this Notice. This can be achieved through mowing, slashing, parkland clearing, or any other means to achieve this objective. Fire-breaks will not stop fires from spreading, but they may prevent small fires from escaping your property and landscape fires from entering. Importantly fire-breaks provide safer access for yourself and firefighters to conduct fire suppression activities on your land.

**Flammable Material** means any material that can be easily ignited or is likely to catch fire and burn or any other thing deemed by an Authorised Officer to be capable of combustion. Flammable Material can be but it is not limited to dead or dried grasses, a buildup of leaf litter, dead or dried timber or trees, stockpile of boxes, cartons or papers. This does not include living trees, shrubs and plants under cultivation.

**Low Fuel Condition** means an area where all flammable material has been reduced to a height of not more than 100mm. This can be achieved through mowing, slashing, parkland clearing, grazing, spraying or any other method to achieve the same objective.

**Trafficable** means the ability for 4x4 vehicles to access your land on a firm surface without obstruction. No firebreak is to terminate without provision for egress to a safe place or a cleared turnaround area not less than a 21 metre radius.

**BUSH FIRES ACT 1954**

*Shire of Nungarin*

**FIRE PREVENTION AND FUEL LOAD NOTICE**

Pursuant to the powers contained in Section 33 of the *Bush Fires Act 1954* (as amended), notice is hereby given to all owners and occupiers of land within the Shire of Nungarin, the Shire of Nungarin adopted the following requirements as a measure to assist in the control of bush fires, or preventing the spread or extension of a bush fire which may occur within the Shire.

All owners and/or occupiers of land within the Shire of Nungarin are required to carry out fire prevention work in accordance with this notice by 1st October each calendar year and maintained until 15 April the following calendar year, or within 14 days of becoming an owner or occupier of land if after that date, to comply with the requirements set out in this notice.

Failure to comply with the requirements of this order may result with the issue of an infringement notice penalty \$250.00 or prosecution in a court of law with a maximum penalty of \$5,000 and be liable whether prosecuted or not to pay the costs of performing the work directed by the notice.

### 1. Building Protection Zone

The Building Protection Zone is an area of very low fuel levels and managed vegetation 20 metres out from habitable buildings (As defined in the Residential Design Codes of WA and in AS 3959) and must meet the following requirements—

Habitable building means a dwelling, workplace, place of gathering or assembly, a building used for the storage or display of goods or produce for sale by wholesale in accordance with classes 1-9 of the Building Code of Australia. The term habitable building includes attached and adjacent structures like garages, carports, verandas or similar roofed structures that are attached to, or within 6 metres of, the dwelling or primary building.

- Building Protection Zones for habitable buildings must extend a minimum of 20 metres out from any external walls of the building, attached structures, or adjacent structures within 6 metres of the habitable building.
- On sloping ground the Building Protection Zone distance shall increase at least 1 metre for every degree in slope on the sides of the habitable building that are exposed to down slope natural vegetation.
- Building Protection Zones must consist of non-flammable managed vegetation, reticulated lawns and gardens and other non-flammable features.
- All grass in Building Protection Zones must be maintained to or under 5cm in height.
- Fuel loads within Building Protection Zones must be maintained at 2 tonnes per hectare or lower.
- The crowns of trees must be separated to create a clear separation distance between adjoining or nearby tree crowns. The separation distance between tree crowns is not required to exceed 10 metres.
- A small group of trees within close proximity to one another may be treated as one crown provided the combined crowns do not exceed the area of a large or mature crown size for that species.
- Trees are to be low pruned (or under pruned) to at least a height of 2 metres from ground.
- No tree, or shrub over 2 metres high are to be within 2 metres of a habitable building.
- Trees and shrubs over 2 metres high must not be planted in groups close to the habitable building and there must be a gap of at least 3 times the height (at maturity) of the shrub away from the habitable building.
- There must be no tree crowns or branches hanging over habitable buildings.
- Firewood and flammable materials must be stored 10m from habitable buildings.
- Driveways and access ways are to be a minimum of (3) metres wide with a vertical clearance of (4) metres to allow for the safe passage of a fire appliance to all buildings and assets on the land.
- Roof gutters should be free of leaves and other combustible material.

### 2. Land with area less than 10,000m<sup>2</sup>

- Maintain all grass on the land to a height no greater than 10cm all windrows or dead flammable material must be removed.
- Maintain fuel loadings in natural bush areas at less than 8 tonnes per hectare across the land
  - Land with a habitable building on it must maintain a Building Protection Zone.

### 3. Agricultural Land or Land with an area greater than 10,001m<sup>2</sup>

- Clear a firebreak consisting of mineral earth, to a width of no less than 3 metres, as close as practical inside the external boundaries of the property.
- Firebreaks must be maintained to provide a vertical clearance of a minimum 3.5 metres as to allow adequate access for fire appliances.
- An approved firefighting appliance is required to be present in any paddock where crop harvesting, straw raking or hay baling is being carried out. The firefighting appliance must be in a state of readiness and have a minimum capacity of 400 litres of water.
- Harvesting is permitted on Sundays and all public holidays, with the exception of Christmas Day, Boxing Day and New Year's Day.

### 4. Fuel Depot and Storage Areas, Haystacks, Chaff Dumps, Stockpiled Flammable Materials and Stationary Machinery.

- Remove all flammable matter within (10) metres of Fuel Depot and Storage Areas of where fuel drums whether containing fuel or not, fuel ramps or fuel dumps are located, Haystacks, Chaff Dumps, Stockpiled Flammable Materials, Stationary Machinery are stored.
- Install bare earth firebreaks three (3) metres wide immediately inside and along all boundaries of land in a continuous form with a vertical clearance of (4) metres where overhanging branches are trimmed back immediately adjacent to Fuel Depot and Storage Areas, Haystacks, Chaff Dumps, Stockpiled Flammable Materials and Stationary Machinery.

### **5. Bushfire or Emergency Management Plans (Compliance is required throughout the year, every year)**

Means a bushfire management plan, emergency management plan or an approved Bushfire attack level (BAL) assessment that has been developed and approved to reduce and mitigate fire hazards as part of a subdivision approval or a building permit.

- All properties with a Bush Fire, Fire or Emergency Management Plan shall comply with the plan in its entirety.
- Any requirements identified in a Bush Fire, Fire or Emergency Management Plan are in addition to the requirements of this notice.

### **6. Application to vary the Firebreak Requirements with Alternative Arrangements**

If it is considered impracticable for any reason whatsoever to implement any of the requirements of this Notice, you may apply in writing to the Shire of Nungarin by no later than the 7th September each year for permission to implement alternative measures. If permission is not granted in writing you must comply with the requirements of this notice.

### **7. Restricted and Prohibited Burning times**

- The “Restricted Burning Time” means the 1st October through until 31st October and the 16th February through until 15th April each calendar year (inclusive, and as varied pursuant to Sections 17 and 18 of the *Bush Fires Act 1954*).
- The “Prohibited Burning Time” means the 1st November each calendar year through until 15th February the following calendar year (inclusive, and as varied pursuant to Sections 17 and 18 of the *Bush Fires Act 1954*).

### **8. Permits to burn**

Means a “Permit to Burn the Bush” as issued by an Authorised Officer under section 18 of the *Bush Fires Act 1954*.

- Applications for Permits are available from the Shire of Nungarin at no cost.
- You must comply with all conditions imposed by the Shire or an Authorised Officer in respect of any Permit issued by the Shire.
- Permits will not be valid on days of “Very High”, “Severe”, “Extreme” or “Catastrophic” fire danger.
- Permits may also be revoked if in the opinion of an authorised officer the conditions are not deemed suitable for prescribed burns.

Take Notice that pursuant to *Section 18 (11) of the Bush Fires Act 1954* - Where a person starts a fire on land, if the fire escapes from the land or if the fire is in the opinion of a bush fire control officer or an officer of a bush fire brigade out of control on the land, the person shall be liable to pay to the local government on the request of and for recoup to its bush fire brigade, any expenses up to a maximum amount of \$10,000 incurred by it in preventing the extension of or extinguishing the fire, and such expenses may be recovered in any court of competent jurisdiction.

A person who commits a breach of this section other than subsection (11) is guilty of an offence.

Penalty: For a first offence \$4,500.

For a second or subsequent offence \$10,000.

### **9. Harvest, Movement of Vehicles and Hot Works Bans**

All persons within the Shire are required to comply with these bans under the provisions of the Bush Fires Act.

- A Harvest Ban requires the cessation of all harvesting operations within the Shire of Nungarin.
- A Vehicle Movement ban does not permit the movement of vehicles on properties within the Shire of Nungarin except for the essential watering of stock in a diesel-powered vehicle.
- A Hot Works ban is defined as a ban on the outdoor use of all welding, grinding and abrasive tools on properties within the Shire of Nungarin. Further information is available by contacting Shire of Nungarin (08) 9046 5006.

A person/s who lights a fire contrary to the provisions of this section or who fails to carry out any direction given to him is guilty of an offence that carries a maximum penalty of \$10,000.

A Harvest Vehicle Movement and Hot works Ban will be advertised on the Shire of Nungarin Website or Emergency Information Line on (08) 9621 1120. Where possible on ABC Radio 531AM, Radio West 864 AM and. Ban updates can be obtained or via a free SMS service which is available upon request from the Shire of Nungarin (08) 9046 5006.

### **10. Additional Works**

In addition to the requirements noted above, regardless of land size and location, the Shire of Nungarin or its duly authorised officer may require you to undertake additional works on your property to improve access and or undertake further hazard removal and/or reduction works, where in the opinion of that authorised officer, it is to be necessary to prevent the outbreak and/or the spread of a bush fire.

Take notice that pursuant to Section 33(4) of the *Bush Fires Act 1954*, where the owner and/or occupier of land fails or neglects to comply with the requisitions of this Notice within the times specified, the Shire of Nungarin may by its officers and with such servants, workmen and contractors, vehicles and machinery as the officers deem fit, enter upon the land and carry out the requisitions of this Notice which have not been complied with and pursuant to Section 33(5) of the *Bush Fires Act 1954*, the

amount of any costs and expenses incurred may be recovered from you as the owner and or occupier of the land.

If the requirements of this Notice are carried out by burning, such burning must be in accordance with the relevant provisions of the *Bush Fires Act 1954*.

The Penalty for failing to comply with this Notice is a fine not exceeding \$5000 and a person in default is also liable whether prosecuted or not to pay the costs of performing the work directed by this Notice if it is not carried out by the owner and/or occupier by the date required by this Notice.

#### **11. Reserves vested with the Shire of Nungarin**

The Shire of Nungarin reserves the right to conduct any mitigation works deemed necessary on any reserves vested with Shire of Nungarin for the purpose of reducing the risk of fire to the community. Treatment implemented may include but not be limited to prescribed burns, slashing, mulching or any other means necessary as determined by the Shire of Nungarin to ensure the risk is reduced to a satisfactory level.

#### **GENERAL ADVICE**

This notice gives the minimum requirements for fire control within the Shire of Nungarin and all residents and ratepayers are encouraged to be “Bushfire Ready” by undertaking additional fire protection measures like creating a household “Bushfire Survival Plan”. #### **BUSH FIRES ACT 1954**

*City of Kalgoorlie-Boulder*

#### **FIREBREAK NOTICE 2021/2022**

#### **Notice to all owners and/or occupiers of land situated in the City of Kalgoorlie-Boulder**

As a measure to assist in the control of bush fires, and to prevent the spread or extension of a bush fire which may occur, all owners and/or occupiers of land within the City of Kalgoorlie-Boulder district are required before the 1st day in October each year, or within 14 days of becoming the owner or occupier of land if after that date, to clear firebreaks or take measures in accordance with this notice and maintain those firebreaks and measures up to and including the 30th day of April in the following year.

#### **Interpretation**

“Act” means the *Bush Fires Act 1954*;

“Authorised Person” means a person authorised in accordance with S.9.10 of the *Local Government Act 1995* by the City of Kalgoorlie-Boulder.

“City” means the City of Kalgoorlie-Boulder.

“Flammable Matter” includes all form of vegetation both living and dead, and any other flammable materials and combustible matter;

“Firebreak” means ground which is cleared to a mineral earth standard in which all flammable material (which includes vegetation and with all overhanging branches, trees, limbs, etc. to be trimmed back clear of the Firebreak area) has been removed and on which no flammable material (which includes vegetation) is permitted during the Firebreak period and the Firebreak must be the required width.

“Firebreak Period” means the time from 1st October in any year until 30th April in the year following;

“Trafficable” means able to be driven around, unhindered, in a standard four-wheel drive vehicle.

#### **General Requirements**

All owners and/or occupiers of land within the district of the City of Kalgoorlie-Boulder must clear all flammable matter from the land in accordance with the following requirements—

*Land which is 5,000m<sup>2</sup> or less in area*, shall be required to follow the general fire hazard reduction measures as stated in this notice.

*Land which is 5,001m<sup>2</sup> or greater in area*, shall have a trafficable firebreak three (3) metres in width cleared immediately inside all external boundaries of the land to mineral earth or to the satisfaction of an authorised person.

#### **General Fire Hazard Reduction Measures**

All owners/occupiers are required to reduce fire hazards on their property as far as reasonably practicable over the entire area of land. This can be achieved by clearing all “flammable matter” to a height of no more than 50mm, or to the satisfaction of an authorised person and all clearing must be

done in accordance with the Act. Fire Hazard Reduction Orders will be issued where owners/occupiers have failed to reduce fire hazards on their property to a satisfactory state in the opinion of an authorised person.

#### **Amendments to the above requirements**

If an owner or occupier of land within the district of the City of Kalgoorlie-Boulder is unable to comply with the requirements of this notice, that owner or occupier may request in writing to the City, to undertake alternative measures to enable compliance with this notice in the opinion of an authorised person.

#### **The following are the Burning Periods for Kalgoorlie-Boulder District**

**Firebreaks/Reduction Measures must be installed by** 1st October and remain until 30th April in the following year.

**Prohibited Period** - All Burning is prohibited between 1st November to 31st March in the following year.

**Restricted Period** - Permits are required between 1st April to 30th April and 1st October to 31st October each year.

**No permit required Period** - Burning off does not require a permit however restrictions still apply from 1st May to 30th September each year.

#### **The following restrictions apply at all times throughout the year—**

- No burning off on Sunday or Public Holidays.
- No burning off of garden waste, refuse or offensive materials at any time.
- No burning off contrary to the provisions of the City's Health Local Law.
- Authorised burning off will only be undertaken between the hours of 6:00 pm and 11:00 pm.
- All neighbouring property occupiers must be informed of the burning off before commencement.
- An authorised person must be informed of the burning off before commencement.
- Local Fire Station Officers must be informed of the burning off before commencement.

#### **Compliance**

(1) In addition to the requirements of this notice, further works which are considered necessary by an authorised person may be required as specified in writing in a subsequent notice addressed to the land owner as recorded by the City.

(2) Where the owner or occupier of the land fails or neglects to comply with the requirements of this notice or a subsequent notice addressed to the land owner, an authorised person may enter onto and upon the land with any workmen, contractors, vehicles and machinery as required to carry out the requisitions of the notice at the expense of the land owner. Where the City is required to act in default, the land will be cleared in accordance with this notice or at the discretion of an authorised person.

(3) Failure to comply with this notice and subsequent written notices may result in penalties being issued or court action and the liability for any costs incurred by the City in relation to works undertaken on behalf of the land owner.
