1. Citation

2. Commencement

- (b) the rest of the regulations on the day after that day.

This Part amends the *Mining Regulations* 1981.

4. **Regulation 96CB inserted**

After regulation 96CA insert:

96CB. Release of information to Director General of Finance for royalties activities

(1) In this regulation —

Department of Finance means the department of the Public Service principally assisting the Minister for Finance in the administration of the *Taxation Administration Act 2003*;

Department of Finance worker means a public service officer, or any other individual, who is employed or engaged in, or who otherwise holds a position in, the Department of Finance;

Director General of Finance means the individual for the time being holding or acting in the office of chief executive officer of the Department of Finance;

Minister for Finance means the Minister to whom the administration of the *Taxation Administration Act 2003* is for the time being committed by the Governor;

relevant information means information of the kind referred to in section 162(2)(x) of the Act, irrespective of when, as the case may be —

- (a) any application or report containing the information was made or given; or
- (b) the information was supplied to the Minister, a warden or an official;

royalties activities means activities done by the Department of Finance in preparation for, or otherwise in anticipation of, Department of Finance workers having, or being delegated, functions for, or connected with, the administration or collection of royalties in respect of minerals.

- (2) The Director General of Mines may release relevant information to the Director General of Finance for the purposes of, or in relation to, royalties activities.
- (3) If the Director General of Mines releases relevant information under subregulation (2), a Department of Finance worker may access, copy, use, store or disclose the relevant information for the purposes of, or in relation to, royalties activities.
- (4) Subregulation (3) authorises a Department of Finance worker to disclose relevant information only to another Department of Finance worker, the Minister for Finance or another Minister.
- (5) An individual who is or was a Department of Finance worker commits an offence if
 - (a) relevant information released by the Director General of Mines under subregulation (2) came to the individual's knowledge in the course of, or by reason of, their employment or engagement in, or their otherwise holding a position in, the Department of Finance; and
 - (b) the individual accesses, copies, uses, stores or discloses the relevant information
 - (i) for the purpose of personal gain; or
 - (ii) otherwise in a way that is not authorised under subregulation (3).
- (6) A Minister to whom relevant information is disclosed under subregulation (3) or this subregulation may access, copy, use, store or disclose the relevant information for the purposes of, or in relation to, royalties activities.
- (7) Subregulation (6) authorises a Minister to disclose relevant information only to another Minister.

Note for this regulation:

This regulation does not authorise the public release of relevant information.

TEMPORARY CLOSURE—BELMONT WATER SKI AREA

Swan River

Department of Transport, Fremantle WA, 14th January 2022.

Acting pursuant to the powers conferred by Regulation 48A of the *Navigable Waters Regulations 1958*, I hereby cancel Notice MA410 as published in the *Government Gazette* on 27th November 2012 effective from 3pm on 26 January 2022 and hereby declare the following waters to be a restricted Water Ski Area effective from 8am 27 January 2022—

Belmont: All the waters of the Swan River downstream of a line through 31°57.208'S, 115°53.965'E (starboard navigation marker) and 31°57.129'S, 115°54.024'E (port navigation marker) located approximately 100 metres upstream of the Balbuk Way public boat ramp and extending downstream to a line through 31°56.749'S, 115°53.741'E (starboard navigation marker) and 31°56.763'S, 115°53.828'E (port navigation marker) located approximately 1000 metres downstream of the boat ramp. All coordinates based on GDA 94.

Restrictions: All Water Skiing activities within this area are to be carried out in an anti-clockwise direction providing however that no vessel or water skier shall approach within 30 metres of the river bank and that no water ski take-off or landing shall be permitted on any foreshore within this area except at those designated areas as described below;

Take off only: At a point on the foreshore upstream of the Balbuk Way public boat ramp at approximately $31^{\circ}57.226$ 'S, $115^{\circ}53.938$ 'E and extending downstream to approximately $31^{\circ}57.219$ 'S, $115^{\circ}53.919$ 'E

Take off and landing: At a point on the foreshore downstream of the Balbuk Way public boat ramp at approximately 31°57.198'S, 115°53.867'E and extending downstream to approximately 31°57.156'S, 115°53.809'E

Take off only: At a point on the foreshore downstream of the Balbuk Way public boat ramp at approximately $31^{\circ}57.132$ 'S, $115^{\circ}53.790$ 'E and extending downstream to approximately $31^{\circ}57.094$ 'S, $115^{\circ}53.767$ 'E

Take off and landing: At a point on the foreshore downstream of the Balbuk Way public boat ramp at approximately $31^{\circ}57.005$ 'S, $115^{\circ}53.714$ 'E and extending downstream to approximately $31^{\circ}56.899$ 'S, $115^{\circ}53.690$ 'E

This Water Ski Area is open for the towing of a person on water skis, wakeboards and kneeboards only, between the hours of 08:00am to Sunset. The towing of ski tubes and all other inflatable objects is prohibited at all times.

Perth Waters, Swan River

Fremantle WA, 14th January 2022.

Acting pursuant to the powers conferred by Section 67 of the *Western Australian Marine Act 1982*, the Department by this notice limits the speed of motor vessels to 8 knots between 3:00 PM on Wednesday 26th January 2022 until sunrise on Thursday 27th January 2022, in all waters of the Swan River between the Narrows Bridge and the Causeway Bridges; excluding the existing five (5) knot area from the Western most point of Heirisson Island to the Eastern most point of Heirisson Island as published in Notice MA408 of the *Government Gazette* dated 1st October 2013.

The Department also by this notice pursuant to Regulation 10A(b) of the *Navigable Waters Regulations 1958* prohibits Swimming in all waters of the Swan River between the Narrows Bridge and Causeway Bridges, from 3:00 PM on Wednesday 26th January 2022 until Sunrise Thursday 27th January 2022.

Providing however the above swimming closure and speed restriction shall not apply to bona fide vessels or persons involved in approved aquatic events or associated with the Perth Skyworks 2022.
