## Planning and Development (Fees) Amendment Notice 2022

#### SL 2022/105

Made by the Minister under section 20(1) of the Act.

#### 1. Citation

This notice is the *Planning and Development (Fees) Amendment Notice* 2022.

### 2. Commencement

This notice comes into operation as follows —

- (a) clauses 1 and 2 on the day on which this notice is published in the *Gazette*;
- (b) the rest of the notice on 1 July 2022.

### 3. Notice amended

This notice amends the *Planning and Development (Fees) Notice 2021.* 

## 4. Schedule 1 replaced

Delete Schedule 1 and insert:

## Schedule 1 — Fees

## 1. Fees for approval of subdivision (Form 1A)

(1) Application for approval of freehold, survey-strata (freehold or leasehold) or community titles (land) scheme subdivision.

Amalgamation — \$2 496.

Example:

For an application proposing that multiple lots be amalgamated into a single lot, the application fee is \$2 496.

## Subdivision into 2 or more lots (up to and including 100 lots) — \$3 460 and \$78 per lot.

#### Example:

For an application proposing 5 lots, the application fee is \$3 460 plus \$390 (5 lots multiplied by \$78), which totals \$3 850.

## Subdivision into 101 or more lots — \$11 260 and \$27 per lot in excess of 100 lots.

#### Example:

For an application proposing 105 lots, the application fee is \$11 260 plus \$135 (5 lots multiplied by \$27), which totals \$11 395.

(2) Application or contemporaneous applications for approval of amalgamation and subdivision — amalgamation fee does not apply.

## 2. Fees for amended plan for subdivision (Form 2A)

 Amended plan or plans for application for approval of freehold, survey-strata (freehold or leasehold), community titles (land) scheme or community titles (building) scheme subdivision.

#### Amalgamation — \$850.

#### Example:

For amended plans for an application proposing that multiple lots be amalgamated into a single lot, the application fee is \$850.

# Subdivision into 2 or more lots (up to and including 100 lots) — \$1 262 and \$26 per lot.

#### Example

For amended plans for an application proposing 5 lots, the application fee is \$1 262 plus \$130 (5 lots multiplied by \$26), which totals \$1 392.

## Subdivision into 101 or more lots — \$3 862 and \$4 per lot in excess of 100 lots.

#### Example:

For amended plans for an application proposing 105 lots, the application fee is \$3 862 plus \$20 (5 lots multiplied by \$4), which totals \$3 882.

### Note:

Where a minor variation is made at the request of the WAPC, the WAPC may waive some or all of the applicable fee.

(2) Amended plan or plans for application or contemporaneous applications for approval of amalgamation and subdivision — amalgamation fee does not apply.

### 3. Fees for reconsideration of decision (Form 3A)

Request under section 144(1) of the Act to reconsider a refusal or under section 151(1) of the Act to reconsider a condition or conditions.

#### Amalgamation — \$1 154.

#### Example:

For a reconsideration of an application proposing that multiple lots be amalgamated into a single lot, the application fee is \$1 154.

## Subdivision into 2 or more lots (up to and including 100 lots) — \$1 414 and \$31 per lot.

#### Example:

For a reconsideration of an application proposing 5 lots, the application fee is \$1 414 plus \$155 (5 lots multiplied by \$31), which totals \$1 569.

## Subdivision into 101 or more lots — \$4 514 and \$6 per lot in excess of 100 lots.

#### Example:

For a reconsideration of an application proposing 105 lots, the application fee is \$4 514 plus \$30 (5 lots multiplied by \$6), which totals \$4 544.

### 4. Fees for endorsement of plan (Form 1C)

(1) Application for endorsement of a deposited plan, survey-strata (freehold or leasehold) plan or community titles (land) scheme plan.

#### Amalgamation — \$577.

### Example:

For an application for endorsement of a plan proposing that multiple lots be amalgamated into a single lot, the application fee is \$577.

## Subdivision into 2 or more lots (up to and including 100 lots) — \$645 and \$8 per lot.

#### Example:

For an application for endorsement of a plan proposing 5 lots, the application fee is \$645 plus \$40 (5 lots multiplied by \$8), which totals \$685.

## Subdivision into 101 or more lots — \$1 445 and \$5 per lot in excess of 100 lots.

### Example:

For an application for endorsement of a plan proposing 105 lots, the application fee is \$1 445 plus \$25 (5 lots multiplied by \$5), which totals \$1 470.

(2) Application for endorsement of a plan that proposes amalgamation and subdivision — amalgamation fee does not apply.

#### **MEDICINES AND POISONS ACT 2014**

MEDICINES AND POISONS (SECTION 72) NOTICE 2022

Made by the Chief Executive Officer under section 72 of the Medicines and Poisons Act 2014.

#### 1. Citation

This notice may be cited as the Medicines and Poisons (Section 72) Notice 2022.

#### 2. Commencement

This notice comes into operation on the day on which it is published in the *Gazette*.

#### 3. Interpretation

(1) In this notice, unless the context otherwise requires—

 $\textbf{\textit{Agvet Code of WA}} \text{ has the meaning given in the \textit{Medicines and Poisons Act}};$ 

appropriate licence means each of the following-

- (a) a licence granted under Part 4 of the Medicines and Poisons Act; or
- (b) a licence granted under the Agricultural and Veterinary Chemicals Code Act 1994 (Cth); or
- (c) a licence granted under the Agvet Code of Western Australia; or
- (d) a licence granted under the Therapeutic Goods Act 1989 (Cth);

appropriate permit means a permit granted under Part 4 of the Medicines and Poisons Act;

APVMA registered product means a product, registered in accordance with the Agvet Code of WA, and that is under the scheme administered by the Australian Pesticides and Veterinary Medicines Authority (Cth) (APVMA);

licensed pest management technician means a pest management technician who is licensed under the Pesticides Regulations;

Medicines and Poisons Act means the Medicines and Poisons Act 2014;

Medicines and Poisons Regulations means the Medicines and Poisons Regulations 2016;

Pesticides Regulations means the Health (Pesticides) Regulations 2011;

primary producer means a person whose land is used for any or all of the following—

- (a) a commercial agricultural operation but not a forestry, reafforestation or aquaculture operation:
- (b) a grazing, horticultural, viticultural, apicultural, pig-raising or poultry farming operation that is conducted on a commercial basis;

registered label means a label approved under Part 2 of the Agvet Code of WA for an APVMA registered product;

**Schedule** means a Schedule of the Poisons Standard (Cth) (the SUSMP);

Schedule 7 means Schedule 7 of the Poisons Standard (Cth) (the SUSMP) that relates to dangerous poisons that require special precautions during manufacture, handling or use;

Schedule 7 licence holder means a person granted a Schedule 7 retail licence or an indent licence or a wholesaler's/manufacturer's licence that applies to Schedule 7 poisons under the Medicines and Poisons Act;

**SUSMP** means the Standard for the Uniform Scheduling of Medicines and Poisons set out in the current Poisons Standard.

#### 4. Restrictions imposed by this Notice under section 72 of the Medicines and Poisons Act

(1) A Schedule 7 licence holder may only supply a Schedule 7 poison listed in Column 1 of Table 1 consistent with the restrictions set out in Column 2 of the table opposite the specified poison to which the restriction applies;

FIRE HAZARD REDUCTION NOTICE 2022/2023

Notice to All Owners and Occupiers of Land Within the City of Kalamunda

Compliance Due Before: 1 November 2022

Assessments Commence from: 1 November 2022

**Important**: The works outlined below must be completed by 1 November 2022 and maintained in this state up to and including 31 March 2023. Penalties apply for non-compliance. Fines and work orders will be issued from 1 November 2022.

Pursuant to Section 33 of the *Bush Fires Act 1954* (WA), the City of Kalamunda (City) gives written notice to act as specified in this notice to land that you own and/or occupy and with respect to any matter which is upon the land that you own and/or occupy within the City.

Failure or neglect to comply with this notice is an offence and can result in a penalty of up to \$5000. The City's Fire Control Officers are authorized under the *Bush Fires Act 1954* (Act) and have powers to enter land pursuant to Section 14 of the Act. The City advises that its officers, servants, workmen, contractors, vehicles, machinery, and appliances (as the officers deem fit) may carry out the requisitions of this notice that are not complied with by 1 November 2022 and any costs and expenses incurred may be recovered from you as the owner and/or occupier of the land.

## ALL LAND WITH A TOTAL AREA OF 4000m<sup>2</sup> OR MORE

#### • Fire-breaks

Fire-breaks are to be installed or upgrade to: 3-metre-wide bare mineral earth;

4 metre high clearance; Continuous (no dead ends) trafficable as close as possible inside the entire perimeter of the land.

Maintained, reticulated living lawns that are kept completely green is acceptable in conjunction with, or in lieu of, a mineral earth fire break/s (see definition FIRE BREAK).

#### Dead Flammable Material (DFM)

Reduce and/or maintain all dead flammable material below 8 tonne per hectare (see definition FUEL LOAD).

#### • Slashing

Slash, mow, or trim dead grasses, dead shrubs, and dead plants to a height no greater than 50mm.

#### • Asset Protection Zone (APZ)

Maintain a fuel reduced zone around all buildings or assets which extends 20 metres from the outermost point of the building or asset.

- » Gutters, roofs, and walls of all buildings to be free of flammable matter and maintained.
- » Fuel load within the 20-metre zone is reduced and maintained to no more than 2 tonne per hectare.
- » Trees over 5 metres in height within the 20-metre zone to be under pruned up to 2 metres.
- » Trees or shrubs within 2 metres of the asset shall be pruned to a height no greater than 2 metres and/or pruned away from the asset to a distance no greater than 2 metres.

#### ALL LAND WITH A TOTAL AREA LESS THAN 4000m<sup>2</sup>

#### • Dead Flammable Material (DFM)

Reduce and/or maintain all dead flammable material below 8 tonne per hectare (see definition FUEL LOAD).

#### Slashing

Slash, mow, or trim dead grasses, dead shrubs, and dead plants to a height no greater than 50mm.

#### • Clean Gutter Debris

Gutters, roofs, and walls of all buildings to be free of flammable matter and maintained.

#### VARIATION TO THE FIRE HAZARD REDUCTION NOTICE

If you consider it impractical to meet a requirement/s of this Notice, you may apply to the City for a variation no later than 1 October 2021. Note: A variation is not an exemption but an application to employ alternative methods of property preparedness to land that you own and/or occupy. An administration fee of \$150 applies for applications received after 1 October 2021. If your application is not granted you must comply with all requirements outlined in the Fire Hazard Reduction Notice 2022/2023. Variation request application forms are available before 1 October 2022 on the City's website at: www.kalamunda.wa.gov.au/fire

#### **Additional Works**

You may be required to carry out further bushfire property preparedness works on your land to reduce any fire hazards considered necessary by a Fire Officer. If required, these will be outlined in a 'work order' and sent to the address of the owner and/or occupier.

#### **Emergency Management Plans and City Approved Treatment Plans**

All properties and/or land subject to a Bushfire Management Plan, Emergency Management Plan, or an approved Bushfire Attack Level assessment (BAL), as a result of subdivision, development application or a City approved treatment plan, must comply with the listed requirements in their entirety. Compliance with any additional plans does not constitute compliance with this Notice.

#### **Environmental Conditions**

Any property subject to environmental value such as, but not limited to, Threatened Ecological Communities (TEC), Bush Forever sites, Declared Rare Flora and Fauna (DRF) sites and Aboriginal heritage sites etc, should seek further information about what can or cannot be done prior to carrying out requirements under this Notice.

#### DEFINITIONS

#### Fire break

A strip of land free of all flammable material with the intention of minimising the spread or extension of a bushfire and provide safe access on the property for emergency vehicles and other firefighting operations.

- » Clearance must be no less than 3-metres wide and 4-metres in height inside and along all boundaries (including boundaries adjacent to roads, rail and drain reserves and all public open space reserves).
- » Must not be more than 4-metres wide (further width extensions may be considered upon written application for approval to the City).
- » Maintained, reticulated living lawns are lawns considered to be kept completely green. Driveways may be acceptable in conjunction with, or in lieu of, mineral earth fire breaks. Contact a City Fire Officer for further assistance.
- » Must have a corner turning radius of up to 10 metres.
- » Must be a mineral earth break with a continuous trafficable surface for a 4WD vehicle, be clear of any obstructions and must not terminate in a cul-de-sac (dead end).

#### **Fuel Load**

Can be live and dead vegetation that accumulates over time. This Notice refers only to dead vegetation. Fine fuels include = leaf litter, grasses, twigs (up to 6mm diameter), bark etc.

Heavy (course) fuels include = branches, logs, stumps etc.

- » A fuel load depth of 15mm (fine fuels) to the mineral earth is indicative of approximately 8 tonne per hectare. The more fuel load, the higher the flame height and increased fire intensity.
- » Mulch piles, stored firewood and burn piles can contribute to fuel loading on land and must be stored safely away from assets, removed from the property, or actioned as directed by a Fire Officer.
