QUARANTINE AREA REVOCATION NOTICE

Under regulation 61 of the *Biosecurity and Agriculture Management Regulations 2013* (Regulations), the Quarantine Area Notice entitled: Quarantine Area Notice—Perth Metropolitan Local Government Boundaries—Polyphagous Shot-Hole Borer (*Euwallacea fornicatus*) published in the *Government Gazette* on 13 May 2022, and in the West Australian newspaper and on the Department of Primary Industries and Regional Development (DPIRD) website, is revoked and replaced by the following notice.

QUARANTINE AREA NOTICE

Perth Metropolitan Local Government Authority Boundaries

Polyphagous Shot-Hole Borer (*Euwallacea fornicatus*)

- Under regulation 60 of the *Biosecurity and Agriculture Management Regulations 2013* (Regulations) the area within the 21 Local Government Authority boundaries described below is declared to constitute a quarantine area for a period of 12 months following the date of publication.

- The quarantine area is declared because the declared pest Polyphagous Shot Hole Borer, *Euwallacea fornicatus* (PSHB) was present in the area on 3 September 2021 and there are reasonable grounds to suspect the declared pest remains in, or in the vicinity of, the area.
- Persons other than an inspector must not move, or cause or allow to be moved, anything listed in Schedule 1 from a place within the quarantine area to any other place outside the quarantine area except in accordance with—
 - this notice; or
 - an approval under regulation 67 of the Regulations; or
 - a general exemption under regulation 71 of the Regulations.
- A thing referred to in clause 3 (listed in Schedule 1) is moved in accordance with this notice if—
 - it is moved as specified in Schedule 2; or
 - it is moved as authorised or directed by an inspector.
- Each person who is the owner or occupier of land in the quarantine area is taken to have been given a quarantine notice that applies to that land in the terms of this quarantine area notice.
- Failure to comply with this quarantine area notice could result in a fine, the Director General taking remedial action under regulation 133 of the Regulations, or both.

SCHEDULE 1

Wood means wood that is not treated. Treated or seasoned (> 6 months) timber or wood products that are in use for construction, fencing, furniture or packaging and pallets are not considered to be wood and are therefore not considered to be PSHB risk material.

Living plants means any PSHB host plant, organ or plant part (including plant cutting) with woody stems that are greater than 2 cm in diameter. The list of PSHB host plants is published on the Department's website.

Wood machinery means any vehicle, equipment or other mechanical apparatus of any kind that has been used in relation to arboriculture, wood mulching, wood chipping or handling of any other wood.

SCHEDULE 2

Wood may be moved out of the quarantine area if chipped to pieces that are less than 2.5 cm diameter in size.

Wood more than 2.5 cm diameter in size may only be moved out of the quarantine area under an Inspector's Direction.

Living plants with woody stems that are greater than 2 cm in diameter may only be moved out of the quarantine area under an Inspector's Direction.

All **wood machinery** (other than vehicles being used to transport wood in accordance with this notice) must have all wood material removed before moving out of the quarantine area.

Polyphagous Shot-Hole Borer (*Euwallacea fornicatus*)

1. In accordance with regulation 60 of the *Biosecurity and Agriculture Management Regulations 2013* (**Regulations**) a Quarantine Area Notice (**QAN**) entitled: Quarantine Area Notice—Perth Metropolitan Local Government Authority Boundaries—Polyphagous Shot-Hole Borer (*Euwallacea fornicatus*) was published in the *Government Gazette* on 11 November 2022, and in the West Australian newspaper and on the Department of Primary Industries and Regional Development (**DPIRD**) website.
 2. Under regulation 71 of the Regulations, the QAN is subject to the general exemption set out in this notice.
 3. Members of an incorporated association formed for the purpose of horticultural or gardening activities may take wood or living plants (PSHB host material), as defined in Schedule 1 of the QAN, from a place within the quarantine area to a place outside of the quarantine area, under the following conditions—
 - a. the member must first undertake DPIRD online training on Polyphagous Shot-Hole Borer and obtain a certificate of completion. The online training can be found at <https://regtraining.dpird.wa.gov.au/externaluser/course/view.php?id=60>
 - b. all PSHB host material must be examined and found free of signs or symptoms of PSHB infestation by the certified member of the association before being taken outside of the quarantine area.
 - c. any PSHB host material presenting signs or symptoms of PSHB infestation must be immediately reported to DPIRD via the Pest and Disease Information Service (PaDIS; phone 08 9368 3080) and this material must be double bagged and secured until directed by DPIRD.
- Note:** Inspectors authorised under the *Biosecurity and Agriculture Management Act 2007* may conduct inspections from time to time, without notice, to ascertain whether this exemption notice is being complied with.

4. This exemption applies for so long as the QAN remains in force unless this exemption is revoked.

 - b. The wood and living plants are securely transported in a fully sealed and covered skip bin, trailer, or truck.

LG501**BUSH FIRES ACT 1954***Shire of Dandaragan***FIREBREAK AND FUEL HAZARD REDUCTION NOTICE 2022/2023**

Notice to All Owners and Occupiers of Land in the Shire of Dandaragan

As a measure for preventing the outbreak of a bush fire, or for preventing the spread or extension of a bush fire which may occur, all owners and occupiers of land within the Shire of Dandaragan are required before the 1st day of November 2022 to clear firebreaks and take measures in accordance with this Notice and maintain those firebreaks and measures in accordance with this Notice up to and including the 30th April 2023.

DEFINITIONS

- **HABITABLE BUILDINGS**—a dwelling, work place, place of gathering or assembly, and includes any building used for storage or display of goods or produce for sale by wholesale in accordance with classes 1-9 of the Building Code of Australia. The term habitable building includes attached and adjacent structures like garages, carports, verandas or similar roofed structure(s) that are attached to, or within, 6 metres of the dwelling or primary building.
- **INFLAMMABLE MATERIAL**—a substance which is easily set on fire.

RESTRICTED BURNING PERIOD

Burning under a Permit from a Fire Control Officer All Zones 19th September to 31st October and 1st March to 1st April

PROHIBITED BURNING PERIOD

1st November to 28th February—strictly no burning*

*Unless the fire complies with the Shire of Dandaragan Camping and Cooking Fire Policy.

PERMITS

Permits are subject to various conditions including no burning on public holidays, unless approved by the Chief Bush Fire Control Officer.

Prior to any burning you are required to notify your Neighbours, Permitting Officer and one of the two following options—

1) Shire of Dandaragan on 9652 0800.

2) EmergencyWA Burn Registry on 9395 9209—prompt you would like to register your burn, they will ask for your address, contact number and duration of the burn. This will help prevent false alarm calls to 000.

If the burn is to be carried out on any land that is adjoining or adjacent to land that is managed or controlled by the Department of Biodiversity, Conservation and Attractions, their office is to be notified by telephoning 9688 6000.

CAMP FIRES AND COOKING, FIRE BREAK AND FUEL HAZARD VARIATIONS AND MAINTENANCE.

The Shire has introduced a Camping and Cooking Fire Policy that permits you to have a camp or cooking fire at your place of residence subject to the conditions specified in the Policy. Camping and cooking fires are prohibited when the fire danger rating is high or above or a total fire ban is in place.

- No solid fuel fires **OTHER THAN CAMPING OR COOKING FIRES AT YOUR PLACE OF RESIDENCE** are permitted between 1st November and 1st April.
- Only gas or electric barbecues are permitted during **TOTAL FIRE BANS** or when the fire danger rating is above high.

GARDEN REFUSE

- No burning of garden refuse between 1st September and 1st April, unless a permit to burn has been obtained from a Bush Fire Control Officer (restricted times only). During unrestricted times always contact your neighbours and the Shire of Dandaragan (08) 9652 0800 before you light.
- It is free to dispose of green waste at the Shire of Dandaragan waste facilities.

FIREBREAK AND FUEL HAZARD VARIATIONS

If it is impractical to have a firebreak immediately inside a boundary, for environmental or any other reason(s), you are required to apply to the Shire of Dandaragan in writing before 1st October to obtain permission for firebreaks to be installed in an alternative position or for alternative measures to be put in place. Approval is granted for a period of 3 years, after which the landowner must re-apply for a variation to the firebreak notice. Firebreak variation forms can be downloaded from the Shire of Dandaragan website.

NOTICE TO ALL OWNERS AND/OR OCCUPIERS OF LAND IN THE SHIRE OF DANDARAGAN

Notice is hereby given to landowners/occupiers within the Shire of Dandaragan that the requirement of this notice and firebreaks must be installed by 1st November 2022 and maintained clear of inflammable material up to and including 30th April 2023 as per the requirements in relation to Section 33 of the *Bush Fires Act 1954*. Shire Rangers conduct ground and aerial inspections of properties throughout this period. An Authorised Officer may deem further mitigation necessary if the regulations in this notice do not satisfactorily remove or reduce a fire hazard.

URBAN/RESIDENTIAL LAND (All gazetted town sites)

Clear and maintain all inflammable materials on the property so it does not exceed 5 centimetres in height from 1st November 2022 to 30th April 2023.

- Clear a firebreak consisting of mineral earth, to a width of no less than 3 metres, as close as practicable, inside the external boundaries of the property.
- Firebreaks must be maintained to provide a vertical clearance of a minimum 4 metres so as to allow adequate access for fire appliances.
- Clear and maintain a 5 metre mineral earth firebreak immediately surrounding all fuel and chemical storage areas.
- Clear and maintain a 2 metre mineral earth cleared area around all stationary pumps and motors.
- Areas cleared and piled for burning require a 20 metre mineral earth firebreak.
- Clear and maintain a 3 metre mineral earth firebreak around all hay stacks and hay sheds.
- Clear and maintain a 20 metre Building Protection Zone around all habitable buildings.

Tree plantations of more than 3 hectares but less than 10 hectares

Clear and maintain a 10 meter wide mineral earth firebreak with a vertical clearance of 4 meter high, clear of all inflammable material immediately surrounding the plantation (adjacent areas of the same property subject to provisions as for rural areas).

Plantations larger than 10 hectares

Plantations established after 30 November 1984 that exceed 3 hectares in total area shall have a 10 metre wide firebreak completely surrounding the perimeter of planted trees. Each compartment of a plantation is limited to an area of less than 30 hectares in size. Each 30 hectare compartment shall have a 10 metre wide firebreak surrounding the planted trees. Furthermore all plantations shall comply with requirements contained in the Department of Fire and Emergency Services guidelines or standards for Plantation Fire Protection.

HARVEST/MOVEMENT OF VEHICLES, HOT WORKS AND USE OF COMBUSTION ENGINE BANS

A ban on harvesting and the movement of vehicles (except for the watering or movement of stock) is likely to be imposed when the predicted weather conditions are classified by the Bureau of Meteorology as high or above, or when local conditions warrant bans to be applied. All such bans are at the discretion of the Chief Bush Fire Control Officer/Fire Weather Officer.

HARVESTING CONDITIONS

- No harvesting operations are permitted on Christmas Day, Boxing Day and New Year's Day.
- An approved fire fighting appliance is required to be present in any paddock being harvested whilst crop harvesting, straw raking and bailing operations are being carried out during restricted and prohibited periods. The fire fighting unit must be in a state of readiness and have a minimum of 400 litres of water on board. It is recommended that fire fighting units are not mounted on trailers as additional risks are present when towing trailers on a fire ground. The vehicle should also be equipped with UHF radio and carry appropriate personal protective clothing/equipment. UHF Channel 11 is reserved for all fire fighting operations throughout the Shire.

- During any period of restricted or prohibited burning, a person shall not operate any agricultural or earth moving vehicles, unless it is carrying an approved fire extinguisher, as described under Section 3 of the *Bush Fires Regulations 1954*.—Section 3 of the *Bush Fires Regulations 1954*. Fire extinguisher—a device which comprises (a) a container filled with at least 7.5 litres of water; and (b) a pump capable of discharging that water, and which is in a sound and efficient condition.
- It is mandatory for all operators of harvesters to be registered on the Shire of Dandaragan Harvest & Vehicle Movement Ban SMS Notification service. If a ban has been imposed, all persons registered will be sent a text message advising of details. All bans will still be broadcast on ABC radio.
