 - (e) the student commences the course in 2023 or 2024 and —
 - (i) the student is a citizen of Afghanistan and holds a visa of subclass 449; or
 - (ii) the student is a citizen of Ukraine and holds a visa of subclass 449 or 786; or

- (iii) the student —
 - (I) holds a bridging visa that is not subject to condition 8101 set out in the *Migration Regulations 1994* (Commonwealth) Schedule 8; and
 - (II) has received a letter from the Department of State of the Commonwealth assisting in the administration of the *Migration Act 1958* (Commonwealth) acknowledging that the student has made a valid application for a visa of subclass 866;
 - (f) the student commences the course in 2023 and holds a visa of subclass 482 granted on the basis that the student satisfied the secondary criteria for that subclass.
- (1B) In subregulation (1A) a reference to a visa, or to a visa of a particular kind or subclass, is a reference to a visa, or to a visa of that kind or subclass, granted under the *Migration Act 1958* (Commonwealth).

WESTERN AUSTRALIAN MARINE ACT 1982

WAMA—2022—205639

Approval and exemption from compliance with certain speed restrictions for Triple J Tours vessels operating on Lake Kununurra between Diversion Dam and the Lake Argyle Dam

I, **Laurence Adams**, A/Director Waterways Safety Management, Department of Transport (DoT) and delegate of the Chief Executive Officer, acting pursuant to the power in section 115A of the *Western Australian Marine Act 1982* (the Act), **hereby exempt** the following Triple J Tours vessels—

- UVI428232;
- UVI447442;
- UVI441372; and
- UVI447767

from compliance with regulations 48(c), 48(d)(i) and 48(d)(iv) of the *Navigable Waters Regulations 1958* (the Regulations).

In addition, in accordance with regulation 48(a) of the Regulations, I **hereby grant approval** for the above vessels to exceed the speed limit in regulation 48(a).

This exemption is subject to the following conditions—

1. The vessel master only exceeds the speed limit at times when it is expedient and safe to do so, and only to the extent necessary for maintaining the safe navigation of the vessel;
2. The vessel masters carry a copy of this exemption or produce it to DoT as soon as possible upon request; and
3. All aspects of Triple J Tours speed exemption risk matrix are adhered to.

All other applicable legislation including the *Prevention of Collisions at Sea Regulations 1983* must be complied with.

This instrument is to be known as WAMA—2022—205639 and is valid from 23 November 2022 until 1 August 2023 inclusive unless revoked sooner.

WESTERN AUSTRALIAN MARINE ACT 1982

(WAMA—2022—204993)

Exemption for jet karts from compliance with various provisions of the *Navigable Waters Regulations 1958*

I, **Laurence Adams**, acting Director Waterways Safety Management, Department of Transport and delegate of the Chief Executive Officer, acting pursuant to the power in section 115A of the *Western Australian Marine Act 1982*, **exempt** jet karts from compliance with—

- regulations 51D, 52, 52A, and 52C of the *Navigable Waters Regulations 1958* (the Regulations); and
- subregulation 52B(1) of the Regulations when operating within 400m of any shore.

This exemption is subject to the following conditions—

1. the driver of a jet kart wears an appropriate lifejacket, as defined in regulation 50B of the Regulations; and
2. the jet kart carries a means of bailing out water.

The term ‘jet kart’ means a personal watercraft, modified temporarily or permanently so as to be operated by a person within it rather than on it.

This exemption is valid for two years from the date it is signed unless revoked sooner.

INSTRUMENT OF EXTENSION OF TERM OF EXEMPTION OF LAND
