GAS STANDARDS ACT 1972

GAS STANDARDS PROHIBITION ORDER (No.5) 2022—JACKEROO PORTABLE REFRIGERATOR Made by the Director of Energy Safety under section 13H of the *Gas Standards Act 1972*.

1. Citation

This order is the Gas Standards Prohibition Order (No.5) 2022.

2. Commencement

This order comes into operation as follows—

- (a) clauses 1 and 2—on the day on which this order is published in the Gazette; and
- (b) the rest of the order—on the day after that day.

3. Terms used

In this order-

Act means the Gas Standards Act 1972;

DES means the Director of Energy Safety, established under the Energy Coordination Act 1994;

Jackaroo portable refrigerator means the portable three-way refrigerator, branded 'Jackaroo', identified as model number J3PR35L and manufactured between 1 January 2010 and 31 December 2010; and

Sale includes second-hand sales.

4. Prohibition

Having formed the opinion that the Jackaroo portable refrigerator is likely to become unsafe or dangerous, the DES hereby prohibits its sale in Western Australia. This prohibition does not apply where sale is to an officer of the Department of Mines, Industry Regulation and Safety, who is purchasing it for the purpose of testing, validation and/or disposal.
