Made by the Governor in Executive Council.

1. Citation

This order is the *Local Government (Kent) Transitional Order* 2023.

2. Commencement

This order comes into operation as follows —

- (a) clauses 1 and 2 on the day on which this order is published in the *Gazette*;
- (b) the rest of the order on the day after that day.

3. Terms used

(1) In this order —

commencement day means the day on which clause 4 comes into operation;

next election means the ordinary election for the Shire of Kent for which next election day is the ordinary election day;

next election day means the first ordinary election day for the Shire of Kent that falls after commencement day.

(2) If a term used in this order is given a meaning in Schedule 9.3 clause 59(1) of the Act, it has the same meaning in this order.

Local Government (Kent) Transitional Order 2023

4. Change in number of councillors

For the purposes of Schedule 9.3 clause 59(4) of the Act, on and from next election day, the number of offices of councillor that the council of the Shire of Kent is to have is 6.

Note for this clause:

The effect of this clause is to decrease on next election day the number of offices of councillor that the council of the Shire of Kent is to have from 8 to 6.

- (1) This clause applies for the purpose of giving effect to clause 4.
- (2) Part 4 of the Act applies to preparing for and conducting the next election as if the decrease in the number of offices of councillor takes effect on commencement day.
- (3) The next election is to be for 3 offices of councillor for terms ending in 2027.
- (4) There is to be no election to fill the office of councillor that became vacant in February 2023.
- (5) The operation of the Act is modified to the extent necessary for the purposes of subclauses (2) to (4).

This order is the *Local Government (Kondinin) Change Order* 2023.

2. Commencement

This order comes into operation as follows —

- (a) clauses 1 and 2 on the day on which this order is published in the *Gazette*;
- (b) the rest of the order on the day after that day.

3. Terms used

(1) In this order —

commencement day means the day on which clause 4 comes into operation;

next election day means the first ordinary election day for the Shire of Kondinin that falls after commencement day;

ordinary election means an ordinary election for the Shire of Kondinin;

subsequent election day means the first ordinary election day for the Shire of Kondinin that falls after next election day.

(2) If a term used in this order is given a meaning in section 2.16A of the Act, it has the same meaning in this order.
