RETAIL TRADING HOURS (CITY OF ALBANY) CHRISTMAS AND PUBLIC HOLIDAY VARIATION ORDER 2023

1. Citation

This order is the Retail Trading Hours (City of Albany) Christmas and Public Holiday Variation Order 2023.

2. Commencement

This order comes into operation as follows-

3. Variation of retail trading hours during Christmas 2023

AMENDMENT LOCAL LAW 2023

Under the powers conferred by the *Local Government Act 1995*, the *Bush Fires Act 1954*, the *Dog Act 1976* and all other powers enabling it, the Council of the Shire of Kondinin resolved on 20 September 2023 to adopt the following local law.

1. Citation

This local law may be cited as the Shire of Kondinin Amendment Local Law 2023.

2. Commencement

This local law comes into operation 14 days after the date of its publication in the Government Gazette.

3. Bush Fire Brigades Local Law 2022 amended

The $Shire\ of\ Kondinin\ Bush\ Fire\ Brigades\ Local\ Law\ 2022$ published in the $Government\ Gazette$ on $10\ November\ 2022$ is amended as follows—

- (a) delete clause 7(2)(e);
- (b) delete clause 8; and
- (c) delete clause 9.

4. Dogs Local Law 2022 amended

The $Shire\ of\ Kondinin\ Dogs\ Local\ Law\ 2022$ published in the $Government\ Gazette$ on 10 November 2022 is amended as follows—

- (a) in clause 3.3(3)(a)(iii) replace the full stop with a semi-colon; and
- (b) in clause 7.2(2) replace the reference "5.1(2)" with the reference "6.2(2)".

5. Public Places and Local Government Property Local Law 2022 amended

The Shire of Kondinin Public Places and Local Government Property Local Law 2022 published in the Government Gazette on 10 November 2022 is amended as follows—

- (a) in clause 2.7—
 - (i) in subclause (1)(g)(iii) after the semi colon insert the word "and";
 - (ii) in subclause (1)(h) replace "; and" with a full stop; and
 - (iii) delete subclause (1)(i);
- (b) in clause 4.8(b) after the word "dog" insert the words "or cat";
- (c) in clause 7.2(2)(a) after the word "animal" insert the words ", other than a cat,";
- (d) in clause 9.2 after the word "thoroughfare" in the opening line delete the word "or";
- (e) in clause 9.5 delete subclauses (b) and (c) and insert-
 - (b) if the value of the property is reasonably believed to have a realisable value more than 1% of the amount prescribed by regulation 30(3) of the *Local Government (Functions and General) Regulations 1996* but not exceeding the amount prescribed, by handing the property to the Western Australian Police Force; or
 - (c) if the property is reasonably believed to be of less value than that in subclause (b)—
 - (i) by donation to a not for profit body incorporated under the Associations Incorporations Act 2015; or
 - (ii) if likely to be of no interest to a not for profit body, in any manner he or she thinks fit.
- (f) in clause 11.3(2)(b) delete the words "do the"; and

(g) in Schedule 1 Item 34, delete "5.8(f)" and insert "6.8(f)".

BUSH FIRES ACT 1954

City of Vincent

Important Notice to All Owners and/or Occupiers of Land Within the City of Vincent

Please help us keep Vincent fire safe this season.

Pursuant to the powers conferred in Section 33 of the *Bush Fires Act 1954* Western Australia, you are required on or before the 31st day of October 2023, and thereafter up to and including the 30th day of April 2024, to clear inflammable matter on land owned and/or occupied by you in accordance with the following requirements—

- 1. All land which is 2000m² or less in area—
 - Remove inflammable matter from the whole of the land, except living trees and shrubs; plants under cultivation and lawn, by means of ploughing, cultivating or slashing to a height of no more than 50mm.
- 2. All other land within the City of Vincent exceeding 2000m² (larger than average residential block size)
 - (i) Firebreaks of a minimum width and height of 3 metres are to be cleared immediately inside all external boundaries of the land;
 - (ii) Firebreaks to a minimum width of 3 metres and height of 3 metres are to be cleared immediately surrounding all buildings situated on the land; and any place where inflammable liquids and gas products are kept.

In addition to the requirements in this notice, the City may, by notice in writing, require an owner and/or occupier to act as and when specified in the notice with respect to anything which is upon land and which in the opinion of the City is or is likely to be conducive to the outbreak of a bush fire or the spread or extension of a bush fire.

The term "Inflammable Matter" for the purpose of this notice includes bush (as defined in the *Bush Fires Act 1954*), timber, boxes, cartons, paper, rubbish and any other combustible or inflammable matter, but does not include buildings, green standing trees and bushes or growing bushes or plants in gardens or lawns.

All land within the City of Vincent must be cleared on or before the 31st day of October in any year and thereafter maintained clear of inflammable matter up to and including the 30th day of April in the following year.

If, for any reason, an owner and/or occupier considers it impractical to clear the land or comply with other fire protection measures in accordance with the notice, the owner and/or occupier may apply in writing to the City no later than the 31st day of October in any year for a variation. If permission is not granted in writing by the City or its authorised officer, the owner and/or occupier must comply with the requirements of this notice. Any variation granted by the City will apply only for a single Firebreak Period. A variation granted by the City shall only remain in force until the 30th day of April in the following year.

The penalty for failing to comply with this notice is a fine of not more than \$5,000.00 and a person in default is also liable, whether prosecuted or not, to pay the cost of performing the work directed in this notice if it is not carried out by the owner or occupier by the date required by this notice.

Pursuant to Sections 24G(2) and 25(1a) of the *Bush Fires Act 1954*, the burning of garden refuse and lighting of fires in the open air is prohibited within the districts of the City of Vincent between the 31st day of October 2023 and the 30th day of April 2024.

Prior to undertaking any earthworks or development of the land, the landowners shall demonstrate to the satisfaction of the City, Department of Health and the WAPC that primary production or filling has not occurred on the subject land, or, undertake a Soil Contamination Assessment of the land, at the landowner's cost to determine the presence or absence of soil contamination to the satisfaction of DWER. The Soil Contamination Assessment should
 - i. be in accordance with National Environmental Protection (Assessment of Site Contamination) Measure guidelines;
 - ii. reviewed by an independent Contaminated Sites Auditor in accordance with *Contaminated Sites Regulations 2006* reg 31(1).
 - iii. take into consideration—
 - · Buried waste.
 - Asbestos containing material.
 - Groundwater contamination.
 - e. Should any soil contamination be identified in the soil contamination assessment, a Site Remediation and Validation Report for the subject land shall be prepared in accordance with legislative and regulatory requirements at the landowner's cost by the developer/subdivider and remediation works shall be undertaken at the landowner's cost for all identified contamination and should be validated as being free of contamination above acceptance guidelines to the satisfaction of the DWER, prior to undertaking any earthworks or development of the land.
 - f. An Urban Water Management Plan, consistent with the approved Local Water Management Strategy and prepared in consultation with the Department of Water and Environmental Regulation to the satisfaction of the City of Armadale, will specify site drainage and fill details to prevent adverse impacts on significant wetlands or groundwater dependent ecosystems, either within or surrounding the amendment area.
 - g. A fauna management plan, prepared to the satisfaction of the City of Armadale, which specifies measures to avoid impacts to significant fauna including—

- e. Modify Special Control Area Map 1 to remove the entire Poultry Farm Buffer over all properties; and

General description

The Minister for Planning has granted approval to the declaration of a Planning Control Area (PCA) over portion of Whiteman Yanchep Highway (from Gnangara Road to north of Neaves Road) and the extension of Flynn Drive to Neaves Road as shown on Western Australian Planning Commission (WAPC) plans number 1.8023, 1.8024, 1.8025 and 1.8026.

Purpose of the Planning Control Area

The purpose of the PCA is to protect lands required for the future Whiteman Yanchep Highway and Flynn Drive extension. The WAPC considers that the PCA is required over properties to ensure that no development occurs on this land which may prejudice this purpose until it may be reserved as Primary Regional Roads in the Metropolitan Region Scheme (MRS).

Duration and Effects

The declaration remains in effect for a period of five years from the date of publication of this notice in the *Government Gazette* or until revoked by the WAPC with approval by the Minister, whichever is the sooner

A person shall not commence and carry out development in a PCA without the prior approval of the WAPC. The penalty for failure to comply with this requirement is \$200,000 and, in the case of a continuing offence, a further fine of \$25,000 for each day during which the offence continues.

Compensation is payable in respect of land injuriously affected by this declaration, and land so affected may be acquired by the WAPC in the same circumstances and in the same manner as if the land had been reserved in the MRS for a public purpose.
