GAS STANDARDS ACT 1972 GAS STANDARDS PROHIBITION ORDER 2023

Made by the Director of Energy Safety under section 13H of the *Gas Standards Act 1972*.

1. Citation

This order is the *Gas Standards Prohibition Order 2023*.

2. Commencement

This order comes into operation as follows—

- (a) clauses 1 and 2—on the day on which this order is published in the *Gazette*; and
- (b) the rest of the order—on the day after that day.

3. Terms used

In this order—

gas cylinder valve means the component of a gas cylinder which controls the release of gas from a gas cylinder and to which a supply hose for installation or appliance is connected.

valve outlet means the part of a gas cylinder valve which is designed to mate with a valve connection.

valve connection means a fitting on a supply hose for an installation or appliance designed to mate with a valve outlet.

Type 21 valve outlet means a valve outlet of the type detailed in Figure 2.6 of AS 2473.2.

Type 27 valve outlet means a valve outlet of the type detailed in Figure 2.12 of AS 2473.2.

AS 2473.2 means the standard published by Standards Australia Limited, titled 'Valves for compressed gas cylinders—Part 2: Outlet connections (threaded) and stem (inlet) threads', utilising the designation 'AS 2473.2:2015' and includes the 2020 amendment to this standard.

Adaptor means a fitting which—

- sits between a valve outlet and a valve connection; and
- is designed to allow a valve connection, which is designed for mating with a Type 27 valve outlet, to instead be mated to a Type 21 valve outlet.

4. Prohibition

Having formed the opinion that adaptors are unsafe, I hereby prohibit their sale, hire and use in Western Australia.
