#### Chapter 16—Priority Projects

#### Minister may make determinations

- 16.1 The Minister may determine that a project is a *priority project* for the purposes of the provisions of the Code.
- 16.2 The Minister must publish a determination made under section 16.1 in the Gazette.
- 16.3 At the time of *publishing* a *priority project determination* the Minister must also *publish* the *reasons* for the *priority project determination*, including the basis on which the Minister considers that the *priority project determination* meets the *Code objective*.
- 16.4 The Electricity Networks Access Code 2004 Priority Project Determination (North Region Energy Project Stage 1) 2023 continues as if made under this Chapter 16.
