BIOSECURITY AND AGRICULTURE MANAGEMENT (DECLARED PESTS) DECLARATION (NO 3) 2024 Made by the Minister for Agriculture and Food under section 22 of the *Biosecurity and Agriculture Management Act 2007* (Act) and regulation 7 of the *Biosecurity and Agriculture Management Regulations 2013* (Regulations).

#### 1. Citation

This declaration is the Biosecurity and Agriculture Management (Declared Pests) Declaration (No 3) 2024.

#### 2. Declared Pest

- (1) Japanese Encephalitis virus (JEv) is—
  - (a) declared under section 22(2) of the Act to be a declared pest;
  - (b) assigned under section 22(3) of the Act and regulation 7(1)(c) of the Regulations to the control category Category 3 (C3)—Management; and
  - (c) assigned under section 22(3) of the Act and regulation 7(2)(a) of the Regulations to the keeping category *Prohibited keeping*,

for the whole of the State.

(2) All previous declarations under the Act and Regulations, in so far as they apply to Japanese Encephalitis virus, including the following declaration, are revoked: the Biosecurity and Agriculture Management (Prohibited Organisms) Declaration 2013 made by the Minister for Agriculture and Food under section 12 of the Act and regulation 8 of the Regulations on 29 April 2013, notice of which was published in the Gazette on 7 May 2013, in so far as it applies to Japanese Encephalitis virus.

'Means a building or building(s) located on a rural landholding, which are used for accommodating seasonal, temporary or migratory workers employed for agricultural/horticulture activities in the district and is to be incidental to the agricultural use of that land'.

(b) Amend clause 5.34.2.7 relating to Rural Workers Accommodation, to remove the words 'for short-stay purposes', resulting in the clause reading as follows—

Where, on a property which has been developed for intensive agricultural purposes, it can be demonstrated to the satisfaction of the local government that a demand exists for the provision of rural workers' accommodation for transitory or seasonal workers on the holding, the local government may approve proposals for such accommodation on the basis that it will be used to accommodate workers employed for agricultural/horticulture activities in the district.'
