GAS STANDARDS ACT 1972

GAS STANDARDS PROHIBITION ORDER 2025

Made by the Director of Energy Safety under section 13H of the *Gas Standards Act 1972*.

1. Citation

This order is the *Gas Standards Prohibition Order 2025*.

2. Commencement

This order comes into operation on the day following its publication in the *Government Gazette* (noting the deferred signage and labelling requirements).

3. Terms used

In this order—

Appliance connection means the fitting on the end of a hose for a gas appliance or installation which is designed to be connected to a valve outlet to enable the supply of gas to the appliance or installation.

Gas cylinder means a container falling within the scope of AS 2030.1, with an internal water capacity of between 11 litres (commonly referred to as a 4.5 kilogram cylinder) and 22 litres (commonly referred to as a 9 kilogram cylinder).

Gas cylinder collar means the fitting attached to or forming part of the gas cylinder for the purpose of protecting the gas cylinder valve from physical damage.

Gas cylinder collar opening means the opening in the gas cylinder collar intended to enable the connection of an appliance connection to a valve outlet.

Gas cylinder valve means the gas cylinder component which controls the release of gas from a gas cylinder.

LPG gas cylinder means a gas cylinder designed for the storage and transportation of liquified petroleum gas under pressure and which has been filled with liquified petroleum gas for the purpose of supply to a consumer.

Valve outlet means the part of a gas cylinder valve which is designed to connect to an appliance connection.

Type 21 valve means a gas cylinder valve with a valve outlet of the type detailed in Figure 2.6 of AS 2473.2 (commonly referred to as a 'POL valve').

Type 27 valve means a gas cylinder valve with a valve outlet of the type detailed in Figure 2.12 of AS 2473.2 (commonly referred to as a 'LCC27 valve').

Type 27 appliance connection means an appliance connection designed to be connected to a type 27 valve but not a type 21 valve.

4. Prohibition

Having formed the opinion that LPG gas cylinders, fitted with type 21 valves, are or are likely to become unsafe or dangerous when consumers attempt to connect them to gas appliances or installations, through use of type 27 appliance connections, I hereby prohibit the sale and hire of LPG gas cylinders, fitted with type 21 valves, other than where the signage and labelling requirements of this order have been complied with.


5. Site signage

From 15 June 2025, any person selling or hiring LPG gas cylinders, fitted with type 21 valves, is to have compliant signage displayed at any site where they sell or hire such cylinders to consumers.

Subject to clause 7 of this order, for signage to be compliant it must—

- (a) be placed in a conspicuous manner on or in immediate proximity to, and not more than two metres from, any cage, locker or other place on the site where such cylinders are stored; and
- (b) incorporate the graphic set out below at Figure 1. This graphic must be no smaller than A4 size (297 millimetres by 210 millimetres).


6. Cylinder labelling

From 15 September 2025, any person selling or hiring LPG gas cylinders, fitted with type 21 valves, to consumers must have compliant labelling placed on the cylinders.

Subject to clause 7 of this order, for labelling to be compliant it must—

- (a) be fixed to the cylinder, span the gas cylinder collar opening and be positioned in a manner that necessitates removal of the label by a consumer for the consumer to connect the cylinder to a gas appliance or installation; and
- (b) incorporate the graphic set out below at Figure 2. The graphic must be not smaller than 24cm x 5cm.

Figure 2—Default graphic for cylinder labelling

7. Alternative signage and/or labelling

A person who sells or hires LPG gas cylinders, fitted with type 21 valves, may apply to the Director of Energy Safety for approval to use alternative signage and/or labelling.

Approval of alternative signage and/or labelling is at the absolute discretion of the Director of Energy Safety.

An application to use alternative signage and/or labelling is to be addressed to the Director of Energy Safety and sent by email to Gas.Supplier@demirs.wa.gov.au with the subject ‘application to use alternative LPG gas cylinder signage and/or labelling’.

The Director of Energy Safety shall promptly send a return email acknowledging the receipt of an application. The Director of Energy Safety shall approve or reject an application within 10 business days of acknowledging its receipt. Where the Director of Energy Safety fails to approve or reject an application within 10 business days, the application is deemed to be approved.

Where alternative signage and/or labelling is approved for use, it must be used in accordance with the terms of the approval for the purpose of satisfying the signage and/or labelling requirements of clauses 5 and/or 6 of this order.
