BIOSECURITY AND AGRICULTURE MANAGEMENT ACT 2007

NOTICE UNDER SECTION 130(1)

Under section 130(1) of the *Biosecurity and Agriculture Management Act 2007*, I determine rates chargeable on land in the prescribed areas for the financial year commencing on 1 July 2025 as follows—

- (a) 7.12 cents in the dollar on the unimproved value of land held under pastoral leasehold in the local government districts of Carnarvon, Exmouth, Greater Geraldton, Murchison, Upper Gascoyne, Northampton and Shark Bay;
- (b) 8.756 cents in the dollar on the unimproved value of land held under pastoral leasehold in the local government districts of Coolgardie, Dundas, Kalgoorlie-Boulder, Laverton, Leonora, Menzies, Ngaanyatjarraku, Sandstone, Wiluna and Yilgarn;

- (d) 7.0482 cents in the dollar on the unimproved value of the land held under pastoral leasehold in the local government districts of Cue, Meekatharra, Mount Magnet, Mount Marshall, Perenjori and Yalgoo;
- (e) 2.571 cents in the dollar on the unimproved value of land held under pastoral leasehold in the local government districts of Ashburton, East Pilbara, Karratha and Port Hedland;
- (f) 0.04032 cents in the dollar on the unimproved value of freehold land in the local government districts of Dalwallinu, Koorda, Morawa and Perenjori, that is no less than 100 hectares in area with a minimum rate payable amount of \$91;
- (g) 0.00542 cents in the dollar on the unimproved value of freehold land in the local government districts of Carnamah, Coorow, Dandaragan, Mingenew, Moora, Irwin and Three Springs, that is no less than 100 hectares in area with a minimum rate payable amount of \$104.50;
- (h) 0.0280 cents in the dollar on the unimproved value of freehold land in the local government districts of Chapman Valley, Greater Geraldton and Northampton, that is no less than 100 hectares in area with a minimum rate payable amount of \$80;
- (i) a flat rate on freehold land in the local government districts of Boyup Brook, Bridgetown-Greenbushes, Donnybrook-Balingup (in the localities of Balingup, Mullalyup, Grimwade, Southampton, and Wilga West) and West Arthur, that is
 - i. a fixed sum of \$50 on freehold land on the rural valuation roll maintained under the $Valuation\ of\ Land\ Act\ 1978$
 - ii. a fixed sum of \$40 on freehold land within a town-site described as urban residential or urban farming or urban vacant or urban miscellaneous on the urban valuation roll maintained under *Valuation of Land Act 1978*;
- (j) a flat rate (fixed sum) on freehold land in the local government district of Esperance that is no less than 100 hectares in size as follows:

- (l) a flat rate (fixed sum) on freehold land in the local government district of Ravensthorpe that is described as urban farming or urban residential or urban vacant or urban miscellaneous on the non-rural and on the rural valuation rolls maintained under the *Valuation of Land Act 1978* as follows:

EXEMPTION FROM THE APPLICATION OF CERTAIN SPEED RESTRICTIONS FOR ROTTNEST FAST FERRIES VESSELS

WAMA-2025—207793

- I, Peter Beattie, A/Director Waterways Safety Management, Department of Transport (DoT) and delegate of the Chief Executive Officer, acting pursuant to the power in section 115A of the *Western Australian Marine Act 1982* (the Act), hereby exempt the Master of the Rottnest Fast Ferries vessels MV Harbour Master UVI 443404 and MV Ocean Master UVI 463969 from compliance with—
 - Regulation 48(a) of the Navigable Waters Regulations 1958;
 - The speed restriction notice MA402 for Hillarys Boat Harbour made under section 67 of the Act and published in the *Government Gazette* on 13 December 2019; and
 - The speed restriction notice MA405 for North Metropolitan Beaches made under section 67 of the Act and published in the *Government Gazette* on 7 January 2022.

This exemption is subject to the following conditions—

- 1. The vessels do not exceed a speed of 8 knots while they are in the area covered by the speed restriction notice for Hillarys Boat Harbour;
- 2. The vessels do not exceed a speed of 12 knots while they are in the area covered by the speed restriction notice for North Metropolitan Beaches;
- 3. The vessels make the sound signals described in rule 34(a) of the *Prevention of Collisions in State Waters Regulations 1983* (the Regulations) when they depart their berth at Hillarys Boat Harbour:
- 4. The vessels make the sound signals described in rule 34(e) of the Regulations when they enter or exit Hillarys Boat Harbour;
- 5. The vessels display a flashing orange light, visible from all sides while they are inside Hillarys Boat Harbour; and
- 6. The vessel Masters adhere to all aspects of the Rottnest Fast Ferries Safety Management System.

This instrument is to be known as WAMA-2025-207793 and is valid from the date of signing until 1 August 2027 unless revoked sooner.

This instrument revokes the instrument WAMA-2023-206072.
