*To the Honourable Robert Bruce Burnside, Greeting:*

WHEREAS it is desirable that a Royal Commission should be appointed to inquire into the conditions prevailing in the firewood industry on certain goldfields: Now therefore I, the said Sir William Grey Ellison-Macartney, Governor as aforesaid, acting with the advice and consent of the Executive Council, do by these presents appoint you, the said Honourable Robert Bruce Burnside, a Commissioner to inquire into and report to me upon:—

1. The cost of living to the workers in the firewood industry on the Coolgardie, East Coolgardie, North-East Coolgardie, Dundas, and Yilgarn Goldfields; and the method by which they obtain their supplies.

2. The earning of such workers.

3. The cost to the firewood companies engaged in such industry of the firewood sold by them for mining purposes.

4. The profits of such firewood companies—

(a) on the sale of firewood;

(b) on the sale of commodities to their employees.

5. The capital invested in such industry by each firewood company.

6. The cost and distance of haulage of firewood to the mines.

7. Generally upon the conditions prevailing in the said industry.

And I declare this Commission to be a Royal Commission within the meaning of the Royal Commissioners' Powers Act, 1902; and I do hereby desire and request that you do, as soon as the same can conveniently be done, report to me in writing your proceedings and the results of your inquiries, and also your recommendations by virtue of this Commission.
