PCOCLAMATION.

By His Excellency Sir James Stirling, Knt., Governor and Commander in-Chief of the Colony of Western Australia and its Dependencies, and Vice-Admiral of the same.

HEREAS, by the first Section of the Act of Council No. 1, passed in the sixth year of the Reign of William the Fourth, intituled "An Act to amend an Act for establishing a Court of Civil Judicature," it is enacted, that from and after the first day of May next, it shall not be lawful for any Person to act as an Agent or Practitioner in the said Court, without having first obtained from the Commissioner of the said Court a Certificate, and without having paid to the Collector of Revenue, as an Annual License Fee, to act as such recognised Practitioner, such a Sum as shall be appointed by the Governor, or other Person administering the Government of the Colony, by his Proclamation issued from time to time for that purpose, and without having had such Certificate, with the Receipt of the Collector of Revenue for such License Fee acknowledged thereon, enrolled in the Office of the Registrar of the Civil Court:—Now know ye that I, therefore, the Governor, do hereby, by this my Proclamation, pursuant to the Provisions of the said Enactment, appoint the following Annual Fees to be paid in the several cases hereunder-mentioned, viz.:-

For every Person who shall have been duly admitted as a Solicitor or Attorney of any of the Superior Courts of Great Britain or Ireland, the Sum of Two Pounds.

For every Person who shall have been admitted, or who shall have practised for the space of three years or upwards, in any Local, Provincial, or Colonial Court, the Sum of Four Pounds.

For every Person without such previous Qualifications, the Sum of Six Pounds.

All such Licenses so issued to continue in force until the first day of March in each year, except in cases referred to in the said Act. GOD SAVE THE KING!!!
