IS Excellency the Governor directs it to be notified, that His Majesty has been pleased to appoint MAJOR IRWIN, K. H., "Permanent Commandant of the Troops in Western Australia."

So long connected as MAJOR IRWIN has been with this Settlement, and in a manner no less creditable to himself than beneficial to the Colony, His Excellency is persuaded that the announcement of this Appointment will be received with great satisfaction.

On the occasion of CAPTAIN ARM-STRONG'S relinquishment of the Command, and of his retirement from the Executive and Legislative Councils, the Governor feels it due to that Officer to express, in the most public manner, his acknowledgments for the anxious desire which has at all times been evinced by him to forward the Interests of the Settlers; and His Excellency avails himself of this opportunity to assure CAPTAIN ARMSTRONG of the pleasure with which he must ever look back to the period of their co-operation in furtherance of His Majesty's Service.

3.—A new and more direct Road between Perth and Fremantle to be opened, 15 feet wide, by rooting out and clearing away all Trees in the line less than 15 inches in diameter, and removing to the Road-side all Brushwood, fallen Timber, Stumps, and other Impediments.


