LANDS ON THE ISLAND OF ROTTNEST.

HE Local Government having considered it expedient to convert the Island of Rottnest

into an Establishment for the Aborigines, all persons claiming an interest in any Lands whatsoever on that Island are hereby required to come forward and substantiate their Claims on or before the first day of July next, as on that day all Lands so situated will be resumed by the Crown, if not improved to the extent required by the Regulations. The Local Government, however, will be willing to grant an Allotment in Fee-Simple on the main land for every similar lot on Rottnest to which a valid claim shall be made good, as above-mentioned.
