IS Excellency the Governor has been pleased to direct the following report of the Harbour Master of Fremantle, of the late disasters to the shipping, to be published for general information :----

"In compliance with instructions dated the 2d instant, I beg to state the following particulars for his Excellency's information :---

"On the morning of the 22d September, at about 1 o'clock, it came on to blow a sudden gale of wind from the north-At about 3 o'clock I got up and west. called my men, and while in the act of doing so, the people on board the Caledonia fired a gun, when I could see by the flash that she had drifted. By this time the Shepherd was on shore where she now lies. Finding the *Caledonia* was still drifting, I immediately collected a boat's crew, and with great difficulty got on board her, where I found both anchors down, and the cables end for end. I ordered her stream anchor and cable to be let go, which was done, and with the assistance of my own men, had the top-gallant yards and masts sent down, and her top-masts She then hung on, and did not struck. drift any further on to the banks, although she occasionally struck; but on sounding, her, and went on board the brig Fox, as He informed me that he had come | I perceived she was driving during every squall, and did not understand the signals While we were talking, I top-gallant and top-masts. It was with Shepherd, over the hill, that she had also though in a whale-boat with six good

hands. The people on board the Fox informed me they could not strike the masts, and had carried away nearly every block in the ship. I went into the hold and found a top block, and with the assistance of my men we succeeded in striking the top-masts, and sent her topgallant masts down on deck. She then hung on, and did not drive any further.

"The above vessels were anchored in the usual anchorage, distant one mile from the shore, in 4½ and 5 fathoms water. At about 9 o'clock in the evening previous I examined my glass, just previous to my retiring for the night, as was my usual practice when there were any vessels in the roads, at which time it did not indicate any bad weather.

"The *Elizabeth* schooner was endeavouring to return to the anchorage, after having been at sea 24 hours; but in consequence of the gale carrying away all her sails, she could not weather the north beach, which was a dead lee shore, and was in consequence totally wrecked.

"With respect to the barque Lancier, I have only to state, that about 9 o'clock on the morning of Saturday last, I was informed that there was a ship in sight, which was supposed by some to be H.M. S. Beagle, and by others she was taken for some man-of-war that had surveyed the coast, as no other vessel would be where she was seen. I immediately sent for a boat's crew for my whale-boat, and just as I was putting off the report came that she was on shore on the Stragglers. I put off to her as quickly as possible, and succeeded in taking four of the crew off the wreck, having previously met the jolly-boat, with persons in her, who informed me they had left them on the wreck, and that the vessel was breaking up fast.

"The *Caledonia* was got off the shore on Thursday last; she has, by the orders of the surveyors, discharged her cargo, and proceeded to Garden Island to be hove down. I expect the *Shepherd* will be got off to-night, with but little damage."

IS Excellency the Governor directs it to be notified for general information, that at the

next Sitting of the Legislative Council on Tuesday, the 15th Instant, a "Bill to regulate the Licensing of Auctioneers, and the Collection of Duties on Property sold by Auction," will be submitted, of which the following are the heads :--

- . Auctioneers are required to take out a License,
- 2. Manner of applying for a License, and Sureties to be given by persons obtaining a License.
- 3. License to be renewed every year.
- A duty of per Cent. on Proceeds of all Sales by Auction.
- 5. The above Duty a Charge upon the Auctioneer from the closing of the Bidding at every Sale.
- 6. Account of all Sales to be rendered within days. Auctioneers authorized to retain the above Duty from the Proceeds of Sale. To make declaration of the truth of his Account. In case of Judgment being had against an Auctioneer, his License shall become void. Exception.
- 7. If Sales by Auction are rendered null and void, the Duty paid thereon is to be returned.
- 8. In case the Owner of any Goods shall become the Purchaser, an allowance of the Duty arising by this Act will be made.
- 9. This Act not to extend to Goods sold by order of Court; of Collector of Revenue, or distrained for Rent.
- 10. This Act not to extend to any Sales for the benefit of Creditors; of Ships condemned as prizes; of Ships wrecked; or of Ships foundered at sea.
- 11. Mode of rendering the Accounts of Sales made under the authority of the Sheriff, or by order of any Court. Penalty — Pounds. Any Sum above £20 to be recovered by Action at Law, and any Sum not exceeding £20 before two or more Justices. All Fines, Penalties and Forfeitures, to be paid half to the Colonial Fund, and half to the person informing or suing for the same.
