RELIGIOUS ESTABLISHMENTS. IIS Excellency the Governor, with the advice of the Executive Council, has been pleased to establish the following Regulations, under which issues will be made from the Colonial Treasury, in aid of the erection of Churches, Chapels, and Ministers' Dwellings, and toward the payment of Ministers' stipends, under the pro-visions of the Act of Council 4th Victoria, No. 6:

1. All applications for such aid are to be made to the Governor and Executive Council through the Colonial Secretary.

2. Every application for aid toward the building of a Church, chapel, or Minister's dwelling, under the first clause of she said Act, shall be made in the annexed form (A), and shall set forth the particulars therein required.

3. All applications for stipends toward the support of the Ministers, under the second clause of the Act, shall be made in the form hereunto annexed maked (B), and shall contain all such particulars as are set forth in the said clause.

4. All special applications for Minis-ters Stipends, under the third clause of the Act, in cases where there are not one hun-dred adult attendants shall be made in the same form (B) last mentioned, accompa-nied by an explanatory letter setting forth the particular circumstances of the case for the consideration of the Governor and Council.

5. All applications for increase of Stipends, made under the fourth clause of the said Act, shall contain the several particulars required by the second clause, and set forth in form B. with such alterations only as the case may require.

6. All applications under the fifth clause of the Act, for stipends toward the support of Ministers, where there is no Church or Chapel, must contain the several particulars required by that clause, and be accom-panied by some explanatory letter. 7. Pursuant to the sixth clause of the

7. Pursuant to the sixth clause of the said Act a statement shall be transmitted in the month of January of every year, for the satisfaction of the Governor and Executive Council, signed by the Government Residents respectively, certifying that each Minister within their districts, in the receipt of a stipend, has, during the past year, or such part thereof as he shall have been employed, faithfully and diligently performed the several duties allotted to him,—which statement shall be deemed sufficient proof of such performance unless a complaint be made in writing to the Governor and Executive Council, which shall render further inquiry necessary; and no stipend will be issued for the current year until such certiffcate shall have been received, or such in-quiry, if instituted, shall have heen satisfactorily determined.

8. Previously to the issue of any sum from the Colonial Treasury, under these Regulations, toward the erection of any

Church, Chapel, or Minister's Dwelling, the Trustees thereof will be required to transmit to the Colonial Secretary an account, accompanied by the usual vouchers, of the sums actually expended on the Building. Such account will then be referred to some competent Architect, ap-pointed on behalf of the Government, who will be required to examine the Building and certify that the workmanship and materials are good and sufficient, and conformable to the plan and elevation laid before the Governor and Council, and that he believes the specified sum to have been actually laid out. One half the amount (not being less than fifty pounds) of any sums so expended and certified, will be, from time to time, issued to the Trustees subject to the limitation imposed by the said Act.

August 6, 1840. IS Excellency the Governor has been pleased to direct it to be notified that a Despatch has been received from Her Majesty's Secretary of State for the Colonies, sanctioning the following modifications of the Regulations for the Sale of Land in this Colony-

1. That applications from individuals for the survey of any particular blocks of land, not already in the course of being surveyed by the Government, will be accepted subject to the regulations existing in the Colony, and on the understanding that the block included within such survey shall be of not less than five square miles,* and shall be put up for sale in the mass.

2. That the land will be put up for sale at the existing minimum price, or at any other general minimum price which may hereafter be established.

3. That some definite time will be limited by the Governor in Council, after the completion of the survey, within which time the land shall be put up for sale. 4. That if the land, when surveyed, is

not sold, the applicant will bear the expense of the survey; but, if sold, either to him or any other person, an allowance will be made equal to the amount of charge which would have been incurred by Government if the survey had been made in the ordinary course of settlement. It is to be understood, however, that in the case of special surveys, the government will be responsible only for the expense of ascertaining the exterior boundaries, and not for the expense of running or ascertaining any interior division lines.

5. That if the applicant for a special survey will bind himself to become the purchaser so soon as the survey can be effected, and will either deposit the purchase money, or give adequate security for the payment of it, then his title shall not be defeated by any intervening regulations; but a mere offer, by which the applicant is not bound, cannot be admitted to bind the Government to adhere to the then existing terms of the sale, if the public interest should require a change in those terms.
