RELIGIOUS ESTABLISHMENTS.

IS Excellency the Governor, with the advice of the Executive Council, has been pleased to establish the following Regulations, under which issues will be made from the Colonial Treasury, in aid of the erection of Churches, Chapels, and Ministers' Dwellings, and toward the payment of Ministers' stipends, under the provisions of the Act of Council 4th Victoria,

1. All applications for such aid are to be made to the Governor and Executive Council through the Colonial Secretary.

2. Every application for aid toward the building of a Church, chapel, or Minister's dwelling, under the first clause of she said Act, shall be made in the annexed form (A), and shall set forth the particulars therein required.

3. All applications for stipends toward the support of the Ministers, under the second clause of the Act, shall be made in the form hereunto annexed marked (B), and shall contain all such particulars as are set forth in the said clause.

4. All special applications for Ministers Stipends, under the third clause of the Act, in cases where there are not one hundred adult attendants shall be made in the same form (B) last mentioned, accompanied by an explanatory letter setting forth the particular circumstances of the case for the consideration of the Governor and Council.

5. All applications for increase of Sti-pends, made under the fourth clause of the said Act, shall contain the several particulars required by the second clause, and set forth in form B. with such alterations only as the case may require.

6. All applications under the fifth clause of the Act, for stipends toward the support of Ministers, where there is no Church or Chapel, must contain the several particulars required by that clause, and be also accompanied by some explanatory letter.

7. Pursuant to the sixth clause of the said Act a statement shall be transmitted in the month of January of every year, for the satisfaction of the Governor and Executive Council, signed by the Government in what manner.

Residents respectively, certifying that each Minister within their districts, in the receipt of a stipend, has, during the past year, or such part thereof as he shall have been employed, faithfully and diligently performed to the Church, 7.

The site of the Church, 7. the several duties allotted to him, -which statement shall be deemed sufficient proof of such performance unless a complaint be made in writing to the Governor and Ex-ecutive Council, which shall render further inquiry necessary; and no stipend will be issued for the current year until such certificate shall have been received, or such inquiry, if instituted, shall have been satisfac-

torily determined.
8. Previously to the issue of any sum from the Colonial Treasury, under these Regulations, toward the erection of any

Church, Chapel, or Minister's Dwelling, the Trustees thereof will be required to transmit to the Colonial Secretary an account, accompanied by the usual vouchers, of the sums actually expended on the Building. Such account will then be referred to some competent Architect, appointed on behalf of the Government, who will be required to examine the Building and certify that the workmanship and materials are good and sufficient, and conformable to the plan and elevation laid before the Governor and Council, and that he believes the specified sum to have been actually laid out. One half the amount (not being less than fifty pounds) of any sums so expended and certified, will be, from time to time, issued to the Trustees subject to the limitation imposed by the said



Proclamation.

By His Excellency, soun mutt, Paquire, Governor and Commander-in-chief in and over the Territory of Western Australia and its Dependencies.

HEREAS, by an Act of the Local V Legislature, intituled "An Act to constitute the Island of Rottnest a legal Prison," it is among other things enacted, that it shall be lawful for the Governor, or officer administering the Government of the Colony, with the advice and consent of the Executive Council thereof, from time to time by proclamation, to make all such precautionary rules and regulations touching the places, and times, and manner of landing of boats at the said Island, as may be thought necessary for the due custody and prevention of the escape of the prison-ers. Now therefore, I, the Governor, by virtue and in exercise of the authority conferred upon me by the said recited Act, and with the advice and consent of the Executive Couucil, do hereby order and direct that from and after the date hercof, the fol-lowing Rules and Regulations shall be observed by all persons visiting the Island of Rottnest-

1st.—That any persons wishing to proceed to the Island of Rottnest shall first obtain a written permssioin to do so from the Colonial Secretary, or from the Government Resident of Fremantle.

2nd.—That no such permission shall entitle any person to land on the Island before sunrise, or after sunset.

3rd.—That all boats shall land where

the sentry is stationed, in the bay called Thompson's Bay, on the Northeast side of the Island, which has been fixed upon as the landing place.

4th.—That no person shall be permitted to land without first producing to the sentry at the landing place, the written permission to that effect.

5th.—That on landing, individuals shall. be required to report themselves to the Su-

perintendent.

6th.—That no communication shall be allowed with the prisoners, nor shall the buildings or places set apart for their confinement or employment, be allowed to be visited unless in the presence of the Superintendent.

7th.—That no person shall be allowed to pass the night on the Island without the permission of the Superintendent, who is empowered to order any one off the Island

if he may deem it expedient.

8th.—That no boat shall on any account be permitted to enter into any of the Bays of the Island, or to approach the Rocks adjacent, for the purpose or fishing or otherwise, without a written permission to do so under the hand of either of the officers referred to in the first rule.
9th.—That of these rules, the fifth, sixth,

and seventh only, are intended to apply to the case of parties compelled from shipwreck or stress of weather to take refuge on

10th.—That any wilful violation of any of the above rules, shall render the parties liable to the penalties enumerated in the second clause of the Act.
