ORDER IN COUNCIL.

At the Court of Buchingham Palace, February 5, 1841.
Present—the Queen's Most Excellent Ma-

jesty in Council.

Whereas by the late act of uniformity which establisheth the Liturgy and enacts that no form or order of Common Prayer be openly used, other than what is prescribed or appointed to be used in and by the said Book, it is, notwithstanding, provided, that in all those Prayers, Litanies, and Collects, which do any wise relate to the King, Queen, or Royal Progeny, the names be altered and changed from time to time and fitted to the present occasion according to the direction of lawful authority, Her Majesty was pleased this day in Council to declare Her Royal Will and Pleasure, that, in all the Prayers, Liturgies, and Collects, for the Royal Family, the words "The Prince Albert" be inserted immediately after the words "Adelaide the Queen Dowager," and Her Majesty doth strictly charge and command that no edition of the common Prayer be from henceforth printed, than with this amendment; and that in the meantime, till copies of such edition may be had, all Parsons, Vicars, and Curates, within the Realm, do, (for the preventing of mistakes), with the Pen, correct and amend all such Prayers in their Church Books, according to the fore-going direction; and for the better notice hereof that this order be forthwith printed and published and sent to the several Parishes and that the Right Reverend the Bishop do take care that obedience be paid to the same accordingly.

BEACON ON THE WOLFE ROCK.

Trinity House, London,
July 21, 1840.

The corporation of Trinity House have

much satisfaction in stating, for the information of Masters of Vessels and mariners in general, that the difficult and hazardous works which have, during the last four mmmers, been in operation, under their direction, for constructing a beacon upon that dangerous rock called the Wolfe, Muste about 74 miles WSW of the Land's

End of Cornwall, have been completed, and that a conspicuous beacon has been erected

This beacon consists of an artificial cone bearing a mast, having a large ball upon its summit, at an elevation of thirty-six feet above the level of the sea at high water; and mariners are to observe, that spring tides rise at this station nineteen feet, and that at low water of those tides, the rock is uncovered to the height of 15 feet.

The bearings and distances of the undermentioned objects from this beacon are as

Long Ship's light-house, NE by N, distant 74 miles.

Scilly light-house, W by N1N, distant 21 miles.

Rundlestone Rock, which covers at halfflood, E by NIN, distant 7 miles.

Seven Stones, centre thereof, NW1N, distant 13½ miles.

Lizard light-house, SE by E&E, distant 23 miles.

It being of great importance that this Beacon should not sustain injury, masters of vessels and others are hereby cautioned and enjoined not to approach it on any consideration, lest their own safety, as well as the security of the structure should be thereby unnecessarily endangered.

LIGHT AT THE KENTISH KNOCK. Trinity House, London,
July 7, 1840.
This Corporation having, in compliance

with the request of the owners and masters of vessels interested in the navigation of the North Sea, caused a vessel to be prepared for exhibiting a light near the sand called the Kentish Knock; notice is hereby given that the said vessel will be stationed at the cast side of the said sand, a short distance to the eastward of the situation in which the beacon-buoy now lies; and that the light on board the same will be exhibited on the evening of the 1st September next, and thenceforth continued every night from sunset to sunrise.

The light on board this vessel will be exhibited from a single lantern, it will revolve, and will burn at an elevation of 38 feet above the level of the sea.

Note-The Kentish Knock beacon-buoy will be taken away when the new light vessel is stationed, but the small watch-buoy will be continued.

A narrow channel having opened between Covehithe Point, on the coast of Suffolk, and the south end of the Barnard Sand, notice is hereby given that, in order to facilitate the passage of such vessels as may, under circumstances of emergency, be induced to avail themselves of this passage, the Corporation of Trinity House has caused two buoys to be placed in the fol-

lowing situations,—
A black beacon buoy, marked South Inner Barnard, on the inside of the south end of that sand, in 15 feet at low water, spring tides, and with the following marks

Covehithe church, W.N.W.

Kessingland church, north.

LIGHT-HOUSE ON THE MAPLIN SAND. Trinity House, London, Jan. 14, 1841.

Notice is hereby given, that the Light House, which has been for some time past in course of erection upon the Maplin sand is nearly completed; and that the Light therein will be exhibited, for the first time, on the evening of Wednesday, the 10th Eebrurary next; at which time the light hitherto shown on board of a vessel moored off the Sand, will be discontinued, and the vessel taken away.

Mariners are to obesive, that this Lighthouse is erected upon the south-eastern projecting part of the sand, where it becomes dry, or nearly so, at low water, spring tides; and they are particularly cautioned and enjoined never, under any circumstances, either by night or by day, to attempt to cross the sand to the northward of the building.

Mariners are also to observe that, in this light-house, a fixed light, colored red, and visible in all directions, will be exhibited.

VALENCIA HARBOUR LIGHT-HOUSE, WEST COAST OF IRELAND.

Ballast Office, Dublin, Nov. 12, 1840.

The Corporation for preserving and improving the Port of Dublin hereby give notice, that a Light-house has been built on the north-east point of Valentia Island. from which a fixed white light will be exhibited on the evening of the 1st of February, 1841, and thenceforth will be lighted from sunset to sunrise.

Speification given of the position of the Tower, &c., by Mr. Halpin, the Inspector of Light Houses.

The Light-house is erected within the

old building of Cromwell's Fort, on the western side of the principal entrance to Valentia Harbour; and bears from Reenadrolaan Point S.E. by E., distant 1 nautic miles; and bears from Donlus Head S.S.W. W., 11 nautic miles; and bears

S., 12 cable's length.

The light will be a fixed white light, open to seaward from N.W. to S.S.E. E. and elevated 54 feet above the level of high water springs, 60 feet above the mean level of the sea. The Light kept open will lead clear of Reenadrolaan Point, and also of the Harbour Rock within the entrance.

Shelving rocks, partly covered at high water, extend three quarters of a cable's length from Cromwell's Fort.

The bearings given are magnetic. Vari-
