Downing street, Oct. 13, 1842. SIR,-Having had the honor to submit to the Queen the Address of Congratulation on the birth of the Prince of Wales, from the inhabitants of the Colony of Western Australia, which accompanied your despatch No. 30, of the 10th May last, I have received Her Majesty's command to signify to you the gratification which Her Majesty has experienced at receiving this testimony of the loyalty and affection of her subjects in the Colony.
