Colonial Secretary's Office, Perth, April 25, 1844.

His Excellency the Governor has been pleased to direct the publication in conformity with the 5th section of the Act of Council No. 17, 4th & 5th Victoria, of the following description of a line of Road from West Guildford to Ellen's Brook, which has been adopted by the Road Trustees.

By His Excellency's command, PETER BROWN.

Road to be one chain in width (unless where otherwise expressed), on western side of the following lines, which are described with reference to the true meridian, and are marked at their respective angles by good stout posts 3 or 4 feet out of the ground, from which trenches are dug.

Commencing opposite south side of Bridge-street in Guildford, south side of a road 13 chains wide extends from right bank of Swan 13 chains in continuation of Bridge-street, then 3 chains 40 links N 293 deg. W, then 5 chains 20 links W 5 deg. 30 min. S along north side of a fencing ditch to north end of North-street in West. Guildford, then 5 chains 67 links S 69 deg. 50 min. W, then 6 chains 65 links S 38 deg. 50 min. W to south side of Brook-street, then S 51 deg. 20 min. W 20 chains 53 links to NW corner of West Guildford lot No. 125, and thence S. Westward towards No. 125, and thence S. Westward towards Perih; the whole of the above road extending from foot of Bridge-street to west end of Surrey-street. The road then extends 1 chain wide westward of a line 1 chain 97 links in length N 14 deg. W from NW corner of lot 125 aforesaid, then N 11 deg. 25 min. E 28 chains 91 links, then N 7 deg. E 9 chains 42 links to a post on south boundary of a public reserve of 50 acres at 9 chains 38 links west from right bank at 9 chains 58 links west from right bank of Swan, then S 34 deg. 12 min. E 11 chains 4 links to north boundary of J. Dodd's 40 acres, and S 53 deg. E 14 chains 50 links to north side of road already described between foot of Bridge-street and west end of Surrey-street. The road then recommences at post already mentioned on south boundary of the 50 acre reserve, and is one chain wide westward of the following lines as far as Cruise's Mill on Ellen's Brook, viz.;

N 1 deg. 50 min. W. 14 chains 52 links through the reserve aforesaid,-then N 16 deg. E 26 chains 90 links through Swan location P,—then in same direction 13 chains 78 links through location O 1,—then in same direction 12 chains 50 links, and N 5 deg. 45 min. E 12 chains 60 links, and N 31 deg. 20 min. E 14 chains 50 links, and N 51 deg. 10 min. E 5 chains 70 links, and N 68 deg. 18 min. E 2 chains 50 links and N 68 deg. 18 min. E 2 snams 30 links across Bennett's Brook, and N 42 deg. 30 min. E 5 chains 90 links to south boundary of location M 1,—then N 42 deg. 80 min. E 4 chains 70 links, and N 86 deg. E 31 chains 30 links, and N 65 deg. E 17 chains 40 links, and N 32 deg. 45 min. E 13 chains 80 links to south boundary of location M, then N 44 deg. E 9 chains 10 links, and N 66 deg. 30 min. E 27 chains 60 links to south boundary of location L at 55 chains west from right bank of Swan River,—then N 28 deg. 30 min. E 51 chains 20 links through location L aforesaid,—then N 7 deg. 45 min. W 22 chains 30 links through location K 1,—then 10 chains 40 links in same direction, and N 4 deg. 30 min. E 13 chains 20 links, and N 17 deg. 15 min. E 23 chains to south boundary of location I at about 35 chains 80 links west from Swan chains 20 links, and N 17 deg. 15 min. E 13 to the Crown in the Australian Colonies, Land Schains 20 links, and N 17 deg. 15 min. E 14 chains to south boundary of location I about 35 chains 80 links west from Swan River aforesaid,—then N 11 deg. 10 min. E 30 chains 14 links through location I aforesaid,—then 14 chains further N 11 deg. 10 location I Sth day of May next, at the open price

min. E, and N 35 deg. 40 min. E16 chains 54 link, and N 48 deg. E 18 chains 24 links, and N 50 min. W 24 chains 6 links to south boundary of location G I at about 34 chains 10 links west from Swan River aforesaid,—then N 5 deg. 10 min. E 14 chains 74 links, and N 53 deg. 50 min. E 14 chains 80 links, and N 37 deg. 30 min. 14 chains 80 links, and N 37 deg. 30 min. E 11 chains 30 links to south boundary of location G,—then N 18 deg. 30 min. E 20 chains 14 links through location G aforesaid,—then N 9 deg. 30 min. E 25 chains through location F 1,—then N 4 deg. 55 min. E 6 chains 30 links, and N 2 deg. E 18 chains 40 links to south boundary of location E at about 26 chains 6 links west from Swan River aforesaid,—then N 3 deg. 30 min. W 164 chains through location E,—then W 163 chains through location E,—then N 33 deg. 30 min. W 19 chains 90 links through location E 1,—then N 22 deg. W through location E I,—then N 22 deg. W 58½ chains to junction of the present back road from Perth, and N 11 deg. E 27 chains 70 links to south boundary of location A,—then N 18 deg. 50 min. W 13 chains 70 links, and N 5 deg. 20 min. E 21 chains 90 links, and N 24 deg. 50 min. E 5 chains 40 links to south boundary of location No. 1 at about 38 chains 20 links west from left hank of Ellen's Brook.—then N 24 left bank of Ellen's Brook,—then N 24 deg. 50 min. E 14 chains 90 links, and N 30 deg. 30 min. E 34 chains 20 links, and about N 33 deg. W 2 chains 70 links to south corner Cruise's present Water Mill near right bank of Ellen's Brook, on location No. 1 aforesaid.

In pursuance of the authority in me vested by a certain Act of the Imperial Parliament of Great Britain and Ireland, passed in the fifth and sixth years of Her Majesty's reign, intituled "An Act for regulating the Sale of Waste Lands belonging to the Crown in the Australian Colonies,

affixed thereto, on the terms and conditions set forth in certain Land Regulations dated the 14th June, 1843:-
