*By His Excellency JOHN HUTT,
Esq., Governor and Commander-in-Chief of the Territory of Western Australia and its Dependencies, and Vice-Admiral of the same.*

In pursuance of the authority in me vested by a certain Act of the Imperial Parliament of Great Britain and Ireland, passed in the fifth and sixth years of Her Majesty's reign, intitled "an Act for regulating the Sale of Waste Lands belonging to the Crown in the Australian Colonies," I do hereby notify and proclaim that the following portion of land in the District of Wellington be offered for sale by public auction, at Bunbury, by the Sub-Collector of Revenue, on Wednesday, the 12th day of February next, at the upset price affixed thereto, on the terms and conditions set
