Proclamation.

To His Excellency JOHN HUTT, Esq., Governor and Commander-in-Chief of the Territory of Western Australia and its Dependencies, and Vice-Admiral of the same.

Whereas the undermentioned Acts passed by the Governor of Western Australia, with the advice and consent of the Legislative Council thereof, were passed in the seventh and eighth years of Her Majesty's reign, namely—

No. 12 of 7th Victoria, intituled "An act to regulate summary proceedings before Justices of the Peace."

No. 13 of 7th Victoria, intituled "An act for adopting certain Acts of Parliament passed in the third and fourth, the fourth and fifth, the fifth and sixth, and the sixth and seventh years of the reign of His late Majesty King William the Fourth; as also certain Acts of Parliament passed in the first and second, the second and third, and the fifth and sixth years of the reign of Her present Majesty Queen Victoria respectively, and applying the same in the administration of justice in Western Australia in like manner as the other laws of England are applied therein."

No. 15 of 7th Victoria, intituled "An act to prevent the spreading of the infectious disease called the scab in sheep in the Colony of Western Australia."

No. 2 of 8th Victoria, intituled "An act to enable certain ratepayers in Towns to vote and act as Trustees of such Towns, and to qualify the right of Town Trustees to vote."

No. 4 of 8th Victoria, intituled "An act to authorize the Keepers of Boarding Houses to sell spirituous and fermented liquors by retail under special regulations."

Now therefore I, the Governor, do hereby proclaim and make known to all to whom it may concern, that Her Majesty has been graciously pleased to confirm and allow the before-mentioned acts.

Proclamation.

By His Excellency JOHN HUTT, Esquire, Governor and Commander-in-Chief of the Territory of Western Australia, and Vice-Admiral of the same.

Whereas by the first section of an Ordinance passed in this present year, intituled "An Ordinance to make provision for the Trial of Criminal Offences at Albany and other remote Districts of the Colony of Western Australia," it is enacted that Courts of General Sessions of the Peace for the various Districts of this Colony may be holden at such times and in such places as the Governor shall by Proclamation from time to time appoint;—Now therefore I, the Governor, by this my Proclamation, appoint that Courts of General Quarter Sessions may be holden at Albany on the second Wednesday in February, the second Wednesday in May, the second Wednesday in August, and the second Wednesday in November in each and every year until further notice.

TOWN OF PERTH.

His Excellency the Governor directs it to be notified for general information, that the several Streets and lines of communication in the Town-site of Perth,

having been finally marked out on the ground and designated by square sawn posts, branded P T T, and the outer limits of the said Town-site having been also defined by strong posts placed in trenches, and the Divisional Boundaries between the respective Allotments in the said Town having likewise been defined by short stakes driven into the ground, in conformity with the various provisions of the Ordinances 8 and 9 of the 8th of Victoria, a duplicate plan of the said Town as thus finally arranged has been delivered to the Chairman of the Town Trust in order to enable him to proceed forthwith to adjust and regulate the line of streets according to such plan as he is authorised and required to do in pursuance of said Ordinance, first above mentioned.

NATIVES' DOGS.

In consequence of the great increase of late of Dogs in the possession of the Natives, and the frequent injuries which they inflict on the flocks of the colonists, the Governor has been pleased to offer a reward to Constables of One Shilling for the head of each Dog, and of Sixpence for the head of each Puppy, henceforth found in the possession of any of the aboriginal race.

These rewards to be paid on the certificate of a Magistrate, that the head for which the reward is claimed has been destroyed in his presence.

His Excellency requests attention to the fact, that the evil complained of arises almost entirely from the baneful practice of the settlers giving young dogs to the natives.
